SUBJECT:

Authorizing the Mayor or his designee to accept a donation in the amount of \$9,901.50 from The Cathedral Church of Saint Peter paid by the Episcopal Diocese of Southwest Florida and Episcopal Church Province IV to support the Health 360 program and to execute all documents necessary to effectuate this transaction; approving a supplemental appropriation in the amount of \$9,901.50 from the increase in the unappropriated balance of the General Fund (0001), resulting from these additional revenues, to the Parks & Recreation Department, Healthy St. Pete Division (190-1587).

EXPLANATION:



The Healthy St. Pete Division of the Parks and Recreation Department implements the Health 360 program in several recreation centers throughout the city. This free community-based program offers six-weeks of evidence-based curriculum on topics that include finances, mental and behavioral health, nutrition, cooking, and physical fitness for all ages and abilities. The donated funds will be used to support the continuation of the program and includes but not limited to providing fresh produce vouchers, advertising, marketing, and other programmatic supplies.

COST/FUNDING/ASSESSMENT INFORMATION:

Revenues of \$9,901.50 will be received from The Cathedral Church of Saint Peter. A supplemental appropriation in the amount of \$9,901.50 from the increase in the unappropriated balance of the General Fund (0001) resulting from these additional revenues to the Parks & Recreation Department, Healthy St. Pete Division (190-1587) is required.

A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ACCEPT A DONATION IN THE AMOUNT OF \$9,901.50 FROM THE CATHEDRAL CHURCH OF SAINT PETER PAID BY THE EPISCOPAL DIOCESE OF SOUTHWEST FLORIDA AND EPISCOPAL CHURCH PROVINCE IV TO SUPPORT THE HEALTH 360 PROGRAM AND TO EXECUTE ALL DOUCMENTS NECESSARY TO EFFECTUATE THIS TRANSACTION; APPROVING A SUPPLEMENTAL APPROPRIATION IN THE AMOUNT OF \$9,901.50 FROM THE INCREASE IN THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND (0001), RESULTING FROM THESE ADDITIONAL REVENUES, TO THE PARKS & RECREATION DEPARTMENT, HEALTHY ST. PETE DIVISON (190-1587); AND PROVIDING AND EFFECTIVE DATE.

WHEREAS, The Cathedral Church of Saint Peter has donated \$9,901.50 paid by the Episcopal Diocese of Southwest Florida and Episcopal Church Province IV to support the Health 360 program; and

WHEREAS, the Health 360 program is offered by the Healthy St. Pete Division of the Parks and Recreation Department and provides community education classes in health, finance, nutrition, and healthy behaviors; and

WHEREAS, the funding awarded to the City will be utilized to enhance current programs and expand the Health 360 program in at-risk areas of the city; and

WHEREAS, such programs will help residents learn valuable nutritional information, budgeting, healthy food preparation, and physical fitness techniques; and

WHEREAS, Administration recommends approval of this resolution.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that the Mayor or his designee is authorized to accept a donation in the amount of \$9,901.50 from The Cathedral Church of Saint Peter paid by the Episcopal Diocese of Southwest Florida and Episcopal Church Province IV to support the Health 360 program and to execute all documents necessary to effectuate this transaction.

BE IT FURTHER RESOLVED that there is hereby approved from the increase in the unappropriated balance of the General Fund (0001), resulting from these additional revenues, the following supplemental appropriation for FY20:
