A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXECUTE TASK ORDER NO. 21-02-C/TB(C) TO THE ARCHITECT/ENGINEERING AGREEMENT DATED JANUARY 20, 2021 BETWEEN THE CITY OF ST. PETERSBURG, FLORIDA AND STANTEC CONSULTING SERVICES, INC. (“A/E”) FOR A/E TO PROVIDE (I) DATA COLLECTION, SITE INVESTIGATION AND A HYDRAULIC REVIEW, (II) AN EVALUATION OF REPLACEMENT OPTIONS, (III) DESIGN SERVICES INCLUDING 100% DESIGN DOCUMENTS, (IV) PERMITTING SERVICES AND TYPE 1 CATEGORICAL EXCLUSION, (V) FINAL SIGNED AND SEALED CONSTRUCTION DOCUMENTS, AND (VI) BIDDING ASSISTANCE AND RECOMMENDATION OF AWARD RELATED TO THE 17TH STREET NORTH BRIDGE REHABILITATION – BRIDGE NO. 157126 PROJECT IN AN AMOUNT NOT TO EXCEED \$307,526.31; RESCINDING UNENCUMBERED APPROPRIATIONS FROM THE FOLLOWING PROJECTS IN THE CITYWIDE INFRASTRUCTURE CAPITAL IMPROVEMENT FUND (3027), \$163,000 FROM THE BRIDGE LIFE EXTENSION PROGRAM FY23 PROJECT (19167) AND \$200,000 FROM THE BRIDGE REPLACEMENT PROGRAM FY23 PROJECT (19184); APPROVING A SUPPLEMENTAL APPROPRIATION IN THE AMOUNT OF \$363,000 FROM THE INCREASE IN THE UNAPPROPRIATED BALANCE OF THE CITYWIDE INFRASTRUCTURE CAPITAL IMPROVEMENT FUND (3027), RESULTING FROM THESE RESCISSIONS, TO THE 157126 17TH ST N BRIDGE REHABILITATION PROJECT (19660) TO PROVIDE FOR THE NECESSARY FUNDING FOR THIS TASK ORDER AND ENGINEERING PROJECT MANAGEMENT COSTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of St. Petersburg, Florida (“City”) and Stantec Consulting Services, Inc. (“A/E”) executed an architect/engineering agreement on January 20, 2021 for A/E to provide professional services for miscellaneous Transportation and Bridge Improvement Projects on a continuing basis with an estimated construction cost not to exceed \$4 million; and

WHEREAS, Administration desires to issue Task Order No. 21-02-C/TB(C) for A/E to provide (i) data collection, site investigation and a hydraulic review, (ii) an evaluation of replacement options, (iii) design services including 100% design documents, (iv) permitting services and type 1 categorical exclusion, (v) final signed and sealed construction documents, and

(vi) bidding assistance and recommendation of award related to the 17th Street North Bridge Rehabilitation – Bridge No. 157126 Project in an amount not to exceed \$307,526.31, which amount includes a \$10,000 allowance; and

WHEREAS, funding for this Task Order and Engineering project management costs will be available after (i) rescinding unencumbered appropriations from the following projects in the Citywide Infrastructure Capital Improvement Fund (3027): \$163,000 from the Bridge Life Extension Program FY23 Project (19167) and \$200,000 from the Bridge Replacement Program FY23 Project (19184) and (ii) approving a supplement appropriation from the increase in the unappropriated balance of the Citywide Infrastructure Capital Improvement Fund (3027), resulting from the above rescissions, to the 157126 17th St N Bridge Rehabilitation Project (19660).

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida that the Mayor or his designee is hereby authorized to execute Task Order No. 21-02-C/TB(C) to the architect/engineering agreement dated January 20, 2021 between the City of St. Petersburg, Florida and Stantec Consulting Services, Inc. (“A/E”) for A/E to provide (i) data collection, site investigation and a hydraulic review, (ii) an evaluation of replacement options, (iii) design services including 100% design documents, (iv) permitting services and type 1 categorical exclusion, (v) final signed and sealed construction documents, and (vi) bidding assistance and recommendation of award related to the 17th Street North Bridge Rehabilitation – Bridge No. 157126 Project in an amount not to exceed \$307,526.31.

BE IT FURTHER RESOLVED that unencumbered appropriations in the Citywide Infrastructure Capital Improvement Fund (3027) in the amount of \$163,000 from the Bridge Life Extension Program FY23 Project (19167) and \$200,000 from the Bridge Replacement Program FY23 Project (19184) are hereby rescinded.

BE IT FURTHER RESOLVED that there is hereby approved from the increase in the unappropriated balance of the Citywide Infrastructure Capital Improvement Fund (3027), resulting from the above rescissions, the following supplemental appropriation from FY23:


