Codes Compliance Assistance is just one of several agencies that provide enforcement services for the residents of the St. Pete. See below for a list of agencies and phone numbers to assist you and which City Department or Pinellas County Agency to contact.

ISSUES HANDLED BY THE CITY OF ST. PETERSBURG CODES COMPLIANCE ASSISTANCE DEPARTMENT

Building Maintenance	Construction work performed without a permit such as replacing a roof or extensive remodeling, disrepair such as defective paint, rotted wood, roof damage, broken windows, etc.
Health & Safety	Unsafe structures that are vacant and open to unauthorized access, structures with severe deterioration, unsanitary conditions posing potentially serious public health or safety hazards
Nuisance / Blight	Junk vehicles, hazardous dead trees, overgrown yards, outdoor storage of junk, cars parked on the front yard, boats and trailers parked in front yards during unapproved times, commercial equipment parked in residential areas
Tenants	Interior inspections of rental units for minimum maintenance, unsafe electric, dwelling units without working appliances, water or electric service
Zoning	Illegal property use, setback violations (i.e., encroachments), prohibited business in a residential area, illegal signs, illegal sheds

To report a violation: 727-893-7373

Florida State Bill 60, which went into effect on July 1, 2021, states that all codes complaints can no longer be reported anonymously. When calling in a complaint (or reporting a complaint via SeeClickFix) you will be required to give your name and address which will become part of the public record.
