I further agree to be responsible for ensuring that all other occupant(s) of the aforementioned property comply with the terms of this Agreement, applicable provisions of the St. Petersburg City Code, and the Policies and Procedures for Irrigation Only Water Service. I hereby agree that the City shall have the right to enter the above property to inspect the property, the water piping and fittings, and the in-ground irrigation system at any reasonable time.

I understand and agree that as the owner of the above-described property, I shall be responsible for prompt payment to the City of St. Petersburg, Florida of all connection charges and monthly service charges to the described property in accordance with the St. Petersburg City Code and applicable Policies and Procedures. I understand and agree that the City may discontinue irrigation-only water service due to any infraction of the City's ordinances, resolutions and/or Policies and Procedures, for nonpayment of the service charges, for tampering with the service (includes meter and appurtenances), for cross-connections with another service or water source, or any other reason determined by the City to be a detriment to public health, safety, and welfare. I also understand that such infraction(s) of City ordinances or the Policies and Procedures may also result in civil or criminal prosecution.
