

ORDINANCE 2018-17

AMENDING TITLE 10, CHAPTER 10.24 OF THE MUNICIPAL CODE OF ORDINANCES OF THE CITY OF STREATOR, LA SALLE AND LIVINGSTON COUNTIES, ILLINOIS BY DESIGNATING THE ADDITION OF TWO "HANDICAPPED PARKING" SPACES IN THE 400 BLOCK OF EAST HICKORY STREET

WHEREAS, the Streator Municipal Code of Ordinances, LaSalle and Livingston Counties, Illinois, regulates motor vehicles and traffic; and

WHEREAS, Chapter 10, Section 10.24 of the Streator Municipal Code of Ordinances has been previously amended for the purpose of, more specifically, regulating motor vehicles and traffic within the City of Streator, LaSalle and Livingston Counties; and

WHEREAS, the Illinois Vehicle Code, Illinois Compiled Statutes 625 5/11-708 allows local authorities after appropriate study to determine when warranted the designation and installation of handicapped parking spaces.

NOW THEREFORE, be it ordained by the City Council of the City of Streator, LaSalle and Livingston Counties, Illinois, as follows:

Section 1: That the Streator Municipal Code of Ordinances, Chapter 10, Section 10.24 "Stopping, Standing, and Parking", be and the same is hereby amended by the elimination and addition of "handicapped parking" areas in the 400 block of East Hickory Street:

ADDITION OF HANDICAPPED PARKING SPACES

Add Space 1 which is within the northern parking lane of the 400 block of E Hickory Street located 105'-125' east from the corner of N. Vermillion Street.

Add Space 2 which is within the northern parking lane of the 400 block of E Hickory Street located 125'-145' east from the corner of N. Vermillion Street.

Section 2: That each section, paragraph, sentence, clause and provision of this ordinance is separable and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this ordinance nor any part thereof, other than that part affected by such decision.

Section 3: That except as to the amendments heretofore mentioned, all chapters and articles and sections of Streator Municipal Code of Ordinances shall remain in full force and effect.


Section 4: That this ordinance shall be published in pamphlet form and shall take effect ten (10) days following publication and shall be incorporated into the Streator Municipal Code of Ordinances.
