

ORDINANCE 2018-22

AUTHORIZING THE EXECUTION OF AN ANNEXATION AGREEMENT
BETWEEN THE CITY OF STREATOR, ILLINOIS AND TRAVIS AND
JENNIFER SWEEDEN, OWNERS, A PARCEL LYING NORTH ON ROUTE 18
EAST, SECTION 30, TOWNSHIP NORTH 31, LASALLE COUNTY, ILLINOIS

WHEREAS, Travis and Jennifer Sweeden, owners of property legally described as:

The east half of the south one third of the north half of the southeast quarter of Section 30, Township 31 North, Range 4 East of the Third Principal Meridian, LaSalle County, IL, excluding the subdivided area; and

WHEREAS, the City of Streator desire to annex said property to the City of Streator; and

WHEREAS, the said territory is not within the corporate limits of any municipality but is contiguous to the city of Streator; and

WHEREAS, all petitions, documents, and other necessary legal requirements are in full compliance with the terms of the annexation agreement and with the statues of the of the state of Illinois, specifically Section 7-1-1, 7-1-2, 7-1-8 of the Illinois of the Illinois Municipal Code, 65 ILCS 5/7-7-1, 5/7-1-2, 5/7-1-8 and 5/11-151.1; and

WHEREAS, the City of Streator has given notice and conducted a public hearing of this proposed agreement in the manner required by law.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Streator, Counties of LaSalle and Livingston, Illinois as follows:


Section 1: That the City of Streator has found it is in the best interest of the health, safety, and welfare of the citizens of the City of Streator that the mayor be authorized to enter into an annexation agreement with Travis and Jennifer Sweeden, owners of property legally described above in Township 31 North, City of Streator, LaSalle County, Illinois, to make it consistent with surrounding property uses, be and the same is hereby approved.

Section 2: That the annexation agreement between the City of Streator and Travis and Jennifer Sweeden, owners, of property located in Township 31 North, LaSalle County, Streator, Illinois.

Section 3. The Mayor and city clerk of the City of Streator are hereby instructed and authorized to sign the document on behalf of the city of Streator.
