

ORDINANCE 2018 -26

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF STREATOR,  
ILLINOIS, COUNTIES OF LA SALLE AND LIVINGSTON  
MARY LIN J. MEYERS TRUST& IVA CAMERON REVOCABLE TRUST  
(#34-30-421-000 and #34-30-420-000)

WHEREAS, a written petition (attached as Exhibit A) signed by the legal owners of record of all land within the territory hereinafter described, has been filed with the Clerk of the City of Streator, county of LaSalle, Illinois, requesting that said territory, legally described as the Southwest Quarter of the Southeast Quarter of Section 30; excluding the 3 acres owned by the First Christian Church of the Nazarene, in Otter Creek Township, Counties of LaSalle and Livingston, Illinois, comprising of 37 acres, more or less be annexed to the City of Streator; and

WHEREAS, the said territory is not within the corporate limits of any municipality but is contiguous to the city of Streator; and

WHEREAS, legal notices regarding the intention of the city to annex said territory have been sent to all public bodies required to receive such notice by State statute; and,

WHEREAS, all petitions, documents, and other necessary legal requirements are in full compliance with the terms of the annexation agreement and with the statutes of the state of Illinois, specifically Section 7-1-1, 7-1-2, 7-1-8 of the Illinois Municipal Code, 65 ILCS 5/7-7-1, 5/7-1-2, 5/7-1-8 and 5/11-15.1.1; and,

WHEREAS, it is in the best interests of the City of Streator that the territory be annexed thereto,

NOW, THEREFORE, be it ordained by the City Council of the City of Streator, County of LaSalle, Illinois as follows:


Section 1: That the territory legally described as the Southwest Quarter of the Southeast Quarter of Section 30; excluding the 3 acres owned by the First Christian Church of the Nazarene, in Otter Creek Township, Counties of LaSalle and Livingston, Illinois, comprising of 37 acres, more or less and indicated on an accurate map (attached as Exhibit B), which has been attached hereto and becomes a part hereof this ordinance, is hereby annexed to the City of Streator, Counties of LaSalle and Livingston, Illinois.

Section 2: That the City Clerk is hereby directed to record with the LaSalle County Recorder and to file with the LaSalle County Clerk a certified copy of this ordinance, together with Exhibits A and B which have been appended to the ordinance.

Section 3: That this ordinance shall be in full force and effect from and after its passage approval, and publication in pamphlet form as provided by law.
