ORDINANCE 2019 - 32

FOR THE LEVY AND ASSESSMENT OF TAXES ON REAL PROPERTY FOR ALL PURPOSES FOR DEFRAIVING EXPENSES FOR ALL CORPORATE PURPOSES FOR THE CITY OF STREATOR, LA SALLE AND LIVINGSTON COUNTIES, ILLINOIS, FOR THE FISCAL YEAR COMMENCING ON JANUARY 1, 2020 AND ENDING ON DECEMBER 31, 2020.

BE IT ORDAINED by the City Council of the City of Streator, LaSalle and Livingston Counties, Illinois as follows:

Section 1: That the total amount of appropriations for all corporate and special purposes, legally made, is \$26,920,672, and the portion to be collected from the real estate tax levy for the 2020 fiscal year is hereby ascertained to be the sum of *three million eight hundred fifty six thousand nine hundred sixty four dollars (\$3,856,964)*.

Section 2: That the amounts hereinafter set forth or that amount as may be authorized by law shall be levied for such corporate purposes as shown in Exhibit A, which is attached to and considered as part of this ordinance.

Section 3.: That the amounts levied for each object and purpose as set forth in Section Two of this ordinance, for which real estate taxes may be levied are as follows:

Section 4: That the total amount of *three million eight hundred fifty six thousand nine hundred sixty four dollars (\$3,856,964)* be and the same is hereby levied, assessed for all real property subject to taxation within the City of Streator according to the value of said property as assessed and equalized for State and County purposes for the current year.

Section 5: That the City Clerk shall certify to and file with the County Clerks of LaSalle and Livingston Counties, Illinois the several sums above, constituting said total amount and the total *three million eight hundred fifty six thousand nine hundred sixty four dollars (\$3,856,964)* which total amount the City of Streator requires to be raised by taxation for the current fiscal year for the City, and the City Clerk is hereby ordered and directed to file with the County Clerks of LaSalle and Livingston Counties on or before the time required by law, a certified copy of this ordinance.

Section 6: That this ordinance shall be in full force and effect from and after its passage and approval as provided by law.


Passed by the City Council of the City of Streator, LaSalle and Livingston Counties, Illinois at a regular meeting thereof held on December 18, 2019 and approved by me as Mayor on the same day.
