FOR THE LEVY AND ASSESSMENT OF TAXES ON REAL PROPERTY FOR ALL PURPOSES FOR DEFRAYING EXPENSES FOR ALL CORPORATE PURPOSES FOR THE CITY OF STREATOR, LASALLE AND LIVINGSTON COUNTIES, ILLINOIS, FOR THE FISCAL YEAR COMMENCING ON JANUARY 1, 2022 AND ENDING ON DECEMBER 31, 2022.

BE IT ORDAINED by the City Council of the City of Streator, LaSalle and Livingston Counties, Illinois as follows:

Section 1: That the total amount of appropriations for all corporate and special purposes, legally made, is \$23,794,640, and the portion to be collected from the real estate tax levy for the 2021 fiscal year is hereby ascertained to be the sum of *four million two-hundred forty-nine thousand eight hundred sixty seven dollars (\$4,249,867)*.

Section 2: That the amounts hereinafter set forth or that amount as may be authorized by law shall be levied for such corporate purposes, and special purposes upon all property subject to taxation within the city as that property is assessed and equalized in the following sums:

Section 4: That the City Clerk shall file with the County Clerks of LaSalle and Livingston Counties, on or before the last Tuesday in December a certified copy of this ordinance.

Section 5: That this ordinance shall be in full force and effect from and after its passage and approval as provided by law.


