

ORDINANCE 2018-38

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF STREATOR,
COUNTIES OF LIVINGSTON & LASALLE, ILLINOIS
United Pipe and Supply Co. – 1608 E. Main Street – 34-30-354-000

WHEREAS, a written petition (attached as Exhibit A) signed by the legal owners of record of all land within the territory hereinafter legally described as:

That portion of the Southwest Quarter Section 30, Township 31 North, Range 4 East of the Third Principal Meridian situated in LaSalle County described as follows:

Beginning at a point 118 South and 94 feet West of the Northwest corner of Lot 4 in the Ringle Addition to the City of Streator; thence west 201.1 feet; thence south 208 feet; thence east 102.1 feet; thence north 110 feet; thence east 99 feet; thence north 98 feet to the point of beginning including adjacent Illinois Route 18 right-of-way; and

WHEREAS, the said territory is not within the corporate limits of any municipality but is contiguous to the City of Streator; and

WHEREAS, all petitions, documents, and other necessary legal requirements are in full compliance with the terms of the annexation agreement and with the statutes of the State of Illinois, specifically Section 7-1-1, 7-1-2, 7-1-8 of the Illinois Municipal Code, 65 ILCS 5/7-7-1, 5/7-1-2, 5/7-1-8 and 5/11-15.1.1; and

WHEREAS, it is in the best interests of the City of Streator that the territory be annexed thereto.

NOW, THEREFORE, be it ordained by the City Council of the City of Streator, Counties of LaSalle and Livingston, Illinois as follows:

Section 1: That the territory legally described above and indicated on an accurate map, which has been attached hereto as Exhibit B and becomes a part hereof this ordinance, is hereby annexed to the City of Streator, Counties of LaSalle and Livingston, Illinois.

Section 2: That the City Clerk is hereby directed to record with the LaSalle County Recorder and to file with the LaSalle County Clerk a certified copy of this ordinance, together with Exhibits A and B which have been appended to the ordinance.

Section 3: That this ordinance shall be in full force and effect from and after its passage approval, and publication in pamphlet form as provided by law.

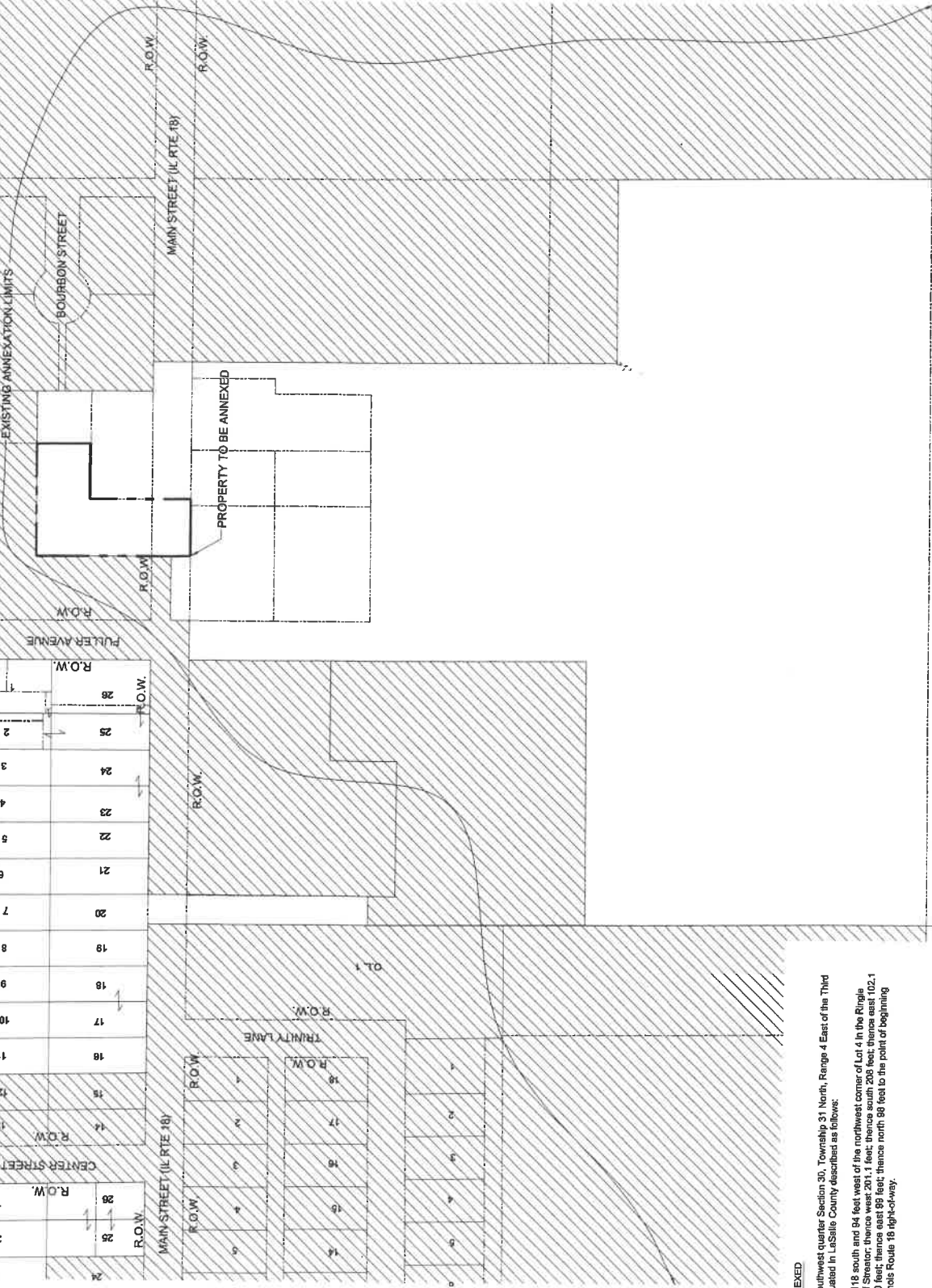
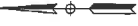
