**WHEREAS**, a written petition (attached hereto and incorporated herein as Exhibit A) signed by the legal owners and at least 51% of the electors of the "Territory" as described below has been filed with the Streator City Clerk requesting that the Territory be annexed to the City of Streator.

**Legal**

**Description:** Lots 10 and 11 in MC PIC Park, being a Subdivision of a Portion of the East 24 Acres of the Southeast Quarter of the Northwest Quarter of Section 23, Township 31 North, Range 3 East of the Third Principal Meridian, According to Page 60, LaSalle County, Illinois, including Adjacent Helen Street and Pine Tree Road Rights of Way.

**Address:** 10 & 11 Helen Street, Streator, Illinois

**PINS:** 33-23-114-001 and 33-23-114-002

**WHEREAS**, the Territory is not within the corporate limits of any municipality but is contiguous to the City of Streator; and

**WHEREAS**, legal notices regarding the City's intention to annex the Territory have been sent to all public bodies required by law to receive such notice; and

**WHEREAS**, all petitions, documents, and other necessary legal requirements are in full compliance with the statutes of the State of Illinois, specifically Section 7-1-8 of the Illinois Municipal Code; and

**WHEREAS**, the City Council finds it is in the best interests of the City of Streator to annex the Territory.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Streator, LaSalle and Livingston Counties, Illinois as follows herein.

**Section 1:** The Territory described herein and on the attached Exhibits and as indicated on the




map attached hereto and incorporated herein as Exhibit B is hereby annexed to the City of Streator, Illinois.

**Section 3:** This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.


