Enclosed with this memo please find two applications for the Downstate Small Business Stabilization Program Grant Program being administered by DCEO. These applications were submitted on behalf of the following business and will be used to fund working capital costs for 60 days if the grant is approved by DCEO.

- Deke Trucking
- Trainor Floor Covering

In accordance with the program rules if the grants are approved by DCEO grant agreements between the City and DCEO will be executed that will allow for the grant dollars to come from DCEO to the City. Once the City has received the funds, the business recipient, for a period of sixty days, will bring in requests for releases of funds until the grant monies are gone. Once the grant funds are spent the City is then required within one year to complete a grant closeout report itemizing how the funds were spent. The participation agreement enclosed within the applications are the legal document that is required by DCEO to be executed by the City and the businesses to ensure that if funds are not spent correctly the City can require the funds to be repaid.

PUBLIC HEARING NOTICE

The City of Streator will hold a public hearing on June 4, 2020 at 1:30 p.m., in Streator City Hall, 204 S Bloomington, Streator, IL 61364 to provide interested parties an opportunity to express their views on the proposed Downstate Small Business Stabilization application funded by Community Development Block Grant (CDBG) funds. On or about June 5, 2020, the City of Streator intends to apply to the Illinois Department of Commerce and Economic Opportunity for a grant from the State CDBG program. This program is funded by Title 1 of the federal Housing and Community Development Act of 1974, as amended. These funds are to be used to provide working capital for the benefit of Trainor Flooring Company and Deke Trucking, Inc. The total amount of CDBG funds to be requested is \$50,000 (\$25,000 per business) and will address the urgent needs of the business due to the COVID-19 emergency.
