

Dear Tarboro Town Council,

Along with many others, I was saddened when the Tarboro Confederate Civil War monument was taken from its long-held position in the town commons, where it had proudly stood since for over a century. Although I understand the sensitivity of this issue, and that our town doesn't want to divide its citizens any further, I firmly believe that this testament to the fallen holds worth; that the painful memories don't necessarily override the preservation of history. Because of this, I would like to take over the stewardship of the marker, and I will detail why I believe I am the best choice for this—potentially—controversial decision.

My family has been part of the fabric of Edgecombe County since at least the eighteenth century. After going to school and building my career out of town, I came back because this place is in my blood. I purchased a historic home here and hope to leave it in better condition than I found it.

The monument in question was gifted in 1904 by the Daughters of the Confederacy, many of whom elderly women were who still remembered fallen brothers and fathers. My family lost two young men in that war; Henry and Richard Powell. It is their family home that I currently reside, and where I would like to transplant this statuary to keep it from disappearing, entirely.

My home, Coolmore on Alt Rt 64, has a rose garden which can be seen from the road. I would like to place the statue there. Coolmore is in the National Historic Trust and is available for public tours by appointment. Occasionally, we invite the public for an open house, which would also include this piece of history.

I understand that there is a finesse to moving a shrine, and I would base the timeline of my retrieval of the monument's current location based on the current Covid-19 situation, as well as procuring the appropriate experts. I plan for it to be within the next six months, all other considerations notwithstanding.

I appreciate your giving me the time to plead my case, and I hope that you can understand that a commemoration created for the dead of Edgecombe County should remain within the confine of its borders. I believe that my home—and its availability to the public, as well as the fact that it is included in the register of established historic homes, would be a good compromise. It is accessible, yet not intrusive to those it might harm.

Subject: Relocation of the Edgecombe County/Tarboro Civil War Monument.

On behalf of the Fort Branch Historical Society, I submit it's interest in obtaining the monument for the purpose of re-erection at the fort. The Fort Branch Historical Society is a 501 3C non-profit organization that is focused on historical and archaeological preservation of Fort Branch, Hamilton, NC. This organization has been focused in preserving the site for over 40 years. It has been entrusted with major artifacts from the time by the State of North Carolina to include 7 cannons that were recovered from the Roanoke River during 1972 and 1977. We are charged with care and maintenance and public display of the artifacts from the two recovery opereations. The 7 cannons at Fort Branch account for 70 percent of the cannons at Fort Branch. The fact that those cannons are still on display at the fort makes Fort Branch unique among all Civil War sites. No other site comes even close to being able to display such a high percentage of original guns that are directly connected to the specific site.

Why is Fort Branch a good place for the monument? Governor Cooper has stated that such monuments should be at sites that corrilate in historical context. Following that mindset, monuments have been successfully re-erected at the Kinston and Bentonville Battlefields. Fort Branch is a Confederate Earthen fort which was the closet military installation to Tarboro/Edgecombe County.

Tarboro/Edgecombe County and Fort Branch have a major connection for the time period. Tarboro/Edgecombe County has many of it's sons that spent time serving at Fort Branch. Historical family names for the town and county are represented among Fort Branch defenders. These names include Blount, Pippen, O'Neal, Webb, Dew, Carlisle, Stallings, Temple, and Norris. The town and county even sent some of its boys to defend the fort. These boys, 15-17 years old, served with the 70 NC Infantry (1st NC Junior Reserves). A couple of the family names were Clark and Overton. An abbreviated list of Tarboro/Edgecombe County soldiers that served at Fort Branch is attached to this proposal.

Fort Branch, in turn, came to the defense of Tarboro during the only time in its history to be attacked by an enemy force. On July 20, 1863, a raiding party under the command of Gen.

Edward E. Potter rode into Tarboro bringing fear, destruction and property loss with them. These raiders destroyed food stocks, bridges, warehouses and steamboats in Tarboro. They looted shops and homes of anything of value down to sewing needles and thimbles (so ladies of the town could not sew and mend confederate uniforms). Though these men were "US soldiers", they did not behave in the manner that we hope our soldiers do today.

When the Fort Branch garrison got word that an enemy force was threatening Tarboro, they came to it's defense. First, the 62<sup>nd</sup> Georgia Calvary left Fort Branch to meet the threat. At the same time, Lt. Col. John Lamb of the 17 NC Infantry marched companies D & G 17 NC from Fort Branch towards Tarboro. The first to reach Tarboro was the 62<sup>nd</sup> Georgia Calvary. They engaged the enemy at the river bridge in the area that is today, Princeville.

The small force that hit the raiders were serving as a "decoy" to lure the enemy out of Tarboro, which worked. The Union raiders split into two elements, one took up a position of defense in a revine that ran perpendicular to the river in the area of where Rick Williams Auto is today. The other followed the decoy force farther out of town.

While the 62th GA Calvary was leading one group of raiders out of town, the two companies of the 17<sup>th</sup> NC were moving from Shiloh Mills towards the river bridge. They met the force that had taken up a position in the ravine and went into battle. Yes, an unnamed battle occurred in the area of Rick Williams Auto that consisted of at least 400 soldiers and 4 cannons. This "stiff fight" lasted for over 2 hours before the Union raiders decided to start falling back towards the bridge.

Meanwhile, the 62<sup>nd</sup> GA Calvary continued to lure the other force farther out of town. In the area of Danielhurst, the plantation home of Rev. John Daniels, the 62<sup>nd</sup> had set up an ambush near a small school house. The bait soldiers of the 62<sup>nd</sup> GA Calvary led the raiders into a perfect ambush. They were hit by shotgun fire from both sides of the road. It resulted in at least 6 invaders killed and the wounded were housed in the schoolhouse (Battle of Daniels Schoolhouse). The invaders had no choice but to break contact and return to the bridge.

Once all of the Union soldiers made it back to the bridge, they set the bridge on fire in an attempt to destroy it. The 17<sup>th</sup> NC Infantry, companies D & G, moved in and were able to save the bridge. Sons of Tarboro and Edgecombe County were among the men that saved the bridge.

The 62<sup>nd</sup> GA Calvary also came into town to push the invaders out. They, actually, chased the Union raiders all the way to Street's Ferry, a crossing only 8 miles from New Bern, before breaking contact. The men that came from Fort Branch to defend and protect Tarboro did an exceptional job. The 62<sup>nd</sup> GA Calvary even picked up looted goods from homes and shops of Tarboro that the raiders discarded in their retreat to return to the citizens of Tarboro. This is well documented in books and contemparary newspaper articles.

This mutual assistance continued. At Christmas time in 1864, Fort Branch faced its greatest threat. "The Roanoke Expedition", consisting of 9 Union ships, was moving up the Roanoke River to attack the fort. The fort's cannons were manned by companies B, G, and H of the 1<sup>st</sup> NC heavy artillery. The only infantry force stationed in the area, at the time, was the 1<sup>st</sup> NC Junior Reserves. A force litterary made up of boys from 15 – 17 years old. These two units, with the aid of others that were close enough to respond in time were able to put up enough of a fight to stop

the enemy from advancing and push them back to their base. Both of these units contained Tarboro/Edgecombe County citizens. Their names are listed later.

In conclussion, there is and never has been a more appropriate site for the relocation of the Edgecombe County Confederate Soldier's monument than Fort Branch. If granted the monument, the Fort Branch Historical Society fully intends to re-erect it at Fort Branch to honor all soldiers that fought in the conflict. We would make plans to remove the components of the monument from town storage within 120 days.

I, myself, am a lifelong Tarboro resident except for the time I attended and graduatued from The Citadel, The Military College of South Carolina and served in the US Army. There is a lot more history that can be provided about the connections between the fort and Tarboro. Then if you want to go into the history of the monument itself and the organization that commissioned it, we could discuss Mrs. Patsy Shelton (the organist at my church as I grew up), mother of Gen. Henry (Hugh) Shelton and her successor Louise Norris (my Grandmother). I am deeply connected to the town, the fort, and the monument. I deeply care about the history that can be saved here.

I, on behalf of the Fort Branch Historical Society, thank the City Council for considering Fort Branch for the relocation of the Tarboro / Edgecombe County Confeterate Monument. We will do everything in our power to re-erect this monument to honor these veterans and keep it available to the public.

Subject: Bid Award - Public Safety Software

On October 15, 2020, staff submitted a Request for Proposals regarding the replacement of critical public safety software and hardware. This software specifically includes the Records Management System, Computer Aided Dispatch, Mobile Computer Aided Dispatch, and Field Based Reporting systems as well as the equipment needed to operate them. The current software used for these programs is more than 20 years old and is not compliant with the National Incident Based Reporting System, which is now the standard.

Two (2) companies responded with proposals prior to the deadline of November 12, 2020. Both of these companies are well qualified and capable of providing the services outlined within the proposal. After carefully reviewing the submitted documentation and attending presentations hosted by both vendors, it was determined that CentralSquare Technologies will provide the best solution for the Town of Tarboro. This is based upon CentralSquare providing a lower bid and their ability to better meet the police department's software needs.

It is recommended that Council award the bid to CentralSquare Technologies for their bid amount of \$184,079.19 and authorize staff to complete the necessary upgrades. It is anticipated that the funding for this project will be divided between the police department's current Capital Outlay allocation and the E911 Fund. The NC 911 Board has approved \$62,538.96 in eligible expenses.

RESOLUTION AMENDING THE TRAFFIC SCHEDULE OF THE TOWN OF TARBORO ADOPTED AS REQUIRED BY ARTICLE IX ENTITLED "TRAFFIC SCHEDULES" OF CHAPTER 19 ENTITLED "TRAFFIC" OF THE CODE OF ORDINANCES, TOWN OF TARBORO, NORTH CAROLINA, TO AMEND SUBSCHEDULE (31) RELATING TO PARKING LOT SPACES ADJACENT TO TOWN HALL.

WHEREAS, the Town Council of the Town of Tarboro pursuant to and in accordance with G.S. 160A-77 and 19-267 of Chapter 19 entitled "Traffic" of the Code of Ordinances, Town of Tarboro, North Carolina, has adopted Traffic Schedules for said Code of Ordinances; and

WHEREAS, it has been determined that Subschedule (31) of said Traffic Schedule should be amended as hereinafter set forth;

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Tarboro that Subschedule (31) of said Traffic Schedule is hereby amended to read as follows:

Subschedule (31) Municipal Parking Lot Reserved Spaces.

Parking spaces shall be reserved for the exclusive use of certain officials or purposes within the municipal parking lot located on the west side of Main Street and north of the town hall. The parking of vehicles shall be limited to two (2) hours between the hours of 8:00 a.m. and 6:00 p.m. every day except Saturdays and Sundays and legal holidays; provided, however, that this limitation shall not apply to those spaces appropriately marked as reserved parking spaces in such lots.

BE IT FURTHER RESOLVED that this Resolution be effective upon its adoption.
