3.1. Open public hearing regarding the City of Thrall 2022 Proposed Tax Rate.

A tax rate of \$0.422267 per \$100 valuation has been proposed by the governing body of City of Thrall.

PROPOSED TAX RATE \$0.422267 per \$100  
NO-NEW-REVENUE TAX RATE \$0.421409 per \$100  
VOTER-APPROVAL TAX RATE \$0.422267 per \$100

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for City of Thrall from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that City of Thrall may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that City of Thrall is proposing to increase property taxes for the 2022 tax year.

fees and the fees set forth in this ordinance; providing for reimbursement to the City for any third party service cost which the City is required to obtain when the City determines the third party service is reasonable or necessary to provide any service set forth in this ordinance or regarding development within the City; providing a severability clause; providing a repealing clause; providing a penalty of fine not to exceed the sum of five hundred dollars (\$500.00) for each offense, except where a different penalty has been established by state law for such offense, or for any violation of any provision which governs public health or sanitation which shall be punished by penalty of fine not to exceed the sum of two thousand dollars (\$2,000.00); and providing for publication.
