Sealed Bids: Sealed Bids for the construction of the **Puckett Park Basketball Court Improvements** will be received, by **Tift County Board of Commissioners**, at the **Charles A. Kent Administration Building, Room 207, 255 North Tift Avenue, Tifton, GA 31794**, until **11:30 A.M., Wednesday May 31st, 2023** local time, at which time the Bids received will be publicly opened and read. No bid may be withdrawn after the closing time for receipt of bids for a period of sixty (60) days.

Contractor License: Any Contractor submitting a bid must be licensed by the State of Georgia. License numbers must be written on the face of the bid envelope. No bid will be opened unless the license number is clearly shown. Any Contractor submitting a bid must have a minimum of three years' experience in the construction of recreational courts such as Basketball Courts, Tennis Courts, Pickleball Courts, etc. See Instructions to Bidders for additional bidding requirements.

Work to Be Done: The work to be done shall consist of furnishing all labor, materials and equipment necessary to construct the proposed **Puckett Park Basketball Court Improvements** as shown on the construction drawings. In general, construction consists of demolition of existing asphalt court, grading, fill material, base material, asphalt surfacing, painting, fencing, grassing, erosion control measures all associated measures for the complete project. This work will be awarded in one (1) contract with a **90** consecutive calendar day construction schedule.
