

CALLED SESSION
TIFT COUNTY BOARD OF COMMISSIONERS
WEDNESDAY, OCTOBER 28, 2020 (NOON)

The Called Session of the Tift County Board of Commissioners was called to order by Chairman Grady Thompson on Wednesday, October 28, 2020 at Noon in the Commission Meeting Room of the Charles Kent Administration Building. Members of the Commission present were Chairman Grady Thompson and Commissioners Paul Webb, Greg Wood, Donnie Hester, Fred "Buck" Rigdon, and Melissa Hughes. Commissioner Stan Stalnaker was absent.

Due to social distancing recommendations during the COVID-19 pandemic, the meeting was also available via teleconference. Notice of this meeting was given to the Tifton Gazette (legal organ), WALB News, Fun Channel, Grapevine, posted on the County's Website and Facebook page and posted at the Charles Kent Administration Building. The notice contained direction and opportunity for any citizens desiring to attend the meeting by phone.

- A. **Resolution No. 2020-19, Joint Resolution for Service Delivery Strategy Agreement:** County Manager Jim Carter stated that the resolution being considered would adopt the Form 2s and accompanying agreements necessary for submission to DCA for Service Delivery. Mr. Carter read over several portions of the resolution. Commissioner Fred "Buck" Rigdon made a motion to approve Resolution No. 2020-19. Motion was seconded by Commissioner Melissa Hughes. Motion carried 6-0 with the Chairman voting.

Clerk's Note: New agreements approved with this Resolution include Animal Control Services, Development Support Services, E911 Services, Jail Inmate Services, Mosquito Control Services, Tax Collection Services and Voter Registration and Election Services.

EXECUTIVE SESSION:

Commissioner Melissa Hughes made a motion to enter into Executive Session for the purpose of pending litigation. Motion was seconded by Commissioner Greg Wood. Motion carried 6-0 with the Chairman voting.


