

**CALLED JOINT MEETING  
TIFT COUNTY BOARD OF COMMISSIONERS

CITY OF TIFTON MAYOR AND COUNCIL  
THURSDAY, March 31, 2014 (5:00 P.M.)**

The scheduled Called Meeting of the Tift County Board of Commissioners and the City of Tifton Mayor and Council was called to order by Chairman on Monday, March 31, 2014, at 5:00 P.M. at the Welcome Station in the City of Tifton. **The purpose of this meeting was for Presentations from Waste Pro and Golden Environmental of their Proposal for Countywide Garbage Pickup.**

**After both presentations have been completed the vendors will be dismissed to allow for time for discussion by the Council and Commission members.**

**Each vendor addressed in their presentations the Criteria that was addressed in the proposal. Both proposals will become a permanent record in the Tift County Board of Commissioners Office and may be viewed upon request.**

**Several Commissioners and Council persons had questions for both vendors as will as directing some questions to the City and County Manager as well as the respective attorneys.**

**County Attorney Tony Rowell then address the Governing Bodies for discussion of the evaluation sheet which is to be used for each individuals preface, it was designed to be a working tool through this process. He then explained that each body will need to vote separately on the selection of the vendor and suggested that another meeting be called for Monday, April 7, 2014 at the same location at 5 PM for the voting process to take place. It was agreed upon by both bodies to schedule this meeting for the vote.**
