

**REGULAR SESSION  
TIFT COUNTY BOARD OF COMMISSIONERS  
MONDAY, APRIL 13, 2015 (6:00 P.M.)**

The scheduled Regular Session of the Tift County Board of Commissioners was called to order by Chairman Thompson on Monday, April 13, 2015, at 6:00 P.M. in the Commissioners Meeting Room in the Administrative Building. Member of the Commission present including Chairman Thompson were Vice Chairman Donnie Hester and Commissioners Robert Setters, Greg Wood, Buck Rigdon, Stan Stalnaker, and Melissa Hughes.

Commissioner Setters gave the invocation followed by the pledge to the flag.

**E. Appointment to the Tift County Department of Family & Children Services:** It is the recommendation of the Department of Family & Children Services for the Board's consideration of the reappointment of Audrey Cromer. Chairman Thompson opened the floor for nominations. Vice Chairman Hester nominated Audrey Cromer. There were no further nominations and Chairman Thompson closed the nomination process. Motion was made by Vice Chairman Hester to reappoint Audrey Cromer to serve another five year term, seconded by Commissioner Setters. Motion carried unanimously.

**F. Appointment to the Tift County Hospital Authority:** Letter of recommendation was submitted by the Hospital Authority with three names in order of preference to fill the expired term of John Prince. Chairman Thompson opened the floor for nominations. Commissioner Hughes nominated Dr. Jessica Beier. There were no further nominations and Chairman Thompson closed the nomination process. Motion was made by Commissioner Hughes to

appoint Dr. Jessica Beier to fill the vacant position on the Hospital Authority Board, seconded by Commissioner Stalnaker. Motion carried unanimously.

**G. Appointment to the Community Service Board/Behavioral Health Services:** At a previous meeting Commissioner Stalnaker was appointed to fill this position however because of time conflicts he will not be able to serve. Staff has discussed this position with Chad Alexander, Tax Commissioner and he has expressed a desire to serve. The Chairman opened the floor for nominations. Commissioner Setters nominated Chad Alexander. There were no further nominations and Chairman Thompson closed the nomination process. Motion was made by Commissioner Setters to appoint Chad Alexander to serve on the Community Service Board/Behavioral Health Services Board, seconded by Vice Chairman Hester. Motion carried unanimously.
