# REGULAR SESSION TIFT COUNTY BOARD OF COMMISSIONERS MONDAY, NOVEMBER 13, 2017 (6:00 PM)

The scheduled Regular Session of the Tift County Board of Commissioners was called to order by Chairman Grady Thompson on Monday, November 13, 2017 at 6:00 pm in the Commission Meeting Room of the Charles Kent Administration Building. Members of the Commission present were: Chairman Grady Thompson and Commissioners Robert Setters, Greg Wood, Donnie Hester, Fred "Buck" Rigdon, Stan Stalnaker and Melissa Hughes.

Commissioner Melissa Hughes offered an invocation followed by the Pledge of Allegiance to the United States Flag.

### MINUTES:

Commissioner Donnie Hester made a motion to approve the following minutes: (1) Workshop Session – October 3, 2017 and (2) Regular Session – October 9, 2017. Motion seconded by Commissioner Robert Setters. The motion carried 6-0.

### **PUBLIC COMMENTS:**

Magnolia Henderson-Martin, 3108 4<sup>th</sup> Street, expressed her concerns regarding the following: (1) inclusion of walking trails in TSPLOST when there are other needs in the South part of town and (2) condition of vacant properties – in particular a vacant lot next to hers owned by Greg Branch.

Sharon Petzel, Tiftarea Greenway Association, spoke on the benefits of having a walking/biking trail in the community.

Marianne Hill, 1021 Love Avenue, spoke regarding the following items: (1) ordinances on code enforcement need to be worked on to help clean up blighted properties; (2) the community's perception of the county is not good; and (3) walking trails do not belong in TSPLOST.
