Commissioners Greg Wood and Donnie Hester asked everyone to keep the County Manager and family in their prayers during his mother's illness.



EXECUTIVE SESSION:


There was none to report.




Chairman Grady Thompson, District 7




Commissioner Tony McBrayer, District 3
