LOWNDES COUNTY POLL WORKER TRAINING; We visited their poll worker training and learned a lot. We used their idea to create a Forms Notebook.

REGIONAL MEETING LOWNDES; The regional meeting will be October 6th, to discuss redistricting, new SEB rules and SB 202.

RECALL APPLICATION; We had on person on the recall application and it was completed the same day on September 21st. The process was completed in Enet as well.

L&A PUBLIC NOTICE; Will run in the paper on August 25th and L&A will start on September 2nd or as soon as we get the data base.

DROP BOX; The drop box has been moved inside according to SB202 rule. We moved the one in front of the Admin building.

ELECTION NIGHT; After Polls have closed must call in the scanner numbers and Provisional numbers before doing anything else. In addition, the Board had a long discussion about how to get the memory cards back into Election Central. After much discussion the Board agreed that if by 8:00 pm the memory cards are not in, the poll manager needs to call the office and come on in even if they are not finished or have not balanced.

REGISTRATION DRIVES; Anyone wanting to have a drive should get rules and regulations before having the drive.

With no further business Taylor made a motion to adjourn; and Kimbrough seconded.
