

**TIFT COUNTY BOARD OF ELECTIONS & REGISTRATION
BOARD MEETING
Monday – January 25, 2021**

BOARD MEMBERS PRESENT: Robinson, Taylor, Kimbrough, McKee, Paulk.

SUPERINTENDENT- Kimbrough called the meeting to order.

Swearing in of the new Superintendent Stephanie McKee; Kimbrough called for the motion to swear in Kimbrough. Taylor made a motion for McKee to serve one year as the Superintendent; seconded by Kimbrough, all members agreed and McKee was approved as Superintendent.

MINUTES:

Each Board Member read and signed the minutes; Taylor made a motion to approve the minutes; Kimbrough seconded; all of the members agreed and the minutes were approved and accepted.

BUDGET:

The Board was briefed by Dollison on the current budget; Dollison stated that the budget was in good standing. Taylor made the motion to accept the budget; seconded by Taylor; all approved, budget accepted.

GENERAL AGENDA ITEMS:

Amos Kimbrough Reappointment; Amos will accept the reappointment in April. Dollison stated she has the letter ready for the Representatives.

McKee moved on to the next item on the agenda; Overview of January 5th Election Runoff: McKee brought up several issues that needed addressing. The phone on Election Day; McKee suggested that one person answers the call take the information and respond by email or phone. After much discussion the Board agreed to look at how this could be done or modified. The other issue is making sure Tech's are assigned to the precincts that need the most help. In addition, there was a huge discussion on training and poll manager following instructions. It was agreed that we needed hands on training. Dollison informed the Board that Dominion sent out Tech fees for counties needing that service.

McKee asked Dollison to address appointment of Poll managers. Dollison stated that all poll managers had agreed to serve for the 2021 Election year. The Board appointed the Poll managers by consensus; all members agreed and the Poll managers were approved.

Felon List. Holley stated the felon list is running its usual course with no challenges.

2021 Election Dates; The Election Dates were presented to each member. See attachment.


McKee moved to the next agenda item. Offices up for Re-Election; District 1 Johnny Terrell, District 3 Wes Ehlers.



With no further business Paulk made a motion to adjourn; and Taylor seconded.


