

**TIFT COUNTY BOARD OF ELECTIONS & REGISTRATION

**MINUTES:**

Each Board Member read and signed the minutes; Taylor made a motion to approve the minutes; Kimbrough seconded; all of the members agreed and the minutes were approved and accepted.

**BUDGET:**

The Board was briefed by Dollison on the current budget; Dollison stated that the budget was in good standing. Taylor made the motion to accept the budget; seconded by Kimbrough; all approved, budget accepted.

**GENERAL AGENDA ITEMS:**

**Budget Worksheet;** The budget was turned in with all budget needs being requested. A proposed increase for the poll workers and the Board. Requested the purchase of two Poll Pads and Poll worker training for 1 day at \$2000. In addition, from the old budget we purchased a shredder. We received it last week.

**Signature Match;** SOS and UGA wants us to send in all Absentee Ballot Cure Affidavits and oath envelopes. We have filed the documents with the Clerk of Court and until we get a Court order we cannot open the boxes.

McKee asked Dollison to address the **100% Audit;** Voter registration applications need to be checked for accuracy and that involves moved out of county, moved out of state, deceased, felons and cancelled voter requested. In addition, we need to check all streets from each municipality to make sure all streets are correct before redistricting.

**Felon List;** Holley stated the felon list is running its usual course with no challenges.

**Georgia Extended Warranty;** We will have to start paying for the warranty 2022. It was put in the budget for 2022.

McKee moved to the next agenda item. **GAVERO Conference;** will be held on August 29<sup>th</sup> thru September 1<sup>st</sup>. The room reservations have been made. Three people are allowed to attend this year

due to COVID. The Westin is where we will be staying. Conference registration has not been sent out yet

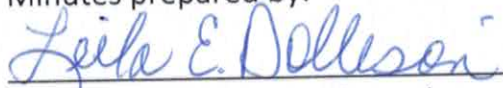
**Election Bills;** Mr. Perry spoke briefly on what is coming up.

**The Election calendar and qualifying packet** was presented to the Board.

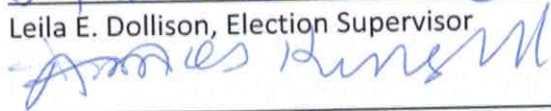
With no further business Kimbrough made a motion to adjourn; and Taylor seconded.

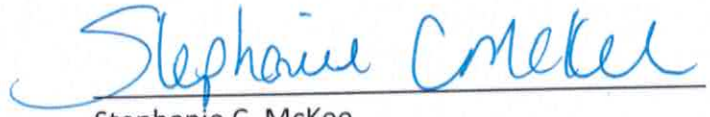

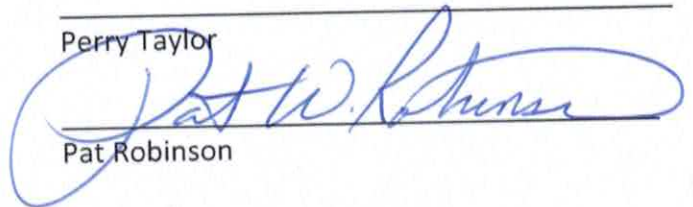
