Please accept the following report for the month of April.


- Police Activity Graph for the month of April 2021 attached. Total calls for service 850.
- Both applicants completed the test for the open Sergeant's position. On Wednesday 04/28/2021 both candidates took part in a lengthy interview administered by all three supervisors. A second interview will be next Wednesday. Both Officers are performing well.
- On Saturday April 24 we had a drug take back day. The event was very successful. It was a positive community policing event.
- Our newest Officer Jacob Poulin just completed his twelfth week of training. The program is very demanding and filled with many challenges. During the month of May, he will begin to transition from being closely supervised to ultimately working on his own. Several Officers have helped with his training creating a strong team effort.

Dear Chief Macdaid,

We would just like to express our utmost gratitude to your department and officers.

Late on the evening of the 13th of April our moving company phoned as said they would be delivering to us the following day. We have waited weeks for this so we were very excited, however the driver was extremely rude and said that as we lived on a State Highway (we live at 28 Smiley Avenue) he would not be able to deliver our belongs and it would be an additional \$727 to shuttle our belongings. Through their customer support we discovered there was an option to have the police there to warn traffic about the truck on the road - the driver insisted that he needed a permit, and they would have to stay there the whole time. It seems the driver didn't want to do our delivery, he wanted to pass it off to a smaller truck but paying the extra cash was just something we couldn't afford at this time.

We phoned the Winslow Police Department and spoke to Police Officer/ACO Charles Theobald. Officer Theobald was amazing and offered to put together an email on letterhead to provide to the driver...however the driver was not happy with that and demanded Officer Theobald's phone number to 'tell him the rules'.

Later when we spoke to Officer Theobald, he advised that the driver was not happy with the email and that WPD would provide an officer to assist with warning traffic and help us out. Whilst Officer Theobald was ever the professional, he alluded to the fact that the driver had been difficult with him, the driver is literally the rudest man we have ever dealt with, so we are grateful for Officer Theobald's patience.

Today when the moving company driver showed up, we were blessed to have Patrol Officer Jacob Poulin present. Officer Poulin was so professional and polite even though the driver was extremely rude. The driver did not have a ramp so he was unable to take our large tool chest off his truck, but Officer Poulin was able to recommend a local flatbed company to assist the driver.

Both Officer Theobald and Officer Poulin are a credit to the Winslow Police Department. As two Aussies, a long way from home and new to the area we are truly grateful to have moved to a community like Winslow.

## MUTUAL AID AGREEMENT FOR POLICE SERVICES BETWEEN THE COMMUNITIES OF WATERVILLE, WINSLOW, OAKLAND, FAIRFIELD & CLINTON

This Agreement between the participating municipalities and law enforcement agencies is effective April 1, 2021, and supersedes all previous Agreements on this subject.

This Agreement is made and entered into by and among the City of Waterville, and the Towns of Winslow, Oakland, Fairfield and Clinton to facilitate law enforcement mutual aid between the aforementioned municipalities, pursuant to 30-A MRSA section 2674, as the same may be amended from time to time. The terms of this agreement are as follows:

- Mutual aid assistance will be made when either police agency requires
  additional manpower and/or resources to protect life or property, to maintain
  order, to prevent the commission of criminal acts, to prevent the escape of a
  person who has committed a criminal act, and to ensure officer safety
  pursuant to standard police practice and training guidelines.
- 2. Mutual aid assistance will be provided when either police agency requires assistance for a major unplanned incident or lack of sufficient manpower that jeopardizes the health and welfare of the citizens of the requesting municipality and when delay or limited staffing may cause further jeopardy to life or property or in the case of jointly planned collaborative activity.
- 3. In the event of a mutual aid situation, the Chief of Police or designee of the agency requiring mutual aid shall contact the Chief of Police or designee of the agency from which mutual aid is being requested and provide information that is relevant for appropriate response and record keeping.
- 4. In the event of a mutual aid situation, each assisting agency will furnish personnel, equipment, or services that are available, in the opinion of the assisting department's Chief of Police or designee. The assisting agency's Chief of Police or designee must take into consideration the continuing amount of police protection required within its jurisdiction when making this decision and may deny a request for mutual aid based on the needs within its jurisdiction.
- 5. In the event of a mutual aid situation, each assisting agency will be responsible for the wages, pension, workers' compensation and other benefits incurred by its own personnel, and shall be liable, if any liability is determined to exist, for personal injury or property damages caused by or occurring to its own personnel in the course of providing assistance, except for liability incurred by the command or operational decisions made by the

requesting department which will be assumed by the requesting department.

- 6. Police Officers responding to mutual aid assistance requests outside of their appointed jurisdiction shall have the same authority as Police Officers of the requesting agency and, when assisting other municipalities, shall have the same privileges and immunities as when acting in their own municipality and as an officer of the requesting agency, except as to the service of civil process.
- 7. Each municipality represents to the others that it has full and complete authority to enter into the Agreement and the person executing this Mutual Aid Agreement on its behalf is duly authorized to do so.
- 8. A municipality may terminate participation in this Agreement by vote of the municipality's municipal officers, with or without cause, upon written notice to the other municipality parties to this Agreement.
- 9. All written notices shall be deemed to have been properly given if personally delivered or sent by United States certified or registered mail, return receipt requested, postage prepaid, addressed to a party for whom it is intended as its address herein set forth:

If to Waterville

- 10. Any subsequent modifications or amendments relating to this Agreement shall be in writing and be signed by all parties.
- 11. If any term, covenant, or condition of this Agreement, or the application thereof to any person or circumstance shall to any extent be invalid or unenforceable, the remainder of this Agreement, or the application of Page 3 of 5

- such term, covenant or condition to the other persons or circumstances, shall not be affected thereby, and each term, covenant or condition of this Agreement shall be valid and enforceable to the fullest extent of the law.
- 12. Each party represents to the other, and each relies upon the other's representation, that they and their undersigned representatives are fully authorized and empowered to enter into this Agreement and to bind their principals and constituents.
- 13. The benefits and burdens of this Agreement shall inure to and be binding upon the successors, assigns, and constituents of Waterville, Winslow, Oakland, Fairfield and Clinton.
- 14. This Agreement shall be construed and governed under the laws of the State of Maine.
- 15. Each of the parties hereto agrees to take any and all actions reasonably necessary in order to effectuate the intent and to carry out the provisions of this Agreement.
- 16. This Agreement may be executed in multiple counterparts, each of which shall constitute an original, but all of which shall constitute one and the same Agreement.
