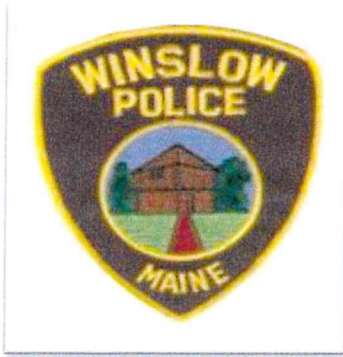
Please accept the following report for March.

- On 03/26/22 Scott Christiansen resigned from his position as a police officer.

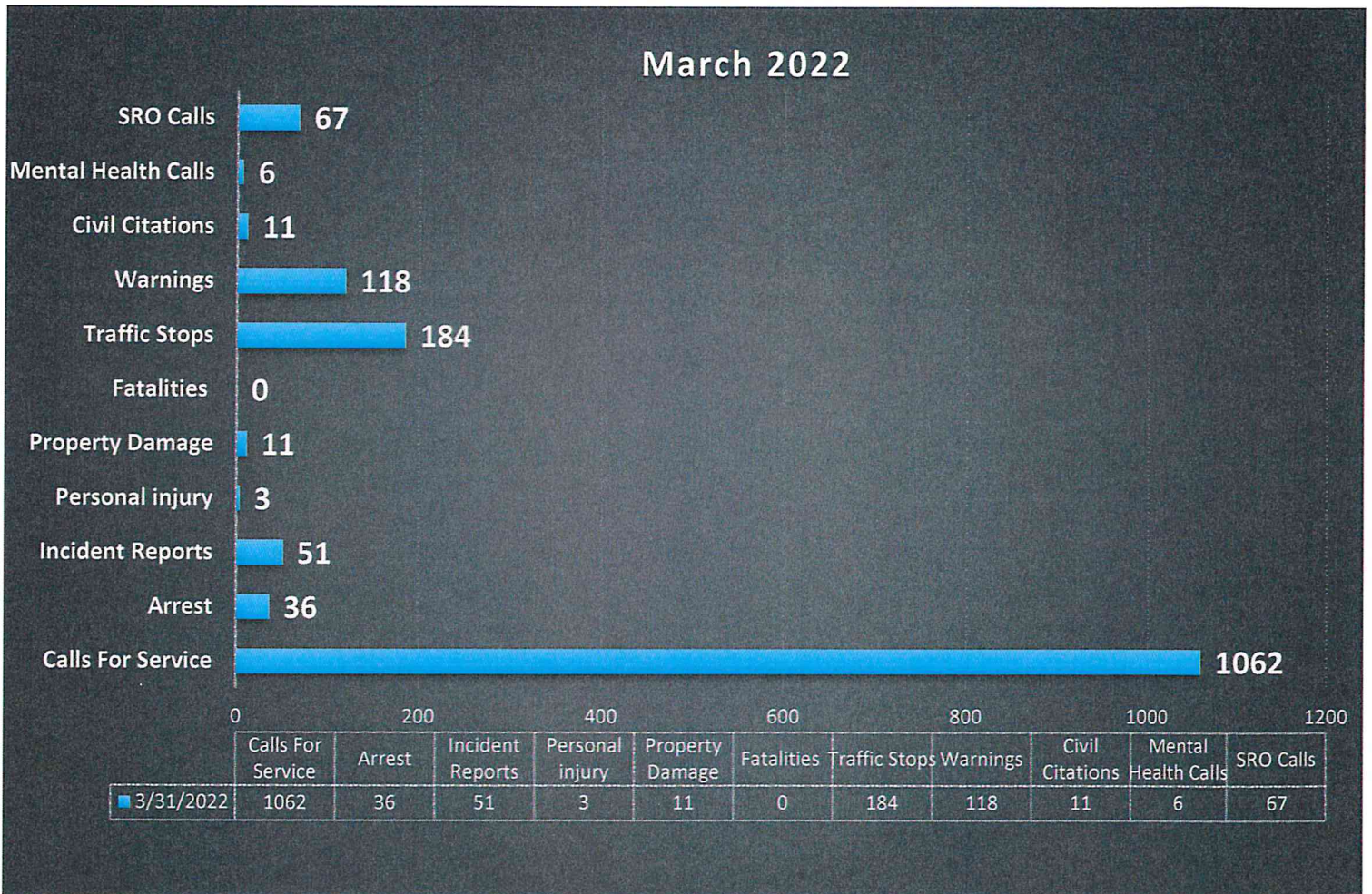

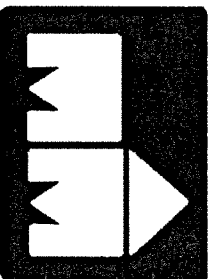
