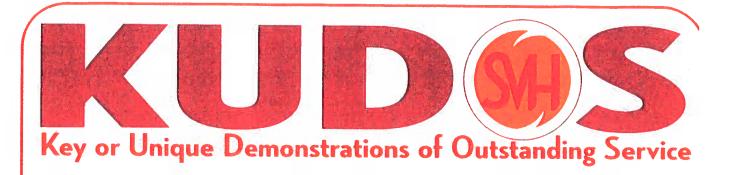

Re: Recommendation for Medal of Commendation

On October 9, 2019 about 2230 hours there was a large structure fire at 501 S. Broadway (Cielo Vista RV Park). First of all, all of our officers did an outstanding job evacuating citizens from nearby trailers and 5th wheels. But one officer stood out in doing so, Officer Sergio Maldonado. After clearing everyone from the area, he made one last sweep to make sure. This is when he located a male crouching down hiding behind his trailer. Officer Maldonado made contact and found out that there was still one more person exposed to the fire.

By this time, there had been a few explosions, 1 vehicle and 3 trailers were fully engulfed in flames.

Despite the danger, Officer Maldonado worked his way around the fire and located the male only feet away from the fire, who was severely burned throughout his body from one of the explosions. Officer Maldonado grabbed the male by the arms but only pulled him a short distance away. He then radioed for assistance but his transmissions did not go through.

It was at this time, Officer Maldonado lifted the male onto a nearby picnic table to get him in the upright standing position. Officer Maldonado then placed the male across his shoulders in a "fireman" carry position. He then carried him around the fire to a safe location away from the fire so the male could receive immediate medical attention.

This act is characterized by obvious self-sacrifice of his own safety while facing personal danger. I recommend that Officer Maldonado be recognized for this incident by receiving the Medal of Commendation for his actions.

Attached is a copy of Officer Maldonado's memo from the incident along with a portion of the policy that includes the awards.

City Clerk Cantin gave an overview of her understanding of the funding, which is 1% of the Lodger's Tax revenue. The spreadsheets of the expenses show a starting balance for FY 2018/2019 as \$6000 and there was \$2208 spent, so she estimated a balance for the FY a little less than \$3800. Mr. Madrid indicated that final numbers would not be available until the budget is approved by the DFA and he would check on the final amount.

C. ENGINEERING FOR REED ROCKETS

Traci Burnett wasn't available to give a report on the engineering, but Mr. Madrid indicated that we do have an engineer on hold that we can use to possibly see what we can do with putting the Reed Rockets up.

The board discussed including the Reed Rockets with the Foch Street project, because they were interested in art projects.

Summary/Background:

The City or T or C is in need of rehabilitating its service area vacuum sanitary sewer collection system. The vacuum system was first constructed in 1995, followed by a second phase in 1997, making the collection and vacuum system well over 20 years old. The vacuum sensors are beginning to deteriorate and malfunction, causing for manual start-up and have experienced vacuum pit overflow. The existing vacuum station is out of current building code compliance and requires lighting and insulation upgrades. A horizontal vacuum station pump (one of two) is no longer operable and requires replacement. One of the check-valves is no longer function properly and requires replacement. New energy saving lighting and controls also need to be re-evaluation and upgraded to current industry standards. Finally, there are isolated areas were the sanitary sewer service lines appear to be less than 1/2" per foot drop, causing issues with the wastewater collection. The vacuum pits and service connections require survey and analysis for vertical pit adjustments. The desired end result is to rehabilitate all the valve pit packages, adjust isolated vacuum pits to improve sanitary sewer service connections, replace a single failed horizontal sewage pump, replace station controls, upgrade Light-emitting diodes (LED) lighting for energy savings, and upgrade the Vacuum Station building to comply with current UBC code. The end result is to (1) prevent surface spills at vacuum pits, (2) improve the collection of waste water, (3) bring the Vacuum Station to current UBC Code Compliance, and (4) to rehabilitate pumping system equipment in the Vacuum Station.

ORDINANCE NO. 708

AUTHORIZING THE CITY OF TRUTH OR CONSEQUENCES ("BORROWER") TO ENTER INTO A LOAN AGREEMENT WITH THE NEW MEXICO ENVIRONMENT DEPARTMENT ("NMED") FOR THE PURPOSE OF OBTAINING PROJECT LOAN FUNDS IN THE PRINCIPAL AMOUNT OF \$373,000.00 PLUS 1.2% ACCRUED INTEREST; AND LOAN SUBSIDY GRANT FUNDS IN THE AMOUNT OF \$100,000.00 FOR A TOTAL FUNDED AMOUNT OF \$473,000.00; DESIGNATING THE USE OF THE FUNDS FOR THE PURPOSE DEFINED IN THE MOST CURRENT PROJECT DESCRIPTION FORM AS APPROVED BY NMED; DECLARING THE NECESSITY FOR THE LOAN; PROVIDING THAT THE LOAN WILL BE PAYABLE AND COLLECTIBLE SOLELY FROM THE BORROWER'S PLEDGED REVENUES DEFINED BELOW; PRESCRIBING OTHER DETAILS CONCERNING THE LOAN AND THE SECURITY THEREFOR.

Capitalized terms used in the following preambles are defined in Section 1 of this Ordinance, unless the context requires otherwise.

WHEREAS, the Borrower is a legally and regularly created public body organized under the general laws of the State of New Mexico ("State"); and

WHEREAS, the Borrower now owns, operates and maintains a public utility constituting a Wastewater System (System), which includes a system for disposing of wastes by surface and underground methods; and

WHEREAS, the present System is insufficient and inadequate to meet the needs of the Borrower; and

WHEREAS, the Loan Agreement and Note will be payable solely from the Pledged Revenues; and

WHEREAS, the funds for this Project will include funds from a one-time federal grant to the NMED from the Environmental Protection Agency ("EPA"); and

WHEREAS, the Project is subject to specific requirements of the federal grant; and

WHEREAS, the Borrower has the following obligations outstanding to which the Pledged Revenues have already been pledged:

WHEREAS, the Governing Body of the Borrower has determined that it is in the best interest of the Borrower to accept and enter into the Loan Agreement and to execute and to deliver the Note to the NMED.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE BORROWER:

Section 1. DEFINITIONS. As used in the Ordinance, the following terms shall have the meanings specified below, unless the context clearly requires otherwise (such meanings to be equally applicable to both the singular and the plural forms of the terms defined unless the plural form is separately defined):

ACT. The general laws of the State, including the Wastewater Facility Construction Loan Act at sections 74-6A-1 to 74-6A-15 NMSA 1978, as amended; enactments of the governing Body of the Borrower relating to the Note and the Loan Agreement made by resolution or ordinance, including this Ordinance; and the powers of the Borrower as a public body under authority given by the Constitution and Statutes of the State.

ANNUAL AUDIT or SINGLE AUDIT. Financial statements of the Borrower as of the end of each Fiscal Year, audited by an Independent Accountant, consistent with the federal Single Audit Act and the State Auditor's rules.

AUTHORIZED OFFICER. The Borrower's mayor, chief administrative officer, or other officer or employee of the Borrower as designated by the Borrower's Resolution Number <u>09 19/20</u> adopted by the governing body of the Borrower, as amended.

BORROWER. The entity requesting funds pursuant to the Act.

FISCAL YEAR. The twelve-month period commencing on the first day of July of each year and ending on the last day of June of the succeeding year, or any other twelve-month period which the Borrower hereafter may establish as the fiscal year or the System.

FUNDS. Loan and Loan Subsidy Grant funds.

GOVERNING BODY OF THE BORROWER (e.g., Council, Commission, Board, etc.)

Council.

LOAN. A loan of funds from NMED made pursuant to the Loan Agreement.

LOAN AGREEMENT. The loan agreement between the Borrower and the NMED, pursuant to which funds will be loaned to the Borrower to construct the Project and pay eligible costs relating thereto; and the final loan agreement which shall state the final amount the NMED

loaned to the Borrower, which shall be executed upon completion of the Project and dated on the date of execution.

LOAN SUBSIDY GRANT. A sub-grant of funds to the Borrower from a one-time federal grant of funds to the NMED by EPA, for the purpose of subsidizing the amount loaned to the Borrower under the Loan Agreement and Note.

NMSA. New Mexico Statutes Annotated, 1978 Compilation, as amended and supplemented.

NOTE. The interim and final promissory notes issued by the Borrower to the NMED evidencing the obligation of the Borrower to the NMED incurred pursuant to the Ordinance and Loan Agreement.

OPERATION AND MAINTENANCE. All reasonable and necessary current expenses of the System, paid or accrued, relating to operating, maintaining and repairing the System.

ORDINANCE. This Ordinance as amended or supplemented from time to time.

PARITY BONDS or PARITY OBLIGATIONS. Revenue Bonds and other bonds or other obligations payable from the Pledged Revenues issued with a lien on the Pledged Revenues on parity with the bonds or obligations as listed in this Ordinance.

PLEDGED REVENUES. Wastewater System Revenues.

PROJECT. The most current NMED approved Project Description listed on the Project Description Form on file with NMED.

PROJECT COMPLETION DATE. Means the date that operations of the completed works are initiated or capable of being initiated, whichever is earlier. This also applies to individual phases or segments.

REGULATIONS. Regulations promulgated by the Water Quality Control Commission at 20.7.5 NMAC and New Mexico Environment Department at 20.7.6 – 20.7.7 NMAC

SUBORDINATE OBLIGATIONS. Other obligations payable from the Pledged Revenues issued with a lien on the Pledged Revenues subordinate to the lien of the Loan Agreement and Note as may be listed in this Ordinance.

Section 2. RATIFICATION. All action heretofore taken (not inconsistent with the provisions of the Ordinance) by the Board, the officers and employees of the Borrower, directed toward the Loan Agreement and the Note, is hereby ratified, approved and confirmed.

Section 3. FINDINGS. The Governing Body of the Borrower hereby declares that it has considered all necessary and relevant information and data and hereby makes the following findings:

- (A) The execution and delivery of the Loan Agreement and the Note pursuant to the Act to provide funds to finance the Project, is necessary and in the interest of the public health, safety, and welfare of the residents of the Borrower and will result in savings of finance costs to the Borrower.
- (B) The money available for the Project from all sources other than the Loan Agreement is not sufficient to pay when due the cost of the Project.
 - (C) The Project is and will be part of the System.
- (D) The Pledged Revenues may lawfully be pledged to secure the payment of amounts due under the Loan Agreement and Note.

Section 4. SYSTEM. The System shall continue to constitute a Wastewater system and shall be operated and maintained as such.

Section 5. AUTHORIZATION OF PROJECT. The acquisition and construction of the Project and payment of eligible items as set forth in the Regulations from proceeds of the Loan Agreement and Note is hereby authorized at a cost not to exceed the principal Loan amount of

\$373,000.00 and the Loan Subsidy Grant amount of \$100,000.00 excluding any cost of the Project to be paid from any source other than the proceeds of the Loan Agreement and Note.

Section 6. AUTHORIZATION OF LOAN AGREEMENT.

For the purpose of protecting the public health, conserving the property, and (A) protecting the general welfare of the residents of the Borrower and acquiring the Project, it is hereby declared necessary that the Borrower, pursuant to the Act and the Regulations execute and deliver the Loan Agreement and Note, and the Borrower is hereby authorized to execute and deliver the Loan Agreement and the Note, to be payable and collectible solely from the Pledged Revenues. The NMED has agreed to disburse the proceeds according to the terms of the Loan Agreement to the Borrower over the construction period of the Project. The principal Loan amount of the Note shall not exceed \$373,000.00 plus accrued interest without the adoption of another Ordinance amending the Ordinance by the Governing Body of the Borrower, and the annual interest rate on that principal amount shall not exceed 1.2 percent per annum. Interest shall be computed as a percentage per year on the outstanding principal amount on the Loan on the basis of a 365-day year, actual number of days lapsed. The final maturity date on the Note shall not extend beyond the agreed upon useful life of the project. The Loan shall be repaid in substantially equal annual installments in the amount and on the dates provided in the Loan Agreement with the first annual installment due no later than one year after completion of the project. The Borrower must maintain a debt service coverage ratio of no less than 1.2 and must also obtain the written consent of the NMED before issuing additional obligations secured by the Pledged Revenues.

- (B) The Borrower is hereby authorized to accept a Loan Subsidy Grant under the terms of the Loan Agreement. The Loan Subsidy Grant amount shall not exceed \$100,000.00 without the adoption of another Ordinance amending the Ordinance by the Governing Body of the Borrower. By accepting a Loan Subsidy Grant, the Borrower is a sub-recipient of a one-time federal grant of funds to NMED by EPA. As a sub-recipient, the Borrower is responsible for complying with the specific requirements and the conditions of the one-time federal grant. If the Borrower fails to satisfy any federal grant requirements or conditions, the Borrower may be required to refund any federal grant funds disbursed to the Borrower from NMED.
- Officer is hereby authorized and directed to execute and deliver the Loan Agreement and the Note and any extensions of or amendments to any such document to be executed after completion of the Project, or any substitution therefore, with such changes therein consistent with the Ordinance and as shall be approved by an Authorized Officer whose execution thereof, or any extension thereof, or substitution therefore, in their final forms shall constitute conclusive evidence of their approval and compliance with this section.
- (D) From and after the date of the initial execution and delivery of the Loan Agreement and the Note, Authorized Officers, agents and employees of the Borrower are authorized, empowered and directed to do all such acts and things and to execute all such documents as may be necessary to carry out and comply with the provisions of this Ordinance, the Loan Agreement and the Note.

<u>Section 7.</u> SPECIAL LIMITED OBLIGATIONS. The Loan Agreement and the Note and all payments thereon shall be special limited obligations of the Borrower and shall be payable and collectible solely from the Pledged Revenues which are irrevocably pledged as set forth in this

Ordinance. The NMED may not look to any general or other fund for the payment on the Loan Agreement and the Note except the designated special funds pledged therefore. The Loan Agreement and the Note shall not constitute indebtedness or debts within the meaning of any constitutional, charter or statutory provision or limitation, nor shall they be considered or be held to be general obligations of the Borrower and shall recite that they are payable and collectible solely from the Pledged Revenues the income from which is so pledged.

<u>Section 8.</u> **OPERATION OF PROJECT**. The Borrower will operate and maintain the Project so that it will function properly over its structural and material design life.

Section 9. USE OF PROCEEDS. The NMED shall disburse Funds pursuant to the Loan Agreement for NMED approved costs incurred by the Borrower for the Project or to pay contractors or suppliers of materials for work performed on the Project as set forth in the Loan Agreement.

Section 10. APPLICATION OF REVENUES.

- (A) OPERATION AND MAINTENANCE. So long as the Loan Agreement and the Note are outstanding, either as to principal or interest, or both, the Borrower shall pay for the operation and maintenance expenses of the System, approved indirect charges and any amounts for capital replacement and repair of the System as incurred.
- (B) PARITY OBLIGATIONS AND OTHER APPROVED DEBT(S). The Borrower shall pay the principal, interest and administrative fees (if applicable) of parity obligations and other approved debts which are secured from the Pledged Revenues as scheduled.
- (C) EQUITABLE AND RATABLE DISTRIBUTION. Obligations of the Borrower secured by the Pledged Revenues on parity with the Loan Agreement and the Note, from time to

time outstanding, shall not be entitled to any priority one over the other in the application of the Pledged Revenues, regardless of the time or times of their issuance or creation.

(D) SUBORDINATE OBLIGATIONS. The Pledged Revenues used for the payment of Subordinate Obligations shall be applied first to the payment of the amounts due the Loan Agreement and the Note, including payments to be made to other obligations payable from the Pledged Revenues which have a lien on the Pledged Revenues on parity with the Loan Agreement and the Note.

Section 11. LIEN OF LOAN AGREEMENT AND NOTE. The Loan Agreement and the Note shall constitute irrevocable liens upon the Pledged Revenues with priorities on the Pledged Revenues as set forth in this Ordinance. The Borrower hereby pledges and grants a security interest in the Pledged Revenues for the payment of the Note and any other amounts owed by the Borrower to the NMED pursuant to the Loan Agreement.

Section 12. OTHER OBLIGATIONS. Nothing in the Ordinance shall be construed to prevent the Borrower from issuing bonds or other obligations payable from the Pledged Revenues and having a lien thereon subordinate to the liens of the Loan Agreement and the Note. The Borrower must obtain the written consent of the NMED before issuing additional obligations secured by the Pledged Revenues.

Section 13. DEFAULT. The following shall constitute an event of default under the Loan Agreement:

(A) The failure by the Borrower to pay the annual payment due on the repayment of the Loan set forth in the Loan Agreement and Note when due and payable either at maturity or otherwise; or

(B) Default by the Borrower in any of its covenants or conditions set forth under the Loan Agreement (other than a default described in the previous clause of this section) for 60 days after the NMED has given written notice to the Borrower specifying such default and requiring the same to be remedied.

UPON OCCURRENCE OF DEFAULT:

- (A) The entire unpaid principal amount of the Interim and Final Promissory Note plus accrued interest and any fees thereon may be declared by the NMED to be immediately due and payable and the Borrower shall pay the amounts due under Note from the Pledged Revenues, either immediately or in the manner required by the NMED in its declaration, but only to the extent funds are available for payment of the Note. However, if insufficient funds are available for payment of the Note(s), the NMED may require the Borrower to adjust the rates charged by the System to ensure repayment of the Note.
- (B) If default by the Borrower is of covenants or conditions required under the federal grant, the Borrower may be required to refund the amount of the Loan and Loan Subsidy Grant disbursed to the Borrower from NMED.
- (C) The NMED shall have no further obligation to make payments to the Borrower under the Loan Agreement.
- Section 14. ENFORCEMENT; VENUE. The NMED retains the right to seek enforcement of the terms of the Loan Agreement. If the NMED and the Borrower cannot reach agreement regarding disputes as to the terms and conditions of this Loan Agreement, such disputes are to be resolved promptly and expeditiously in the district court of Santa Fe County. The Borrower agrees that the district court for Santa Fe County shall have exclusive jurisdiction over

the Borrower and the subject matter of this Loan Agreement and waives the right to challenge such jurisdiction.

Section 15. REMEDIES UPON DEFAULT. Upon the occurrence of any of the events of default as provided in the Loan Agreement or in this Ordinance, the NMED may proceed against the Borrower to protect and enforce its rights under the Ordinance by mandamus or other suit, action or special proceedings in equity or at law, in any court of competent jurisdiction, either for the appointment of a receiver or for the specific performance of any covenant or agreement contained in the Ordinance for the enforcement of any proper legal or equitable remedy as the NMED may deem most effective to protect and enforce the rights provided above, or to enjoin any act or thing which may be unlawful or in violation of any right of the NMED, or to require the Borrower to act as if it were the trustee of an express trust, or any combination of such remedies. Each right or privilege of the NMED is in addition and cumulative to any other right or privilege under the Ordinance or the Loan Agreement and Note and the exercise of any right or privilege by the NMED shall not be deemed a waiver of any other right or privilege.

Section 16. DUTIES UPON DEFAULT. Upon the occurrence of any of the events of default as provided in this Ordinance, the Borrower, in addition, will do and perform all proper acts on behalf of and for the NMED to protect and preserve the security created for the payment of the Note to ensure the payment on the Note promptly as the same become due. All proceeds derived from the System, so long as the Note is outstanding, shall be treated as revenues. If the Borrower fails or refuses to proceed as required by this Section, the NMED, after demand in writing, may proceed to protect and enforce the rights of the NMED as provided in the Ordinance and the Loan Agreement.

Section 17. TERMINATION. When all obligations under the Loan Agreement and Note have been paid, the Loan Agreement and Note shall terminate and the pledge, lien, and all other obligations of the Borrower under the Ordinance shall be discharged. The principal amount of the Note, or any part thereof, may be prepaid at any time without penalty at the discretion of the Borrower and the prepayments of principal shall be applied as set forth in the Loan Agreement.

Section 18. AMENDMENT OF ORDINANCE. This Ordinance may be amended with the prior written consent of the NMED.

Section 19. ORDINANCE IRREPEALABLE. After the Loan Agreement and Note have been executed and delivered, the Ordinance shall be and remain irrepealable until the Note has been fully paid, terminated and discharged, as provided in the Ordinance.

Section 20. SEVERABILITY CLAUSE. If any section, paragraph, clause or provision of the Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of the Ordinance.

Section 21. REPEALER CLAUSE. All bylaws, orders, Ordinances and Ordinances, or parts thereof, inconsistent herewith are hereby repealed to the extent only of such inconsistency. This repealer shall not be construed to revive any bylaw, order, Ordinance or Ordinance, or part thereof, heretofore repealed.

CITY OF TRUTH OR CONSEQUENCES

ORDINANCE No. 710

AN ORDINANCE AMENDING THE CITY OF TRUTH OR CONSEQUENCES MUNICIPAL CODE OF ORDINANCES, BY AMENDING SECTION 11-2-2 PERTAINING TO THE COMPOSITION OF THE PLANNING AND ZONING COMMISSION.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS, CITY COMMISSIONERS OF THE CITY OF TRUTH OR CONSEQUENCES:

Section one. That section 11-2-2 of the Planning and Zoning Code of the City of Truth or Consequences be amended so that such section shall read as follows:

SEC. 11-2-2 THE PLANNING AND ZONING COMMISSION.

- A. *Purpose*. A Municipal Planning and Zoning Commission is hereby established for the purpose of interpretation of this Code, approving certain actions, receiving requests for modifications to this Code and re-zoning, and making recommendations to the City Commission concerning matters pertaining to zoning within the City.
- B. Administrative review and interpretations.
 - 1. The Planning and Zoning Commission shall review an administrative action of the designated Zoning Administrator when it is alleged that there is an error in the order, requirement, determination, or refusal made by the designated Zoning Administrator and reverse, affirm, or modify the administrative action.
 - 2. The Commission shall interpret this Code when the designated Zoning Administrator is in doubt as to the exact meaning of the text.
 - 3. The Commission shall interpret the Official Planning and Zoning District Map in accordance with the standards set forth in the Comprehensive Planning and Zoning Code when the designated Zoning Administrator is uncertain as to the exact boundary of a District shown on the Official Planning and Zoning District Map.

C. Powers and duties.

- 1. Recommend to the City Commission either approval, denial or modification of a request for annexation, special use permit, variance, subdivision, zoning, amendment of this Code, or any other land use consideration within the planning and zoning jurisdiction of the City.
- 2. Grant final approval or denial of a home occupation or conditional use permit after public meeting, provided there is not an appeal to the City Commission within fifteen (15) days in accordance with Article 7 of this Code.
- D. Composition of the Planning and Zoning Commission. The Planning and Zoning Commission shall consist of five (5) three (3) members each to be appointed by a simple majority of the City Commission. Eligibility requirements for membership shall be

established by the City Commission. Members shall serve staggered terms of two (2) years each. A recording secretary shall be provided to assist the Planning and Zoning Commission by the City. The recording secretary shall not be a member of the Planning and Zoning Commission and shall be only responsible for those duties requested by the Planning and Zoning Commission and approved by the City Manager.

- E. Organization of the Planning and Zoning Commission. The Planning and Zoning Commission shall elect a chairman, vice-chairman, and second vice-chairman in July of each year, or as required due to unforeseen vacancies. They shall serve for one (1) calendar year following their elections.
- F. Voting. A simple majority vote of a quorum of the Planning and Zoning Commission is required for approval of all Planning and Zoning Commission actions. A quorum requires at least three members of the Commission present.

In order for a vote to be valid on a particular issue, a quorum must actually vote regarding the measure. A member who abstains from voting on an issue is deemed to have not voted on the issue.

- G. Findings of facts for recommendations and decisions. In considering all requests, the Planning and Zoning Commission shall review applicable plans and determine whether the request will:
 - 1. Impair an adequate supply of light and air to adjacent property;
 - 2. Unreasonably increase the traffic in public streets;
 - 3. Increase the danger of fire or endanger the public safety;
 - 4. Deter the orderly and phased growth and development of the community;
 - 5. Unreasonably impair established property values within the surrounding area;
 - 6. In any other respect impair the public health, safety and general welfare of the City; or
 - 7. Constitute a spot zone and therefore adversely affect adjacent property values.

All actions or recommendations by the Planning and Zoning Commission shall be based on Findings of Facts as to the impacts of the proposal, using the criteria listed in numbers 1 through 7, above. The Planning and Zoning Commission shall review each of the above listed factors and accord each factor the necessary weight on a case-by-case basis in making its determination.

H. Report to the City Commission. The Planning and Zoning Commission shall provide written minutes, with recommendations as necessary, to the City Commission on all matters that are brought before the Commission. Such minutes shall include a statement of the findings of facts that were the basis of any decision or recommendation made by the Planning and Zoning Commission.

Section two . All other provisions of the aforementioned codes not specifically amended by this ordinance, shall remain unchanged and in full force and effect as written.
Section three . Effective date. The provisions of this Ordinance shall become effective five (5) days upon the publishing of its adoption.

WHEREAS, the Association intends to obtain assistance from the United States Department of Agriculture. (herein called the Government) acting under the provisions of the Consolidated Farm and Rural Development Act (7 U.S.C. 1921 et seq.) in the planning. financing, and supervision of such undertaking and the purchasing of bonds lawfully issued, in the event that no other acceptable purchaser for such bonds is found by the Association:

NOW THEREFORE, in consideration of the premises the Association hereby resolves:

- To have prepared on its behalf and to adopt an ordinance or resolution for the issuance of its bonds containing such items and in such forms as are required by State statutes and as are agreeable and acceptable to the Government.
- To refinance the unpaid balance, in whole or in part, of its bonds upon the request of the Government if at any time it shall appear to the Government that the Association is able to refinance its bonds by obtaining a loan for such purposes from responsible cooperative or private sources at reasonable rates and terms for loans for similar purposes and periods of time as required by section 333(c) of said Consolidated Farm and Rural Development Act (7 U.S.C. 1983(c)).
- To provide for, execute, and comply with Form RD 400-4, "Assurance Agreement," and Form RD 400-1, "Equal Opportunity Agreement," including an "Equal Opportunity Clause," which clause is to be incorporated in, or attached as a rider to, each construction contract and subcontract involving in excess of \$10,000.
- To indemnify the Government for any payments made or losses suffered by the Government on behalf of the Association. Such indemnification shall be payable from the same source of funds pledged to pay the bonds or any other legal ly permissible source.
- That upon default in the payments of any principal and accrued interest on the bonds or in the performance of any covenant or agreement contained herein or in the instruments incident to making or insuring the loan, the Government at its option may (a) declare the entire principal amount then outstanding and accrued interest immediately due and pavable, (b) for the account of the Association (payable from the source of funds pledged to pay the bonds or any other legally permissible source), incur and pay reasonable expenses for repair, maintenance, and operation of the facility and such other reasonable expenses as may be necessary to cure the cause of default, and/or (c) take possession of the facility, repair, maintain, and operate or rent it. Default under the provisions of this resolution or any instrument incident to the making or insuring of the loan may be construed by the Government to constitute default under any other instrument held by the Government and executed or assumed by the Association, and default under any such instrument may be construed by the Government to constitute default hereunder.
- Not to sell, transfer, lease, or otherwise encumber the facility or any portion thereof, or interest therein, or permit others to do so, without the prior written consent of the Government.
- Not to defease the bonds, or to borrow money, enter into any contractor agreement, or otherwise incur any liabilities for any purpose in connection with the facility (exclusive of normal maintenance) without the prior written consent of the Government if such undertaking would involve the source of funds pledged to pay the bonds.
- To place the proceeds of the bonds on deposit in an account and in a manner approved by the Government. Funds may be deposited in institutions insured by the State or Federal Government or invested in readily marketable securities backed by the full faith and credit of the United States. Any income from these accounts will be considered as revenues of the system.
- To comply with all applicable State and Federal laws and regulations and to continually operate and maintain the facility in good condition.
- 10. To provide for the receipt of adequate revenues to meet the requirements of debt service, operation and maintenance, and the establishment of adequate reserves. Revenue accumulated over and above that needed to pay operating and maintenance, debt service and reserves may only be retained or used to make prepayments on the loan. 1. Project Description – Funds will be used to for the Downtown Distribution Waterline Replacement/rehabilitation, Replace the existing gas chlorination system at the Cook Street Facility, install variable frequency drives on existing booster pumps at the Cook Street Facility, install a new flow meter and new chlorine injection point at the Cook Street Facility, install a new backup generator at the Cook Street Facility, upgrade drinking water SCADA/HMI system which is located at the wastewater treatment plant, and remote terminal units at the following sites: Cook Street Facility (Well #1, Tanks and Booster Station), Well #2, Well #4, Well #6, Well #7, Well #8, Morgan Tank & Booster Station, Pershing Booster Station, Cemetery Road Tanks, and Dispatch Center. Replace approximately 32,800 linear feet of 6-inch, 8-inch and 12-inch old and leaking lines on Broadway, Main Street, Pershing, Foch, Daniels, McAdoo, N. Broadway, and Austin within the Main Street District to reduce water losses and increase overall system efficiency

Facilities will be designed and constructed in accordance with sound engineering practices and must meet the requirements of Federal, State, and local agencies. The proposed facility design must be based on the Preliminary Engineering Report (PER) as concurred with by the Agency.

2. <u>Project Funding</u> – Project funding is planned from the following sources:

This funding is offered based on the amounts stated above. Any increase in non-Agency funding will be applied first as a reduction to Agency grant funds, up to the total amount of the grant, and then as a reduction to Agency loan funds.

Any changes in funding sources following obligation of Agency funds must be reported to the processing official. Project feasibility and funding will be reassessed if there is a significant change in project costs after bids are received. If actual project costs exceed the project cost estimates, an additional contribution by the Owner may be necessary. Agency funds will not be used to pre-finance funds committed to the project from other sources.

Project feasibility and funding will be reassessed if there is a significant change in project costs after bids are received. Obligated loan or grant funds not needed to complete the proposed project will be deobligated prior to start of construction. Any reduction will be applied to grant funds first.

SECTION II – LOAN AND GRANT TERMS

4. Repayment – The interest rate will be the lower of the rate in effect at the time of loan approval or the time of loan closing. Should the interest rate be reduced, the payment will be recalculated to the lower amount

Your loan will be scheduled for repayment over a period of 40 years. Payments will be equal monthly amortized installments, beginning one month after closing. For planning purposes, use a 2.125% interest rate and an amortization factor of 3.10 which provides for a monthly payment of \$17,010. The precise payment amount will be based on the interest rate at which the loan is closed and may be different than the one above.

The payment due date will be established as the day that the loan closes. Due dates falling on the 29th, 30th and 31st day of the month will be avoided.

5. <u>Security</u> – The loan will be secured by a Revenue bond with parity lien position. The bond will be fully registered as to both principal and interest in the name of the "United States of America Acting through the United States Department of Agriculture." Bond Counsel will be utilized in preparation of these documents.

The bond and any ordinance relating thereto must not contain any provision in conflict with the Agency Loan Resolution, applicable regulations, or its authorizing law. In particular, there must be no defeasance or refinancing clause in conflict with the graduation requirements of 7 U.S.C. 1983. A draft of the bond, bond ordinance and closing documents must be reviewed and concurred in by the Agency prior to advertising for bids

Additional security requirements are contained in RUS Bulletin 1780-27, "Loan Resolution (Public Bodies) and RUS Bulletin 1780-12, "Water and Waste System Grant Agreement.". The Loan Resolution must be duly adopted and executed prior to loan closing or start of construction, whichever occurs first.

A Parity Agreement will be required between the Agency and the Parity Lender. The bond must specify that, in the event of default each lender will be affected on a proportionate basis.

- 6. <u>Electronic Payments</u> Payments will be made on the day your payment is due through an electronic preauthorized debit system. You will be required to complete Form RD 3550-28, "Authorization Agreement for Preauthorized Payments," for all new and existing indebtedness to the Agency prior to loan closing.
- 7. <u>Disbursement of Agency Funds</u> Any applicant contribution and connection/tap fees will be the first funds expended, followed by other funding sources. Interim financing or Agency loan funds will be expended after all other funding sources unless a written agreement is reached with all other funding sources on how funds are to be disbursed. Agency grant funds will be expended last. Interim financing funds or Agency loan funds must be used prior to the use of Agency grant funds.
- 8. Reserves Reserves must be properly budgeted to maintain the financial viability and sustainability of any operation. Reserves are important to fund unanticipated emergency maintenance and repairs, and assist with debt service should the need arise. The following reserves are required to be established as a condition of this loan:
 - a) Debt Service Reserve As a part of this Agency loan proposal, you must establish a debt service reserve fund equal to at least one annual loan installment that accumulates at the rate of 10% of one annual payment per year for ten years or until the balance is equal to one annual loan payment. Ten percent of the proposed loan installment would equal \$20,361.90 per month; this amount should be deposited monthly until a total of \$203,619 has accumulated. Prior written concurrence from the Agency must be obtained before funds may be withdrawn from this account during the life of the loan. When funds are withdrawn during the life of the loan, deposits will continue as designated above until the fully-funded amount is reached.
 - b) Short-Lived Asset Reserve In addition to the debt service reserve fund, you must establish a short-lived asset reserve fund. Based on the preliminary engineering report, you must deposit at least \$170,861 into the short-lived asset reserve fund annually for the life of the loan to pay for repairs and/or replacement of major system assets. It is your responsibility to assess your facility's short-lived asset needs on a regular basis and adjust the amount deposited to meet those needs.
- 9. <u>Environmental Requirements</u> At the conclusion of the proposal's environmental review process, specific actions were determined necessary to avoid or minimize adverse environmental impacts. As outlined in the Environmental Report dated August 7, 2019, the following actions are required for successful completion of the project and must be adhered to during project design and construction:

1. Historic Preservation

Mitigation Measure: Proposed waterlines will be designed to avoid excessive ground disturbance and above-grade alterations that could impact contributing properties within the Hot Springs Bathhouse, Commercial and Main Street Historic District where feasible. Construction activities, equipment, and work areas will avoid encroaching upon and directly altering all contributing historic properties within the Hot Springs Bathhouse, Commercial and Main Street Historic District by establishing a buffer zone, wherever feasible, between all proposed activities and all contributing historic properties. If the recommended buffer zone cannot be established due to physical conditions or other restrictions at the work site, the proponent will consult with NM SHPO to establish an acceptable alternative avoidance strategy or mitigation plan. Disturbed ground will be restored to the condition it was in prior to construction per standard NEPA guidelines and construction best management practices. In the unlikely event that historical/prehistoric resources are uncovered during the construction activity, construction should cease and the New Mexico State Historic Preservation Office should be immediately contacted.

2. Environmental Risk Management

Mitigation Measure: The potential exists that the presence of contaminated soils, groundwater, and/or a vapor encroachment condition may impact the waterline construction from the above listed facilities. Contamination from any of these sites may impact worker safety (contaminated soils, groundwater, and/or potential volatile organic compound [VOC] vapor release from excavation). If, during the course of construction or excavation activities, a petroleum hydrocarbon odor or any suspicious odor or appearance of contaminated soil is detected, then all work within the immediate area of the discovered hazardous material will stop until the New Mexico Department of Transportation (NMDOT) Project Manager is notified and a plan to dispose of the hazardous material has been developed. Subsequently, NMED will be contacted for consultation and appropriate actions taken.

The above mitigation requirements must be incorporated into the contract documents and enforced during and after construction. In addition, these mitigation requirements will be added as an addendum will be added to RUS Bulletin 1780-28, "Loan Resolution Security Agreement," or 1780-27, "Loan Resolution (Public Bodies)."

The project as proposed has been evaluated to be consistent with the National Environmental Policy Act. Other Federal, State, tribal and local laws, regulations and/or permits may apply or be required. If the project or any project element deviates from or is modified from the originally approved project, additional environmental review may be required.

- 10. <u>Certifications</u> As a condition of the proposed funding, you executed as part of RD Apply and must comply with the following forms and certifications, as applicable:
 - a) RD 400-1 "Equal Opportunity Agreement"
 - b) RD 400-4 "Assurance Agreement"
 - c) AD 1047 "Certification Regarding Debarment Transactions"
 - d) AD 1049 "Certification Regarding Drug-Free Workplace"

- e) RD 1910-11 "Applicant Certification Federal Collection Policies Consumer/Commercial Debts"
- f) 1940-Q.Ex A-1 "Certification for Contracts, Grants and Loans"

SECTION III – REQUIREMENTS PRIOR TO ADVERTISING FOR BIDS

- 11. <u>Legal Services</u> You are required to execute a legal services agreement with your attorney and bond counsel for any legal work needed in connection with this project. The agreement should stipulate an hourly rate for the work, with a "not to exceed" amount for the services, including reimbursable expenses. RUS Bulletin 1780-7, "Legal Services Agreement," or similar format may be used. If costs for the services are expected to exceed \$25,000, Form AD 1048, "Certification Regarding Debarment Lower Tier Transactions" must be executed by the attorney and bond counsel. The legal services agreements must be submitted to the Agency for concurrence prior to advertising for bids. Any changes to the fees or services spelled out in the original agreement must be reflected in an amendment to the agreement and have prior Agency concurrence.
- 12. <u>Legal Authority</u> You must have or will obtain the legal authority necessary for owning, constructing, operating, and maintaining the proposed facility, and for obtaining, giving security for, and repaying the proposed loan. Your organizational document and your attorney's opinion on your legal authority will be reviewed by the Agency's Regional Attorney for adequacy. You agree to make any changes necessary and/or submit additional documentation to satisfy to this requirement.
- 13. Property Rights You and your legal counsel must furnish satisfactory evidence that you have or can obtain adequate continuous and valid control over the lands, and rights-of-way, and water rights needed for the project. Form RD 442-20, "Right-of-Way Easement" may be used to obtain any necessary easements for the proposed project. Acquisitions of necessary land and rights must be accomplished in accordance with the Uniform Relocation Assistance and Real Property Acquisition Policies Act. Such control over the lands and rights will be evidenced by the following:
 - a) Right-of-Way Map Your engineer will provide a color-coded map clearly showing the location of all lands and rights-of-way needed for the project. The map must designate public and private lands and rights and the appropriate legal ownership thereof.
 - b) Form RD 442-21, "Right-of-Way Certificate" You will provide a certification on this form that all right-of-way requirements have been obtained for the proposed project.
 - c) Form RD 442-22, "Opinion of Counsel Relative to Rights-of-Way" Your attorney will provide a certification and legal opinion on this form addressing rights-of-way, easements, and title.
 - d) Water Rights You must submit evidence of title to water rights sufficient to properly operate the facility. Such evidence will include a certificate from the New Mexico State Engineer and an opinion from your attorney regarding the nature of the water rights owned. If water rights are to be acquired as part of this project, you must submit the purchase contract for our review. Final evidence of water rights must be submitted prior to loan closing or start of construction, whichever comes first.

The above rights-of-way forms may contain a few exceptions, such as properties that must be condemned or acquired as part of the project. However, new forms with no exceptions must be provided prior to the issuance of the notice to proceed.

You are responsible for the acquisition of all property rights necessary for the project and for determining that prices paid are reasonable and fair. The Agency may require an appraisal by an independent appraiser or Agency employee in order to validate the price to be paid.

- 14. System Policies & Procedures The facility must be operated on a sound business plan. You must adopt policies, procedures, and/or ordinances outlining the conditions of service and use of the proposed system. Mandatory connection policies should be used where enforceable. The policies, procedures, and/or ordinances must contain an effective collection policy for accounts not paid in full within a specified number of days after the date of billing. They should include appropriate late fees, specified timeframes for disconnection of service, and reconnection fees. A draft of these policies, procedures, and/or ordinances must be submitted for Agency review and concurrence before closing instructions may be issued.
- 15. <u>Contracts & Agreements</u> If the proposed system requires any contracts, leases, and/or agreements for its operation, a draft of these documents must be submitted to the Agency for review and concurrence before closing instructions may be issued.
 - a) Contracts for Services/Lease Agreement Drafts of any contracts or other forms of agreements for other services, including management, operation, and maintenance, or lease agreements covering real property essential to the successful operation of the facility, must be submitted to the Agency for review and concurrence prior to advertising for bids.
 - b) **Parity Agreement** Projects with parity liens must have in place a written agreement between the parity lenders. The draft agreement must receive Agency concurrence prior to advertising for bids.
 - c) Other agreements with governments or other entities regarding joint operation of facilities, granting authority to Agency borrower for providing service within another entity's service area, etc. Existing Agreement between the City of Truth or Consequences and Village of Williamsburg for sale of water and treatment of wastewater The agreement must receive Agency concurrence prior to advertising for bids.
- 16. <u>Closing Instructions</u> The Agency will prepare closing instructions as soon as the requirements of paragraphs 12-15 are complete, and a draft of the security instruments described in paragraph 5, have been submitted. Closing instructions must be obtained prior to advertising for bids.
- 17. Engineering Services You are required to complete an Agreement for Engineering Services, which will consist of the Engineers Joint Contract Documents Committee (EJCDC) documents as indicated in RUS Bulletin 1780-26, "Guidance for the Use of EJCDC Documents on Water and Waste Projects with RUS Financial Assistance," and as modified by RUS Bulletins 1780-26 and 1780-35, and New Mexico Supplement to RUS Bulletin 1780-26. If costs for the services are expected to exceed \$25,000, Form AD 1048, "Certification Regarding Debarment Lower Tier Transactions" must be executed by the engineer. The agreement must be submitted

to the Agency for concurrence prior to advertising for bids. The Agency must approve any modifications to this agreement.

18. <u>Contract Documents, Final Plans and Specifications</u> – The contract documents must consist of the EJCDC construction contract documents as indicated in RUS Bulletin 1780-26 or other Agency approved forms of agreement.

The contract documents, final plans, and specifications must comply with RUS Instruction 1780, Subpart C – Planning, Designing, Bidding, Contracting, Constructing and Inspections, and must be submitted to the Agency for concurrence prior to advertising for bids along with an updated cost estimate. The Agency may require another updated cost estimate if a significant amount of time elapses between the original submission and advertising for bids.

The use of any procurement method other than competitive sealed bids must be requested in writing and approved by the Agency.

- 19. <u>American Iron and Steel Requirements</u> Section 746 of Title VII of the Consolidated Appropriations Act of 2017 (Division A Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations Act, 2017) applies an American Iron and Steel requirement. Specifically, it provides the following:
 - a) No Federal funds made available for this fiscal year for the rural water, waste water, waste disposal, and solid waste management programs authorized by the Consolidated Farm and Rural Development Act (7 U.S.C. 1926 et seq.) shall be used for a project for the construction, alteration, maintenance, or repair of a public water or wastewater system unless all of the iron and steel products used in the project are produced in the United States.
 - b) The term "iron and steel products" means the following products made primarily of iron or steel: lined or unlined pipes and fittings, manhole covers and other municipal castings, hydrants, tanks, flanges, pipe clamps and restraints, valves, structural steel, reinforced precast concrete, and construction materials.
 - c) The requirement shall not apply in any case or category of cases in which the Secretary of Agriculture (in this section referred to as the "Secretary") or the designee of the Secretary finds that applying the requirement would be inconsistent with the public interest; iron and steel products are not produced in the United States in sufficient and reasonably available quantities or of a satisfactory quality; or inclusion of iron and steel products produced in the United States will increase the cost of the overall project by more than 25 percent.

The American Iron and Steel requirements must be incorporated into the Agreement for Engineering Services, the Advertisement for Bids, and the Supplemental General Conditions. In addition, the engineer and contractor must comply with any reporting requirements. Additional guidance will be provided by the Agency.

20. <u>Interim Financing</u> – For all loans exceeding \$500,000, where loan funds can be borrowed at reasonable interest rates on an interim basis from commercial sources for the construction period, such interim financing will be used to preclude the necessity for multiple

advances of Agency loan funds. You must provide the Agency with a copy of the interim loan financing agreement for review prior to advertising for bids. The Agency approving official may make an exception when interim financing is cost prohibitive or unavailable. Grant funds from the Agency will be disbursed by multiple advances through electronic transfer of funds after interim financing or Agency loan funds are expended, in accordance with RUS Instruction 1780.45.

- 21. <u>Construction Account</u> You must establish a separate construction account with an acceptable financial institution or depository that meets the requirements of 31 CFR Part 202. All project funds will be deposited into this account and you must provide monthly bank statements to evidence payment of project expenses. Agency funds will be disbursed into the construction account through an electronic transfer system. Form SF-3881, "ACH Vendor/Miscellaneous Payment Enrollment Form" must be completed and submitted to the Agency prior to advertising for bids.
- 22. <u>System Users/Proposed Operating Budget</u> This letter of conditions is based upon your indication at application that there will be at least 2,703 residential users, 555 non-residential users on system when construction is completed. Based on the water usage information in the PER and comparing your system to similar systems, we have determined that your system should produce at least \$1,323,613 in revenues.
 - a) Before the Agency can agree to the project being advertised for construction bids, you must certify that the number of users indicated at application are currently using the system or signed up to use the system once it is operational. If the actual number of existing and/or proposed users that have signed up for service is less than the number indicated at the time of application, you must provide the Agency with a written plan on how you will obtain the necessary revenue to adequately cash flow the expected operation, maintenance, debt service, and reserve requirements of the proposed project (e.g. increase user rates, sign up an adequate number of other users, reduce in project scope, etc.). Similar action is required if there is cause to modify the anticipated flows or volumes presented following approval.
 - b) Prior to advertising for bids, you must submit a proposed annual operating budget to the Agency, as well as a proposed rate schedule, which demonstrates an ability to cash flow the project as determined by our underwriting. The operating budget should be based on a typical year cash flow after completion of the construction. It is expected that O&M will change over each successive year and user rates will need to be adjusted on a regular basis. Technical assistance is available at no cost to help you evaluate and complete a rate analysis on your system.
 - c) If you are relying on mandatory connection requirements, you must provide evidence of the authorizing ordinance or statute. If you are relying on voluntary connections, you must provide a positive program to encourage connection by all users as soon as service is available. The program will be reviewed by the Agency prior to advertising for bids. A guide for developing your positive program is available from the Agency.
- 23. Other Funding Prior to advertising for bids, you must provide evidence of applicant contributions and approval of other funding sources. This evidence should include a copy of the commitment letter from each source.

- 24. <u>Permits/Regulatory Approvals</u> The owner or responsible party will be required to obtain all applicable permits and regulatory approvals for the project. The consulting engineer must submit a written certification that all applicable permits and regulatory approvals required prior to construction have been obtained prior to advertising for bids.
- **Yulnerability Assessment/Emergency Response Plan (VA/ERP)** The Agency requires all financed water and wastewater systems to have a VA/ERP in place. Borrowers with existing systems must provide a certification that a VA/ERP has been completed prior to advertising for bids. Technical assistance at no cost is available in preparing these documents.
- **26.** <u>Bid Authorization</u> Once all the conditions outlined in Section III of this letter have been met, the Agency will authorize you to advertise the project for construction bids. Such advertisement must be in accordance with applicable State statutes.

SECTION IV - REQUIREMENTS PRIOR TO START OF CONSTRUCTION

- 27. <u>Bid Tabulation</u> Immediately after bid opening, you must provide the Agency with the bid tabulation and your engineer's evaluation of bids and recommendations for contract awards. You must also submit an opinion from your legal representative that the bidding procedures met applicable State law. If the Agency agrees that the construction bids received are acceptable, adequate funds are available to cover the total project costs, and all the requirements of Section III of this letter have been satisfied, the Agency will authorize you to issue the Notice of Award.
 - a) Cost Overruns. If bids are higher than expected, or if unexpected construction problems are encountered, you must utilize all options to reduce cost overruns. Negotiations, redesign, use of bidding alternatives, rebidding or other means will be considered prior to commitment of subsequent funding by the Agency. Any requests for subsequent funding to cover cost overruns will be contingent on the availability of funds.
 - b) Excess Funds. If bids are lower than anticipated at time of obligation, excess funds must be deobligated prior to start of construction with grant funds being deobligated first. Excess funds do not include contingency funds as described in this letter.
- **28.** Security Documents RUS Bulletin 1780-27, "Loan Resolution (Public Bodies) must be duly adopted and executed.
- 29. <u>Contract Review</u> Your attorney will review and certify that the executed contract documents, including performance and payment bonds are adequate and that the persons executing these documents have been properly authorized to do so in accordance with RUS Instruction 1780.61(b). Once your attorney has certified that they are acceptable, the contract documents will be submitted to the Agency for its concurrence. The Notice to Proceed cannot be issued until the Agency has concurred with the construction contracts.
- 30. Resident Inspector(s) We have considered your request for part-time inspection if appropriate and have determined full-time inspection for waterlines and part-time inspection for water tank is required for the proposed project. Inspection services are to be provided by the

consulting engineer unless other arrangements are requested in writing and concurred with by the Agency. A resume of qualifications of any resident inspector(s) will be submitted to the owner and Agency for review and concurrence prior to the pre-construction conference. The resident inspector(s) must attend the pre-construction conference.

- 31. <u>Preconstruction Conference</u> A preconstruction conference will be held prior to the issuance of the Notice to Proceed. The consulting engineer will review the planned development with the Agency, owner, resident inspector, attorney, contractor, other funders, and other interested parties, and will provide minutes of this meeting to the owner and Agency.
- 32. <u>Final Rights-of-Way</u> For projects involving the acquisition of land and/or water rights, you must provide evidence that you have clear title to the land and water rights prior to the issuance of the Notice to Proceed. Land rights will be evidenced by a Final Title Insurance Policy on all existing real property related to the facility, now owned and to be acquired for this project. Water rights will be evidenced by a certificate from the New Mexico State Engineer and an opinion from your attorney regarding the nature of the water rights owned.

If any of the rights-of-way forms listed previously in this letter contain exceptions that do not adversely affect the suitability, successful operation, security value, or transferability of the facility, the approving official must provide a written waiver prior to the issuance of the Notice to Proceed.

33. <u>Insurance and Bonding Requirements</u> – Prior to the start of construction or loan closing, whichever occurs first, you must acquire and submit to the Agency proof of the types of insurance and bond coverage for the borrower shown below. The use of deductibles may be allowed, providing you have the financial resources to cover potential claims requiring payment of the deductible.

The Agency strongly recommends that you have your engineer, attorney, and insurance provider(s) review proposed types and amounts of coverage, including any exclusions and deductible provisions. It is your responsibility and not that of the Agency to assure that adequate insurance and fidelity or employee dishonesty bond coverage is maintained.

- a) General Liability Insurance Include vehicular coverage.
- b) Workers' Compensation In accordance with appropriate State laws.
- c) Fidelity or Employee Dishonesty Bonds Include coverage for all persons who have access to funds, including persons working under a contract or management agreement. Coverage may be provided either for all individual positions or persons, or through blanket coverage providing protection for all appropriate workers. At a minimum, the amount of coverage must be for at least the total annual debt service of all outstanding Agency loans; however, it is recommended coverage be in an amount equal to the maximum amount of funds under the control of that position at any one time. The Agency must be listed as loss payee.
- d) National Flood Insurance If the project involves acquisition or construction in designated special flood or mudslide prone areas, you must purchase a flood insurance policy at the time of loan closing.

e) Real Property Insurance – Fire and extended coverage will normally be maintained on all structures except reservoirs, pipelines and other structures if such structures are not normally insured, and subsurface lift stations except for the value of electrical and pumping equipment. The Agency must be listed as mortgagee on the policy when the Agency has a lien on the property.

Insurance types described above are required to be continued throughout the life of the loan. See Section VII.

- 34. <u>Initial Compliance Review</u> The Agency will conduct an initial compliance review of the borrower prior to loan closing or start of construction, whichever occurs first, in accordance with 7 CFR 1901, Subpart E.
- 35. <u>Loan Closing</u> If multiple advances of Agency funds will be used, the requirements of Section V must be met prior to the start of construction.

SECTION V - REQUIREMENTS PRIOR TO LOAN CLOSING

- 36. <u>Documents from Section II and III</u> The security documents described in paragraph 5 must be fully executed and adopted. Form RD 3550-28, "Authorization Agreement for Preauthorized Payments," described in paragraph 6 must be submitted. The policies, procedures, contracts and agreements described in paragraphs 13 -15 must be fully executed and adopted.
- 37. Other Requirements All requirements contained in the Agency's closing instructions, as well as any requirements of your bond counsel and/or attorney, must be met prior to loan closing.
 - a) System for Award Management. You are required to maintain a Dun and Bradstreet Data Universal Numbering System (DUNS) number and maintain an active registration in the System for Award Management (SAM) database. Renewal can be done on-line at: http://sam.gov. This registration must be renewed and revalidated every twelve (12) months for as long as there are Agency funds to be expended. To ensure the information is current, accurate and complete, and to prevent the SAM account expiration, the review and updates must be performed within 365 days of the activation date, commonly referred to as the expiration date. The registration process may take up to 10 business days. (See 2 CFR Part 25 and the "Help" section at http://sam.gov).
 - b) Litigation. You are required to notify the Agency within 30 days of receiving notification of being involved in any type of litigation prior to loan closing or start of construction, whichever occurs first. Additional documentation regarding the situation and litigation may be requested by the Agency.
 - c) Certified Operator. Evidence must be provided that your system has or will have, as defined by applicable State or Federal requirements, a certified operator available prior to the system becoming operational, or that a suitable supervisory agreement with a certified operator is in effect.

- 38. <u>Use of Remaining Funds</u> Applicant contribution and connection or tap fees will be the first funds expended in the project, followed by non-Agency sources of funds. Any remaining funds will be handled as followed:
 - a) Remaining funds may be used for eligible loan and grant purposes, provided the use will not result in major changes to the <u>original</u> scope of work and the purpose of the loan and grant remains the same.
 - b) Loan funds not needed will be applied as an extra payment on the Agency indebtedness unless other disposition is required by the bond ordinance, resolution, or State statute.
 - c) Grant funds not expended for authorized purposes will be canceled (de-obligated) within 45 days of final completion of project. Prior to actual cancellation, you will be notified of the Agency's intent to cancel the remaining funds and given appropriate appeal rights.

SECTION VI – REQUIREMENTS DURING CONSTRUCTION

- 39. <u>Inspections</u> The Agency requires periodic inspections during construction, as well as a pre-final and final inspection. You, your engineer, and the contractor are required to attend these inspections. In addition, you are required to submit monthly construction monitoring reports, which may be prepared in conjunction with your consulting engineer.
- 40. Change Orders Prior Agency concurrence is required for all Change Orders.
- 41. Payments Prior Agency concurrence is required for <u>all</u> invoices and partial payment requests related to the project, regardless of funding source. All invoices and partial payment requests will be submitted to the Agency, along with Form RD 440-11, "Estimate of Funds Needed," listing amounts by budget category as described above in paragraph 3.

SECTION VII - SERVICING REQUIREMENTS DURING THE TERM OF THE LOAN

- 42. <u>Warranty/Security Inspections</u> Your engineer will schedule a warranty inspection with the contractor and Agency before the end of the one-year warranty period to address and/or resolve any warranty issues. The Agency will conduct an inspection of your records management system at the same time, and will continue to inspect the facility and records systems every three years for the life of the loan. You must participate in these inspections and provide the required information.
- 43. Annual Financial Reporting/Audit Requirements You are required to submit an annual financial report at the end of each fiscal year. Financial statements must be prepared on the accrual basis of accounting in accordance with generally accepted accounting principles (GAAP), and must include at a minimum a balance sheet and revenue and expense statement. The annual report will include separate reporting for each water and waste disposal facility, and itemize cash accounts by type (debt service, short-lived assets, etc.) under each facility. All records, books and supporting material are to be retained for three years after the issuance of the annual report. Technical assistance is available at no cost with preparing financial reports.

The type of financial information that must be submitted is specified below:

- a) Audits. An annual audit under the Single Audit Act is required if you expend \$750,000 or more in Federal financial assistance per fiscal year. The total Federal funds expended from all sources shall be used to determine Federal financial assistance expended. Expenditures of interim financing are considered Federal expenditures.
 - i. All audits are to be performed in accordance with 2 CFR Part 200, as adopted by USDA through 2 CFR Part 400. It is not intended that audits required by this part be separate and apart from audits performed in accordance with State and local laws. To the extent feasible, the audit work should be done in conjunction with those audits. The audit must be prepared by an independent licensed Certified Public Accountant, or a State or Federal auditor if allowed by State law, and must be submitted within 9 months of your fiscal year end.
 - ii. If an audit is required, you must enter into a written agreement with the auditor and submit a copy to the Agency. The audit agreement may include terms and conditions that the borrower and auditor deem appropriate; however, the agreement should include the type of audit or financial statements to be completed, the time frame in which the audit or financial statements will be completed, what type of reports will be generated from the services provided, and how irregularities will be reported.
- b) Financial Statements. If you expend less than \$750,000 in Federal financial assistance per fiscal year, you may submit financial statements in lieu of an audit which include at a minimum a balance sheet and an income and expense statement. The financial statements must be accompanied by supplemental information as required by the Agency, and be submitted within 60 days of your fiscal year end.
- c) Quarterly Reports Quarterly Income and Expense Statements will be required until the processing office waives this requirement. The quarterly report must be submitted within 30 days of each quarter's end. The Agency will notify you in writing when the quarterly reports are no longer required.
- 44. Proposed Budget and Projected Cash Flow Thirty days prior to the beginning of each fiscal year, you will be required to submit a proposed budget and projected cash flow to the Agency. Technical assistance is available at no cost to help you evaluate and complete a rate analysis on your system, as well as completing the proposed budget.
- 45. <u>Vulnerability Assessment/Emergency Response Plan (VA/ERP)</u> You are required to submit a certification to the servicing office every three years that the VA/ERP is current and covers all sites related to the facility. The documents themselves are not submitted to the Agency.
- **46.** <u>Insurance</u> You are required to maintain insurance on the facility and employees as previously described in this letter for the life of the loan.
- 47. <u>Graduation</u> By accepting this loan, you are also agreeing to refinance (graduate) the unpaid loan balance in whole, or in part, upon request of the Government. If at any time the Agency determines you are able to obtain a loan for such purposes from responsible cooperative or private sources at reasonable rates and terms, you will be requested to refinance. Your ability to refinance will be assessed every other year for those loans that are five years old or older.

- **48.** <u>Statutory and National Policy Requirements</u> You are required to comply with U.S. statutory and public policy requirements, including but not limited to the following:
 - a) Section 504 of the Rehabilitation Act of 1973 Under Section 504 of the Rehabilitation Act of 1973, as amended (29 U.S.C. 794), no handicapped individual in the United States shall, solely by reason of their handicap, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Agency financial assistance.
 - b) Civil Rights Act of 1964 All borrowers are subject to, and facilities must be operated in accordance with, Title VI of the Civil Rights Act of 1964 (42 U.S.C. 2000d et seq.) and 7 CFR 1901, Subpart E, particularly as it relates to conducting and reporting of compliance reviews. Instruments of conveyance for loans and/or grants subject to the Act must contain the covenant required by Paragraph 1901.202(e) of this Title.
 - c) The Americans with Disabilities Act (ADA) of 1990 This Act (42 U.S.C. 12101 et seq.) prohibits discrimination on the basis of disability in employment, State and local government services, public transportation, public accommodations, facilities, and telecommunications.
 - d) Age Discrimination Act of 1975 This Act (42 U.S.C. 6101 et seq.) provides that no person in the United States shall on the basis of age, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance.
 - e) Limited English Proficiency (LEP) under Executive Order 13166 LEP statutes and authorities prohibit exclusion from participation in, denial of benefits of, and discrimination under Federally-assisted and/or conducted programs on the ground of race, color, or national origin. Title VI of the Civil Rights Act of 1964 covers program access for LEP persons. LEP persons are individuals who do not speak English as their primary language and who have a limited ability to read, speak, write, or understand English. These individuals may be entitled to language assistance, free of charge. You must take reasonable steps to ensure that LEP persons receive the language assistance necessary to have meaningful access to USDA programs, services, and information your organization provides. These protections are pursuant to Executive Order 13166, titled, "Improving Access to Services by Persons with Limited English Proficiency," and further affirmed in the USDA Departmental Regulation 4330-005, "Prohibition Against National Origin Discrimination Affecting Persons with Limited English Proficiency in Programs and Activities Conducted by USDA."

Agency financial programs must be extended without regard to race, color, religion, sex, national origin, marital status, age, or physical or mental handicap. You must display posters (provided by the Agency) informing users of these requirements, as well as post and include a Non-Discrimination Statement (provided by the Agency) on all materials produced for public information, education and distribution. The Agency will monitor your compliance with these requirements during regular compliance reviews.

49. <u>Compliance Reviews and Data Collection</u> – The Agency will conduct regular compliance reviews of the borrower and its operation in accordance with 7 CFR Part 1901, Subpart E, and 36 CFR 1191, Americans with Disabilities Act (ADA) Accessibility Guidelines for Buildings and Facilities; Architectural Barriers Act (ABA) Accessibility Guidelines.

Compliance reviews will typically be conducted in conjunction with the security inspections described in this letter. If beneficiaries (users) are required to complete an application or screening for the use of the facility or service you provide, you must request and collect data by race (American Indian or Alaska Native, Asian, Black or African American, White); ethnicity (Hispanic or Latino, Not Hispanic or Latino); and by sex. A sample collection form is enclosed. The Agency will utilize this data as part of the required compliance review.

SECTION VIII – REMEDIES FOR NON-COMPLIANCE

Non-compliance with the conditions in this letter or requirements of your security documents will be addressed under the provisions of 7 CFR 1782 and other applicable regulations, statutes, and policies.

30. PROPOSED PROJECT (RECOMMENDED ALTERNATIVE)

30.1 Preliminary Project Design

Based on the examination of the previously presented LCC Analyses and the associated non-monetary factors, T or C would benefit most from constructing the items listed below.

- Improvements to the distribution system waterline components of the Main Street District of Downtown T or C
- 2. Alternative 1- Install an additional 0.300 MG welded steel storage/transfer tank at the Cook St. Treatment Facility.
- 3. Replace the existing gas chlorination system at the Cook Street Facility.
- 4. Install VFDs controller on existing Booster Pumps at the Cook Street Facility.
- 5. Install Cla-Val's at the Cook Street Facility
- 6. Install Micro-Switches at the Cook Street Facility
- 7. Install Surge anticipator valves and DIP fittings and appurtenances as needed
- 8. Install new flow meter and new chlorine injection point at the Cook Street Facility.
- 9. Install new backup generator at the Cook Street Facility.
- 10. Upgrade drinking water SCADA/HMI system which is located at the WWTP
- 11. RTUs at the following sites
 - xi. Cook Street Facility (Well #1, Tanks and Booster Station)
 - xii. Well #2
 - xiii. Well #4
 - xiv. Well #6
 - xv. Well #7
 - xvi. Well #8
 - xvii. Morgan Tank & Booster Station
 - xviii. Pershing Booster Station
 - xix. Cemetery Road Tanks
 - xx. Dispatch Center

No new land or right of way will be required.

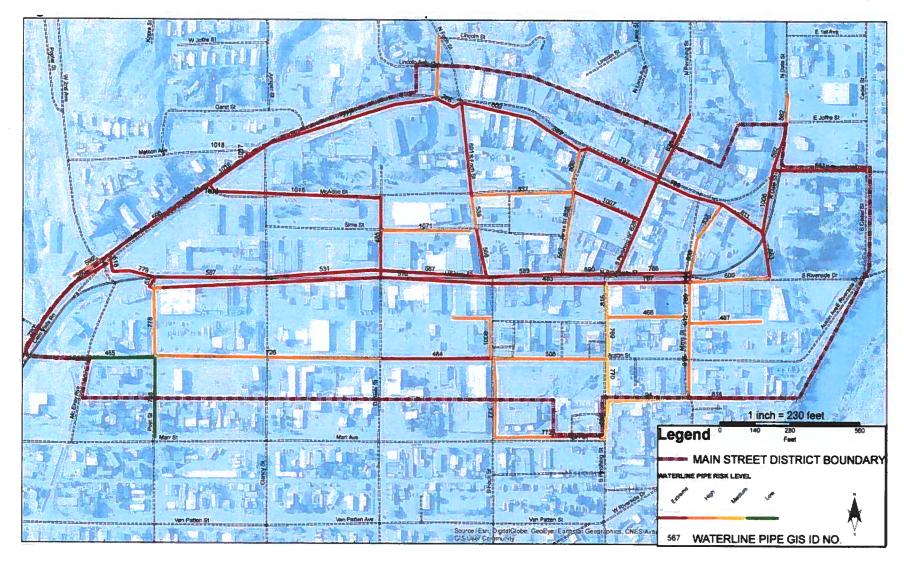


Figure 3: Main Street District Waterlines in Need of Replacement

The waterline distribution system components recommended for replacement in the Main Street District are identified in Figure 3 the basis for replacing the waterline assets in the Main Street District is discussed in section 24.2 of this report. The waterline assets (components)



have been inventoried in the GIS Model, developed as part of the Water System AMP Report, and can be tracked by the GIS Model number.

As part of the waterline replacement, pipes are planned to be upsized for increased capacity and to provide sufficient fire protection. As previously mentioned all 4" and 6" waterline pipes have been preliminarily designed as being upsized to 8" pipes to ensure capacity to provide adequate water for commercial services in the Main Street District as part of redeveloping the area. In addition, the 6" and 8" waterlines in Main St. and the north side of Broadway St. See Figure 3 have been preliminarily designed as being upsized to 12" waterlines and connected to form a loop line which will provide greater pressure and flow for fire protection and better general service to the Downtown area. It is important to note that the preliminary upsizing of the waterlines, in particular the new 12" loop line, will need to be verified and modified as necessary by performing computer modeling the Water System during project design phase.

30.2 Project Schedule

The improvements to the Water System of the Proposed Project are intended to be implemented as one complete project and the waterline improvements in the Main Street District should be scheduled to correspond with the timeline of other planning documents for the area. Specifically, improvements to the waterlines in the Main Street District should be completed prior to improvements to the roads as discussed previously and Information regarding the project schedule will be provided to MRWM Architects to coordinate efforts in common areas of construction. The estimated project schedule is as follows: funding awarded by end of 2018/early 2019; engineering design work completed by mid-late 2019; construction completed by mid-2020.

30.3 Permit Requirements

The project will need to be reviewed by the NMED Drinking Water Bureau. An Application for Construction or Modification of Public Water Supply System will be required by NMED along with an Engineering Design Summary and a disinfection plan.

30.4 Sustainability Considerations

Improved sustainability was a primary goal for implementing the improvements to the water system recommended in the proposed project. Alternative 1 - Construct a new 300,000-gallon Steel Storage tank with improvements to the disinfection system, and existing pump system. This alternative will result in fewer start/stop cycles by providing a larger volume of supply water, and the ability to pace the flow with the VFD controllers.

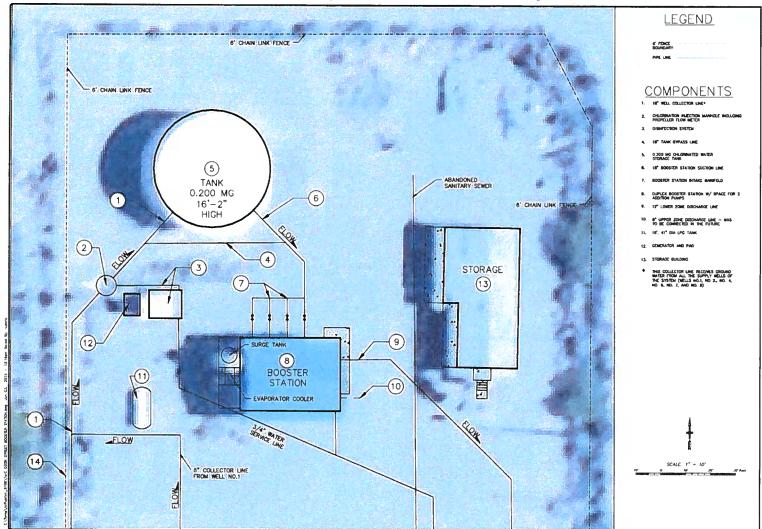


Figure 8: Existing Cook Street Treatment Facility

WHEREAS, the City Commission of the City of Truth or Consequences finds surplus property to be nonessential for public or government functions; and

Whereas, PURSUANT TO Section 3-54-2 of the New Mexico State Statues, 1978, Annotated, the City of Truth or Consequences serves notice that the City will use Willard Hall Auctions to live auction a portion of the property and will use either Public Surplus or Am-Tech for on-line sales of the remaining property belonging to the City as proposed.

NOW THEREFORE BE IT RESOLVED THAT:

- The City of Truth or Consequences may sell personal property having a value of more than two thousand five hundred (\$2,500.00) at public or private sale. If a private sale is held under this subsection, such sale shall be held only after notice is published at least twice, pursuant to the provisions of Subsection J or Section 3-1-2 NMSA 1978, not less than seven days apart, with the last publication not less than fourteen days prior to the sale.
- If a public sale is held, the bid of the highest responsible bidder shall be accepted unless the terms of the bid do not meet the published terms and conditions of the municipality, in which event the highest bid which does meet the published terms and conditions shall be accepted; provided, however, a municipality may reject all bids. Terms and conditions for a proposed sale of lease shall be published at least twice, not less than seven days apart, with the last publication no less than fourteen days prior to the bid opening, and shall be published according to the provisions of Subsection J of Section 3-1-2 NMSA 1978.
- The City of Truth or Consequences may sell, at a private or public sale, exchange or donate real or personal property to the state, to any of its political subdivisions or to the federal government is such sale, exchange or gift is in the best interests of the public and is approved by the local government division of the department of finance and administration. The provisions of Section 6-6-11 NMSA 1978 shall not apply to such sale, exchange or a donation.
