A. CALL TO ORDER

The meeting was called to order by Mayor Pro-Tem Whitehead at 9:00 a.m., who presided and Renee Cantin, City Clerk-Treasurer, acted as Secretary of the meeting.

B. INTRODUCTION

1. ROLL CALL

Upon calling the roll, the following Commissioners were reported present.

Mayor Pro-Tem Whitehead noted for the record Mayor Green is absent and is excused.

There being a quorum present, the Commission proceeded with the business at hand.

2. SILENT MEDITATION

Mayor Pro-Tem Whitehead called for fifteen seconds of Silent Meditation and asked us to keep in our thoughts and prayers all of the tragedy in the last few months with another shooting in California and one in Texas and a previous Mayor Milton Testin who passed away and his family.

3. PLEDGE OF ALLEGIANCE

Mayor Pro-Tem Whitehead led the Pledge of Allegiance.

4. APPROVAL OF AGENDA

Commissioner Clark moved to approve the agenda. Commissioner Frankel seconded the motion. Motion carried unanimously.

C. COMMENTS FROM THE PUBLIC (3 Minute Rule Applies)

Mayor Pro-Tem Whitehead called for Public Comment, noting those wishing to comment would get three minutes, may only approach the podium once, and any material for the Commission was to be left in the black box by the podium.

Ron Fenn, 316 N. Foch addressed the Commission related to:

1) Disheartened on last Wednesday's meeting when an item was moved for the transfer of funds from the streets department to the swimming pool. This was done without public comment and wasn't designated on the agenda for this meeting. Moving it made him think about why it can be moved. Most of the money is that budget is from the Local Road Fund money. That money is designated for road repair and not what anybody wants to use it for. We are talking about imposing a property tax for street repair, but take the money from the street department and put it into the swimming pool. There's nothing wrong with the pool, but it should've come from closing the Golf Course for six months. From the money we wouldn't have to allocate to them for a hand full of golfers to fix the pool. You've taken away from the citizens who are neither swimmers or golfers, and their recreation center for zero money. And now you have taken street funds which he believes will turn out to be a misuse of state funding. Standby.

D. RESPONSE TO PUBLIC COMMENTS

City Manager Fuentes wanted to respond to Mr. Fenn's inaccurate comments regarding the transfer. The transfer was funds from our General Fund budget, to the Street Department. So in essence, it's not State Road Fund dedicated money, it's not Local Government Road Fund money, it's general fund money. It was transferred for a specific project and will be diverted in the meantime for the pool project. He reiterated Mr. Fenn is incorrect calling it a Road Fund or State Funds. He just wanted to clarify that for the record.

Commissioner Hechler asked City Manager Fuentes where the money for the savings at the pool are going to. City Manager Fuentes responded those funds are staying within the same department and is going to be used to offset some of the additional costs.

E. PRESENTATIONS

1. Presentation of a Proclamation for Small Business Saturday on Saturday November 25, 2017. Steve Green, Mayor

Mayor Pro-Tem Whitehead presented the Small Business Saturday proclamation.

2. Presentation on Code Enforcement Progress. Lee Alirez, Police Chief and Ray Chavez, Code Enforcement

Police Chief Alirez made the presentation. He presented a new Vision, Mission, and Value statements for Code Enforcement. So far in 2017 1,012 Code Enforcement cases

have been opened. Many have been resolved very quickly. Usually on Monday morning he gets calls about a paper they received from Ray Chavez. They want to make sure they comply. You will notice when you drive around town, you can see the difference in cleaned up properties. One of the big problems was the Black Range and the owner came down three times to help take care of that. They are using all of their resources in contacting business owners. Now we are getting some nice phone calls thanking them for cleaning up neighbor's yard and they are noticing the difference. Police Chief Alirez publicly thanked Ray Chavez for doing an outstanding job and have exceeded his expectations for Code Enforcement since July.

Commissioner Clark thinks Mr. Chavez looks great in a uniform. She has notice what a difference it's made, she also thanked the Chief for taking on Code Enforcement to help get it done. Police Chief Alirez said finding that true key that motivates someone is the key. Staff enjoys his personality, he's cordial and professional, and looks great.

Ray Chavez wanted to say Robbie had a big hand in this, he can't do anything without seeing him at least twice a day. Police Chief Alirez said it's truly been a teamwork venture and his working closely with them.

Mayor Pro-Tem Whitehead said a couple of weeks ago, she talked about the Cottonwood Trailer Park because of the fire. She would like an update on that because she hasn't seen anything new happening there. Mr. Chavez said he has a court date on December 3rd for that. Police Chief Alirez added they have been aggressively pursuing that.

Police Chief Alirez introduced some of the Officer's in attendance Joffre Bloomquist, Officer Alfidiva Peru, Sabrina Day, Sergio Maldonado, and Officer Marin in the back who is becoming one of the city favorites. He has a couple more who couldn't come this morning. But he is fully staffed, they have become a career now instead of a career pitstop. He thanked all of them.

Commissioner Hechler said he understands due process. He asked for clarification on the process when they enforce violations. Can the Code Enforcement Officer immediately write a ticket or do they have to go through the full process. There is some perception that it takes a long time to get some things done. When you write a letter and get some response, how is that handled. Police Chief Alirez responded they do have the ability to issue a citation or a summons to get them into court right away. One of the enemies is you here, well we've always done it this way. But if it never worked anyway, why were we doing it that way. They met with Judge Sanders and not only are they looking at addressing Code Enforcement issues, but other city ordinances as well. Whether it is animals or noise. There are some things that do occur when we would wait two weeks and that's no longer the case. He gave an example of a case where they went out of town to find the owner to help get these issues cleaned up. Not one size fits all when it comes to this. They are going to work with everybody to get things fixed,

Commissioner Hechler asked some of the things that get thrown back at them are the issues with the city property. Police Chief Alirez responded we had this problem recently with the Solar Farm. They may have more than one party that's responsible for that whether its flood control or other issues. They start making phone calls or meet with Don Armijo to get those wheels rolling to take care of it. They take an aggressive stance on that to get the ball rolling. They are also working on something they can do to utilized people who may have to do community service on some of these issues.

Commissioner Hechler said one final concern he has is the alleys and he hopes they are being as aggressive on those. Mr. Chavez said the alleys and easements are highlighted in the letters to the property owners.

Police Chief Alirez wanted to say when they talked about moving Code to the PD, he got some marching orders in where they needed to go. He was given an expectation of where he needed to go. And it wouldn't have done so great without the buy-in from Mr. Chavez.

City Attorney Rubin said before you is the Ordinance 690 providing a procedure for the recusal of City Board Members. A few months ago, the Commission revised the procedures in relation to recusals during a meeting. This ordinance extends that to all other boards. He read the two main paragraphs of the ordinance.

Mayor Pro-Tem Whitehead asked for comments from the Commission or staff or from the public. There being none, she proceeded with the next public hearing.

2. Public Hearing: Notice of Intent to Submit application to NMFA Colonias Infrastructure Board for Cook Street Water Treatment Facility Improvements. Arnie Castaneda, W/WW Supervisor

Mr. Castaneda said the city will be applying for approximately \$1.5 million for the Cook Street Water Treatment Facility.

Mayor Pro-Tem Whitehead asked for comments from the Commission or staff.

Mayor Pro-Tem Whitehead closed the Public Hearings.

Commissioner Clark moved to approve Final Adoption of Ordinance No. 690 adding Section 2-210 providing a procedure for the recusal of City Board Members. Commissioner Hechler seconded the motion. Roll call vote was taken by the Clerk-Treasurer. Motion carried unanimously.

2. Discussion/Action: Resolution No. 14 17/18 calling for a Regular Municipal Election for March 6, 2018. Renee Cantin, Clerk-Treasurer

Clerk-Treasurer Cantin said this Resolution will be calling for the Regular Municipal Election. The Resolution has to be passed between 112-84 days prior to the election and the next meeting would be one day too late for that. Upon researching the current Commission terms the following positions will be on the ballot: Position I, for a four year term; and Position III for a four year term. She submitted the tentative calendar that meshes both the Regular & Special Elections together and she is waiting for confirmation of some of the dates from the County Clerk for the certification of voting machines. She called their attention to the important date for the Regular Election coming up which will be Candidate Filing Day on January 9, 2018 from 8:00 a.m. – 5:00 p.m. at the Clerk's Office. Once the calendar is finalized, she will distribute it to the media and to anyone who needs a copy of it.

Commissioner Clark asked for clarification for Absentee Voting and why certification of voting machines is done three days later. Clerk-Treasurer Cantin responded Absentee Voting by mail is not done by machines, they will need them for early voting which starts on January 3rd.

Commissioner Frankel moved to approve Resolution No. 14 17/18 calling for a Regular Municipal Election for March 6, 2018. Mayor Pro-Tem Whitehead seconded the motion. Roll call vote was taken by the Clerk-Treasurer. Motion carried unanimously.

3. Discussion/Action: Resolution No. 15 17/18 authorizing and approving submission of a completed application for financial assistance and project approval to the New Mexico Finance Authority for the Colonias Infrastructure Fund for Improvements to the Cook Street Water Treatment Facility. Arnie Castaneda, W/WW Supervisor

Mayor Pro-Tem Whitehead asked if there was any further discussion.

Commissioner Clark moved to approve Resolution No. 15 17/18 authorizing and approving submission of a completed application for financial assistance and project approval to the New Mexico Finance Authority for the Colonias Infrastructure Fund for Improvements to the Cook Street Water Treatment Facility. Commissioner Frankel seconded the motion. Roll call vote was taken by the Clerk-Treasurer. Motion carried unanimously.

Finance Director Torres said they are respectfully requesting approval of the budget adjustment. She wanted to note, DFA has some requirements and although it may show three times, we are just tracing the path as required. Transfers included \$12,000 for the purchase of the building at the Airport; the \$60,000 from Police Department GRT, for the Animal Shelter. The other expense for this is from the Capital Appropriations we received. There are some expenses that have to be taken out of pocket and that's where its taken care of.

Commissioner Hechler moved to approve Resolution No. 16 17/18 Budget Adjustment. Commissioner Clark seconded the motion. Roll call vote was taken by the Clerk-Treasurer. Motion carried unanimously.

a. City Manager

- 1) Noted tomorrow he and a couple of other staff members will be attending the Budget Workshop from DFA in Albuquerque.
- 2) He will also be attending the mediation that will be discussed in Executive Session briefly.
- 3) He asked Building Inspector Travis to introduce our new GIS Planner Susanna Diller. She comes from UNM and has a Bachelor's and Master's Degree. She's done a good job in picking things up quickly and we are excited to have her with us.

Commissioner Clark said she got to meet Susanna and gave her an ear full too. She appreciates her being on because she feels this is something that's very important for the city.

Commissioner Frankel will be meeting with Stream Dynamics to work on the existing drainage ponds. He'll be meeting with the Streets Department. Work is scheduled

between November 28th and December 14th to complete this drainage project we started. He asked the City Manager for an update on the Tourism Director and how that's working out.

City Manager Fuentes gave an update on what she's working on including a new brand for the city. Hotsprings.life and she came up with a new design. She's working with a company for some Customer Service training for businesses. She is working on maintaining the facility and will have a presentation and update to come back to the Commission. They are working on getting enough applications for the Lodger's Tax Board so she can work with those Board Members in the upcoming cycle for funding.

Commissioner Clark asked Clerk-Treasurer Cantin how we are doing on the Airbnb and those Lodgers Tax for that. Clerk-Treasurer Cantin responded they have not received any responses and she will put the notice in the Utility Bills again. She needs to work with the Ruidoso contact to help with making a list of those people who are selling. She set up an account in Airbnb, but it doesn't show an address unless you actually reserve it. Commissioner Clark asked if we could ask the PD to follow through, is that a possibility? Clerk-Treasurer Cantin said she still needs to get with the City Attorney to put together a resolution for the fees so we will have those in place. She was trying to work on the list to see what we have to work with first.

City Manager Fuentes said this is something we can put on the front burner to get the draft resolution at the December meeting or no later than January. Commissioner Clark said her concern is we have the new Tourism Director and some money here that has not been tapped.

APPROVAL OF AGENDA:

Chairman LaFont called for approval of the agenda.

Vice Chairman Senn moved approval of the agenda as submitted.

Member VanGelder seconded the motion. Motion carried unanimously.

APPROVAL OF MINUTES:**Approval of Regular Meeting of Tuesday, April 4, 2017:**

Chairman LaFont called for approval of minutes for April 4, 2017.

Member VanGelder mentioned a few errors he found in the minutes prior to the meeting.

Member VanGelder moved approval of the minutes as corrected.

Vice Chairman Senn seconded the motion. Motion carried unanimously.

COMMENTS FROM THE PUBLIC:

There were no comments from the public.

NEW BUSINESS:**Discussion/Update: Fuel Farm Project; Cheryl Rodriguez, Delta Airport Consultants:**

Cheryl Rodriguez, Delta Airport Consultants reported on the following:

The Fuel Farm Project is broken out into 3 schedules, and the first 2 schedules have been awarded.

- **Schedule 1** is the initial site work, and has been completed. They are going through final inspection, and the final close out process. They will be wrapping up the administrative details in the coming weeks.
- **Schedule 2** is underway, and the tanks are being manufactured. There was a delay in shipping of the pipes and the pump components, but they are currently in route to the tank manufacturer. Once the pipes and the pumps arrive on site with the tank manufacturer, they will be assembled and delivered to Truth or Consequences. The estimated tank delivery date will be the week of August 8th. Once the tanks are delivered, the contractor has approximately 45 days to complete the tank installation onsite.
- **Schedule 3** is the final component of the project, and the completion of the site work. This includes installing the security gates, completing all of the electrical hook ups, and installing the 1000 gallon "low lead" day tank. We are currently going through the bid process, and have received one (1) bid. The city is working with the FAA and the State Aviation Department, to complete the bid negotiations with that bidder. Once we complete that process, then we can hopefully submit the FAA grant application that week. We anticipate the FAA grant funds to be available in August or September of this year. Right now, with the project date for schedule 2 work, and the anticipated funds for schedule 3, we are still on track to have this project wrapped up by the end of this calendar year.

Vice Chairman Senn- He is in the very first hangar, and there is about 60 ft. between the front doors of the hangar and where the new concrete begins. If they are planning to extend the fence out into that pavement where there is a double yellow line it's going to be real tight because he has a large heavy airplane, and it's really hard to turn in there. Also, has any consideration been taken about damage to the pavement in front of hangars #1 and #2 from the large trucks going back and forth because he believes the pavement is made of chip seal and not asphalt?

Cheryl Rodriguez – The fence will not be adjacent to the pavement. It will be adjacent to the concrete wall where the tanks are. And they have not reviewed the damage to the pavement, but that is something from an operations consideration when the tanks and fuel is delivered, and how airport staff maneuver the vehicles. They will have to look at how circulation is affected at that point.

Mark Bleth – They will make it to where the trucks can back straight out.

Discussion/Action: Hangar Lease Fees; Juan Fuentes, City Manager:

City Manager Fuentes – They are looking at all fees throughout the city and one of the things that they have discussed is hangars, and signing off on some of these agreements that we have in place. In reviewing the fees for the hangars, it was brought to his attention that they have not been updated in several years. Mark Bleth did some research on some comparable, and we

wanted to share that information with you all, and have a discussion on whether consideration should be given to the fees we are currently charging as well as any potential adjustments.

Mark Bleth - The rate for most of our hangars is \$100 a month (he left the old hangars out of this discussion). He spoke with Chris Augie about the Augie hangars, and they charge \$155-\$165 for their hangars, and Southwest Aviation in Las Cruces, charges \$190 for their hangars. He went to the Clerk's Office to see how long these prices have been in place, and the oldest records we found were from 2006 and the prices we charged back then was \$100 and \$110 for the hangars. When he spoke to Chris Augie, she believed she paid \$100 for a hangar when they used to rent from the City 15 years ago. So he doesn't think that we are keeping up with the market.

Member VanGelder – The market meaning... since it's been 10 years, the price should automatically go up?

Mark Bleth – No, it's not because of 10 years... it could be 20 years for all we know.

Member VanGelder –Just because we haven't raised the prices, does that necessarily mean that they should automatically be raised?

Mark Bleth – I guess what City Manager Fuentes is saying is that we need to have a discussion about it, because all of our neighbors, and even people within our own facility, like the Auggie's, are getting \$40% more for hangars.

Member VanGelder – That being a good comparison. However, they have electric doors and bigger hangars. You may be comparing apples to oranges. He believes the same is true with Double Eagle or you can probably look at Deming or El Paso. He knows that El Paso charges \$100 a month for some of their hangars.

Mark Bleth – He just looked within our geography.

Vice Chairman Senn- Deming, Silver City, Socorro...

Member VanGelder – He wouldn't mind the rent being raised if you would fix the hangar doors or make it more accessible for people who have low voltage in their hangars. He would gladly have you raise the rent to \$125 a month, and then he can put an air conditioner in there, because you don't have any kind of a system for charging for electric, or those kinds of things. He thinks that there is more to it that should be factored in here. You just rented a hangar to a guy that's keeping cars in his hangar.

City Manager Fuentes – If there are some issues that need to be corrected in these hangars, then obviously those are the things we need to be aware of, and be able to address, but the bottom line is a lot of times we are challenged with finding revenues, and ways of, how to pay for things. If there are issues in the hangars, then obviously the funds for fixing those things

have to come from somewhere. We need funding to fix the hangars, but if we don't have the funding, then how can we fix the hangars. This is something that we are reviewing, but obviously it has to be to a point to where those fees cannot remain for another 20 or 30 years. If there are other comparable that we need to research, then we can do that, but again, it is something that we have to start considering with those concerns that you brought up about, okay we need to at least address deficiencies in the hangars, because you're right, we don't want to have somebody in one of the hangars just running a system 24/7, then we're paying this tremendous electric bill. Another issue that we will be tackling down the road is how to better track usage within those hangars. So within time we can look into that, and how we can best address it.

Member VanGelder – We don't know what it's costing the City on a yearly basis.

City Manager Fuentes – We can certainly provide that information, that's not a problem. But I can tell you we're transferring over \$50,000 to the Airport every year.

Member VanGelder – You have been doing that for years. I mean in fact, I think back in the old days, that number was higher than \$50,000.

City Manager Fuentes – That's correct, but ultimately the goal is to reduce that dependency on other funding. It is considered an Enterprise, and it should be operated as an Enterprise. It's not going to be a fix overnight, but the fact that there is a deficit in that operation means we obviously need to address it, and figure out how to fix that deficit, and obviously fixing it is going to require resources.

Member VanGelder – The purpose of this discussion would be to look at other ways to improve the Enterprise Fund so that it wasn't a deficit, and that would include the leasing of properties at the Airport. For instance, the Propane Farm and those things, if they are also part of the Airport Property they would be part of the Enterprise Fund. He would contend that raising the rent is like, *strangling the chicken to increase egg production*. It's the very place where we really shouldn't be raising the prices unless it's an absolutely last place alternative. You don't want to be running pilots out of here, and having them go to other places. We should be bringing pilots in here, and one of the few things we do have, is good prices on hangars.

Mark Bleth – The lynchpin of the economic recovery of the Airport, is on the backs of the tenants. This is just like cost cutting. We should be able to do better with internet access than using century link for internet for \$375 a month for a horrible connection. There are lots of things that we need to address which includes this item. This isn't an action item. This is a discussion item that this is something that we need to look at. So let's look at the non-commercial side of this which is the issues we have with the hangars that don't have aviation uses. Right now, we can support those people when we don't have a waiting list for a hangar. If there's somebody waiting with a plane those people who have non-aviation use hangars have to go. Since we don't have a wait list they can be there. However, they are supposed to pay market rate which means the rate that would be generated at a storage unit.

Member VanGelder – We went through that last year and the end of that discussion was that the FAA said that there did have to be an airplane in the hangar. He doesn't know if that is different now.

Mark Bleth – He thinks it is pretty clear that the FAA recognizes that municipalities and other ventures that are use Part 139 funding have to survive. If you don't have a wait list for a hangar, and you have empty hangars, they allow non-aviation use for it.

Chairman LaFont – Some people who have an airplane, leave their boat or pickup in the hangars so they can use it when they come to town.

Mark Bleth – There are people who have started their contract that way, and there are people that put numbers on their contracts and say "Oh I live in Albuquerque, and I want to move down here," but then the planes never makes its way down here. There have been changes at the Airport, so nobody has actually held anyone accountable for those things, but we do plan on doing inspections.

Member VanGelder – It sounds to him that your logic on what drives this, is a hangar waiting list. Angela had a hangar waiting list for years, and we made that go away last year. If that's what it takes is to have a hangar waiting list then he thinks all that would take is some simple advertising. Then you'd have a hangar waiting list again.

Mark Bleth – We actually anticipate a hangar waiting list within the next couple months. On the non-aviation market, the rate for 60 x 12 ft. (720 sq. ft.) storage unit is \$1800 a year so if someone were to use one of our hangars (approximately 1100 sq. ft.) it would cost \$1200 a year. So theoretically we should be at minimum, doubling the hangar rent for anyone who doesn't have a plane in their hangar.

Vice Chairman Senn –So what you're saying is that you are going to do an inspection on the hangars, and if they are non-aviation, then you are going to send them a letter? That seems fair to him, because they are using it as storage, and they are getting great rate. See with an airplane you don't have any choice. We have to put it out there.

Member VanGelder – If that is going to be part of this market plan, then he would like to say that he thinks it's a mistake, for the same reason that David is saying that you're comparing "Mr. G's storage," a place that has hundreds of storage units, to one Airport within 50 miles that has storage places that are shaped like airplanes and are only supposed to be used for airplanes.

City Manager Fuentes – The real question before the Advisory Board is, if the hangars are going to be used for non- aviation, basically for storage, do we want to be charging less than what they would be paying at a private sector. We are not talking about aviation. This is non-aviation, people's items. I don't think the intent is for the Airport to allow people to start non-aviation

use where they can find a storage place somewhere else. I just don't see where the benefit is to allow that at a cheaper price, than from a private sector.

Member VanGelder – I don't think it should be part of the discussion at all. I don't think that you should allow that. The FAA paid for those hangars, and it is the purpose of why we pay \$6 a gallon for fuel in most places. This funding is coming from the feds, and it should be for airplanes. You shouldn't be competing against non-aviation businesses.

City Manager Fuentes – So if I understand correctly, from your standpoint, they shouldn't be there if they are not storing a plane.

Member VanGelder – Absolutely.

Chairman LaFont – He thinks that the big thing that we need to say is that we want our hangars to be rented for aviation, period.

Mark Bleth – If everyone that had a hangar felt that they were obligated to park a red pickup truck at the Airport, then we would have 24 red pickup trucks all over the place. So if we allow vehicle storage to happen inside of the gate area there should be a charge for it because we don't charge anything. So we either don't allow it, or if we do allow it, there should be a charge for it. This is a discussion item on whether or not we should take action on this in the near future. This is something that we would like to discuss with you as far as policy on vehicles inside the fence. All I am asking is to create a policy and set a price or have a policy that we don't allow it. This wouldn't be for the general public. It would be for anyone who already has a hangar.

Chairman LaFont – He doesn't know if it could be looked into or not, but he knows that a lot of cities have sold their hangars to individuals and charged so much for the square footage of the hangar, and a lot of people fix up the hangars and get new power and all of that for them. He doesn't know if the FAA owns the hangars that are out here, or if it could be done, but he knows that in Farmington and Albuquerque, the cities do not own those hangars, they're privately owned.

Discussion/Action: Airport Manager Update; Mark Bleth, KTCS Airport:

Mark Bleth reported the following

- Increase of AV Gas sales at the Airport.
- This is leading into the hangar lease. We have a signed lease for the Pippen Hangar from a crew chief that's with Virgin Galactic. His name is Chad and he has also agreed to sponsor the EAA Chapter. We submitted the application and formation of the chapter to the EAA.

- We talked about the T33 as an action item, and he has a quote from Bartoo for that which is right around \$1000 after tax. We are going to look at it internally at the City to see what it would cost for us to do it vs. letting them do it and have that liability of them doing it.
- City Council has amended the Ordinance to allow camping at the Airport. Things have been discussed internally about a "work camper" type of person that we will have onsite. It would be a similar concept to a park out in the middle of nowhere where there is somebody that gets free rent to pick up the trash and take care of things. We had somebody in mind that will be willing to do it, and they are a pilot, and they have a hangar out at the Airport. They would have to go through a background check just like any other city volunteer. We still have to work on a policy as far as aviation use in any of those campers, how long they stay, and those types of things. Once they have everything together they would submit that as a package to the FAA for final approval.

Discussion/Action: Consider declaration of vacancy for Board Member Ron Phillips position; Angela A. Torres, Deputy City Clerk:

Angela Torres – Mr. VanGelder informed her about a month ago that Mr. Phillips has moved away. However, he did not submit a resignation letter. Therefore, I am asking for your approval of vacancy, so that I can move forward with advertising and get that seat filled.

Member VanGelder moved to accept the vacancy of the position so that it can be advertised.

Vice Chairman Senn seconded the motion. Motion carried unanimously.

Discussion/Action: Re-appointment of members, Gerald LaFont, David Senn, and Dennis Anderson to the Airport Advisory Board:

Member VanGelder moved to re-appoint members, Gerald LaFont, David Senn, and Dennis Anderson to the Airport Advisory Board.

Vice Chairman Senn seconded the motion. Motion carried unanimously.

COMMENTS FROM THE BOARD:

Vice Chairman Senn – If we are going to have some hangars that are going to be airplane related is there a protocol for how you're going to sequence the people out. Are you going to send everyone a letter including the people with an aircraft?

Mark Bleth – He will check with City Hall to see who are the slow payers or late payers. We could possibly use seniority. However, everyone has a new lease every year.

City Manager Fuentes – Do we have a list of the hangars, and who was aviation and who was non-aviation?

Mark Bleth – Every one of them have an EIN number that they put on their lease application. Whether or not they actually have that plane, we do not know.

City Manager Fuentes – Maybe after the inspections are completed, we could come back and update the board.

Member VanGelder – This is the only Airport he ever kept his airplane at that doesn't require a certificate of insurance.

COMMENTS FROM STAFF:

There were no additional comments from staff.

ADJOURNMENT:

There being no further business to come before the board, Chairman Gerald LaFont asked for a motion to adjourn the meeting.

Member Chuck VanGelder made a motion to adjourn the meeting.

PUBLIC ARTS ADVISORY BOARD MEETING
October 16, 2017
MINUTES

TIME & PLACE:

The Public Arts Advisory Board of the City of Truth or Consequences, New Mexico met in the conference room in the Administration Annex at 401 McAdoo, Truth or Consequences, New Mexico on Monday, October 16, 2017 at 4:00 P.M.

PRESIDING OFFICER:

The meeting was called to order at 4:08 PM by Sid Bryan.

QUORUM: There being a quorum present, the Board proceeded with the meeting.

APPROVAL OF MINUTES:

A motion to approve the minutes of the September 18, 2017 meeting was made by Juan Fuentes, seconded by Jagger Gustin, and it carried.

COMMENTS FROM THE PUBLIC:

None

While waiting for Andy Underwood to get to the meeting, Juan suggested the Board read Sabina Muñoz's letter regarding her concerns over the structural integrity of the Reed Rockets sculpture and her recommendation to remove the springs. Sid asked if Jeff Barbour had been invited to the meeting. Linda Sparks replied that Jeff was notified of the meeting; however, he did not get a copy of the agenda. (The agenda was posted on the City's website.) Sid asked if this required Board action. Juan responded that it is under Item D and that it may require some action, but it's something the Board needs to discuss to see how it wants to proceed with it. Juan added that it ties in to the final payment because if we have structural issues with the project, they will have to be addressed.

Sid asked if on the 'Update on Art Park' (Item C), if it wasn't really Andy who hasn't seen the presentation for the MainStreet grant application. Juan suggested that when we watch the video, they visualize the Reed Rockets there because when he saw the video and what's being proposed, he's not sure if they're going in there. The Board will wait for Andy to join the meeting before watching the video. Juan continued that the question of payment has been asked regularly and that payment and the structure of the art project now are all tied in.

Jagger inquisitively commented that there's a change called for now so we wouldn't pay for it until it's . . . (Jagger did not finish his thought.) Juan asked, what do you mean? Jagger answered that Sabina is asking for the springs to be removed. Jagger read from Sabina's letter, "I'm requesting that the spring portion be removed to ensure structural integrity for the life of the piece." Jagger asked if Jeff had been given a copy of Sabina's letter. Linda Sparks replied that she did not provide him with a copy of the agenda packet. Jagger stated that the letter is dated August 15th. Sid commented that is 2 months ago. Linda Sparks responded, that's not when we got it. Juan stated that he got the letter from Sazi when they met 2 weeks ago.

Juan recommended postponing Item E, 'FYE 2018 Rodeo Arena Art Project'. Jagger responded that he has some information on that, that he would like to relay.

Small talk ensued while waiting for Andy.

REED ROCKETS SCULPTURE:

Juan suggested moving onto other items on the agenda while we wait. Jagger commented that since we have a quorum, we should be able to do that. Juan asked what the Board thought about what Sabina is requesting. Jagger said his thought is, is it really going to change the whole thing. Is Jeff going to be able to do that and keep the integrity of the . . . Juan interjected, if she has a valid point to her concern and we share her concern, he can show it to Jeff and ask him to address it and have him at the next meeting to explain how he will address this concern, if the Board agrees with Sabina's assessment of the art piece. Jagger commented that he thought the springs really are an integral part of it that hold it and make it do what it's supposed to do. Juan commented he thinks what Sabina is saying is that the spring is going to give out at some point. It's not always going to be that straight. Eduardo responded that it was never straight in the first place. It always had an angle. Juan stated that the question before the Board is, 'Is there a valid concern on this that needs to be discussed?'

Andy joined the meeting and was informed that we are discussing the letter from Sabina. Eduardo asked if she has seen it directly or seen it from a video picture. Juan asked Linda DeMarino if she has been in conversation with her. Linda replied that she has not, but thinks Sabina has been to Jeff's yard. Juan asked again, based on her letter, does she have valid concerns that the Advisory Board needs to make a recommendation to Jeff on that. Sid commented that, like Eduardo said, if there's a normal tilt to them anyway, it may not mean that there is wearing and she should explain what she means by this a little bit more. Then ask Jeff at the same time, if these are correct or not. Jagger commented that he thought Jeff had those parts engineered

and looked at for strength and durability. Juan responded that he doesn't think engineered is the right word. He said what she is saying is that the spring apparatus has weakened and caused a lean. Eduardo asked how often has Sabina seen them because she states that they have weakened. Has she been there more than once? Linda DeMarino responded that she is sure Sabina has been there more than once. She drove by there the first time she was in town. Then there was a plan at some point that she was going to meet with him. Eduardo commented that maybe she saw something that we haven't. Sid repeated that we should get more information from both of them before we make any suggestions. Andy asked if Jeff has had any input into this. Jagger commented that we don't even know if he has seen the letter or not. Andy stated that Jeff's got to have some input in this. Juan again suggested the Board ask both Jeff and Sabina to provide more input on this because eventually down the road whatever is constructed, once it's done, will become our responsibility. Andy added that public safety is #1. Sid asked if he wanted to put it into a motion. Juan replied that he didn't think a motion was required; we'll just forward it to them. Sid responded that we would like an answer to it if we have to be requesting. Andy asked if we should ask Jeff to a meeting to talk about it. Andy added that we have Sabina's input, right. Sid replied, no because this isn't really explanatory. If it does have a lean already built into it, that does not mean it has changed. Then we're saying it could be a safety hazard. Linda DeMarino asked what is it about the springs, is it something you can put your fingers in. Juan replied, yes, they're right at the bottom within reach. Eduardo stated that Jeff was trying to build something to prevent people from getting their hands in some place, but doesn't know how far he has gotten with it. Jagger added that it's some kind of a covering that shrouds that. Juan stated that he will call Sabina and let Sazi know that he will reach out to her with what the Board wanted, ask for more information and detail. We'll invite Jeff to come back to the next meeting and address that. Linda Sparks brought in a picture of some Reed Rockets that Jeff had provided a year prior. The picture showed a lean/tilt approximately mid-way up the poles. Eduardo added that they will bend a little bit more when the wind hits them. Andy stated he helped Jeff set one up one time during Art Hop. Juan commented that he doesn't know whether that is the lean Sabina is referring to or if they're leaning even more. Juan asked if those 3 are still up on his property. Andy replied that the last time he went by there, he doesn't think any of them were up. Linda DeMarino asked if the spring is at the lean or at the base. Sid said he thought they were the ones higher up. Eduardo said there was something at the bottom, but thinks they were bolts. It was determined that they need more information.

UPDATE ON ART PARK:

Linda DeMarino had been asked to present MainStreet's Art Place America grant presentation to the Board. Juan asked Linda to play the video. During the water harvesting part of the video, Juan asked Linda if that was a conceptual of what it is going to look like. Linda answered no; that actually is something Sabina designed for something else. They used it in the application because they needed visuals. They just picked pictures of water. Linda thinks that the art will draw people in and then for them to be able to see different water harvesting techniques in use, is a really good way for educating people. Linda stated that a guy named Alejandro produced the video. They worked 3 days with him, taking pictures and meeting people. He actually works for

Spaceport. He got so much footage so they talked to him about doing something for T or C. Everyone commented how nice it turned out. Linda added that it's been viewed on YouTube about 300 times so lots of people have seen it. Sid asked if Mark would be able to show it in the theatre before the movie. Linda made note of it to ask Mark. They will not find out whether they got it or not until December. That is why everything is on hold. If we get the grant, we might be able to purchase the property next to the Art Park. We could have Sabina draw up a conceptual design of what we have right now, but if we end up acquiring the piece next to it, it changes the whole entire concept. The concept right now is 'art park', but the Art Place people came through and said no, we want you to use that space as your pilot sight for the water harvesting too and the concepts would be married drawing people in for the art, and then teaching them about some of the water harvesting techniques going on around them so it could be really beautiful. We can actually incorporate art into the water harvesting portions of that. Sid asked if they were given a timeline when they thought the grant would be awarded. Linda said they will tell them in December. Sid commented that we should wait until December before we do anything else with this because it would change. Linda stated that it would be a waste of money paying Sabina to do one thing and then going back again and having to pay her to do a whole different concept that's twice as big. Sid stated that even if they just keep that one piece of land, with that extra money they could do some pretty different things than what they would be doing with just what we have now.

Jagger asked to comment on behalf of Jeff. Jeff authorized him to tell the Board that he is not against relocating it somewhere else on a city park or property, but Jagger personally thinks it should go there because it's been designed site specific and it's very dramatic. Jeff wants the Board to know that he's not against relocating it to another city owned parcel somewhere. Jeff asked Linda if Sabina's been paid some to do . . . Linda interjected that she has not. Sabina has given them contracts to sign, but we're holding off with her because like she said, there is no sense throwing money out the window.

Juan addressed Andy's question at the last meeting about final payment to Jeff. Juan stated that the City cannot make payment to Jeff until the art piece has been installed and the City accepting it. Again, also not only just because of the final product, it included installation as well; he as the artist installing the art piece. Now that we may have some questions about the integrity of the structure itself, it needs to be addressed because it changed from the original concept that was presented to us however long ago it was to what it became now, that is one of the reasons we can't make final payment until it's been installed. Andy asked; this wasn't the original concept? Everyone replied no. Linda DeMarino offered to draw it for Andy. She's drawn it many times. Linda explained her drawing of the original concept. Others added to the explanation, while others disputed some aspects. Andy asked if it was to this same scale. Linda answered yes. Eduardo stated that they were 30' tall. Jagger stated that what happened was when Jeff started looking at engineering the gimbals, it was prohibitively expensive to get that done for 14 of them so that's when he changed the design. Linda commented that it's been changed numerous times and listed the changes. Andy commented that he hates to see Jeff have to wait forever because of things that are beyond his control. Juan responded that was why he wanted Linda to give this presentation, because that ties into the reason why we are having to wait, as

Cary said about him wanting it there. Andy asked if the remainder of the money that is owed him, is that on a contract, on a payment schedule. Could you give him a portion of it? Juan stated that Sierra Arts Council paid him its share and the City is not going to pay him anymore until this is installed. Jagger explained that the Arts Council had been saving money for years for the project and so when this came online and MainStreet got on board with it, we paid him the portion that we had. Then the City has paid a portion so it's like a final invoice that's left. It's about \$2,400. Juan added that the City is paying him storage fees as well. Sid asked; how much are the storage fees? Juan inquisitively answered \$25. Linda Sparks responded that is what he charges. Juan stated that more critical is making sure that Jeff, because he is the artist and that's what he proposed to be installed, from our standpoint and for liability reasons, Juan doesn't want the City to assume the responsibility of installing them, then for Jeff to say 'you guys didn't do it right'. It included him also installing/supervising making sure it was all the way he designed it. It's still in Juan's opinion that what we owe him is substantial enough to encourage Jeff to make sure that it's finally installed properly. Andy asked Juan; if you do have concerns about the structure, how are you going to deal with that. Juan replied that he is bringing the concerns that Sabina is bringing to the Board. That's why he brought the letter to the Board so she is going to provide some more information and Jeff will have to address those concerns. He is guaranteeing this art piece. That's why we want to make sure that he is guaranteeing a safe art piece. Juan doesn't want somebody getting decapitated by one of these art pieces. Andy asked if there is a process that the City uses to make sure they are structurally sound and the insulation is good. Juan replied that the artist usually guarantees that. The City doesn't have anybody that is certified or qualified. Andy asked if the Building Inspector can't do that. Juan asked; why would we take that responsibility and liability when we didn't construct it. It is the artist that normally would say this is engineered, this is constructed, this is safe. Otherwise, we are passing the liability on to the City. It's an art piece so it's not something for the Building Inspector. For example, the springs, Sabina as a landscaper and an artist might say, I have some concerns about that; but Jeff as the artist might say, no – it's okay. Does that mean that 15-20 years from now those springs are going to hold up the same way? Linda stated that MainStreet had been asked to create an RFP prior to that art piece being selected, and in a lot of RFPs the artists supply insurance on that piece sometimes for 2-3 years after it's installed. Andy commented he saw that application, sometimes you ask for a 3 or 4 year warranty. Juan stated that for us it's also the safety part of it, and that may be something we require of him as well, the warranty – that he is going to guarantee that the structure is going to be sound for a 2 year period, 3 year period. Andy asked if we have a contract with Jeff. Juan answered that we have his proposal, but he doesn't think it's a formal contract. Andy asked that in the future on projects like this, should we have some kind of permitting thing. He builds for a living so this sounds crazy to him. If he wants to put a steel post on the ground, he has to get it engineered to do it. Juan responded that this was a unique project because it wasn't engineered by a professional; it was more of the artist engineering it himself. That's why, as Linda mentioned, it went through different variations of changes. Andy asked that to protect the City in the future, should we have some kind of a process set to where we make sure things are safe and it's just not art. Juan replied that if it's going to be a structure like this, then yes. It's in our interest to do that. Andy interjected, that's really our job isn't it; not only to provide beauty, but safety. That's why he brought up the thing about

not paying him, because he also thinks that's part of our job too, is to be a good business partner with the artist. He understands the safety aspect completely, but he doesn't think you can ask him for a guarantee if you never asked him in the beginning. It's kind of tough to ask him at the end. Juan replied that it's always been in the beginning. Andy asked; so he's already told you that he'll guarantee it for 3 years? Juan replied that we've discussed the setting of the structure being sound, but like Linda said, it's gone through so many changes. It wouldn't surprise any of us if once it's being installed that he wouldn't ask, let me tweak it a little bit here. It wouldn't surprise Juan if there's a final adjustment at the end. Andy stated that if we ever decide to figure out a permitting process for public art, he would be glad to help out.

FYI 2018 RODEO ARENA ART PROJECT:

Jagger informed the Board that he has toured the rodeo arena and the City and the County, as he's said before, have come together and have really upgraded that facility. It's been painted and the arena floor has been resurfaced with new dirt for the animals, he honestly can't see any place where you would put a piece of sculpture. He doesn't know how you would put it out in the middle of the roadway, if you put it along the tree line. He can't see any place where it would work. He really thinks that if we're going to buy art, that it needs to come downtown where our art pieces are already located. We have plenty of space here. We have Evelyn Renfro Park, the Triangle Park, the Ralph Edwards Park, even our Plaza that's beautiful and right next door. What he thinks is needed out there is some signage. He had opportunity a few weeks ago to go to the High School and attend a meeting. He was asked to go because of the art scene and the Arts Council and they have a grant. It's called the Carl Perkins Foundation Grant and he thinks there's \$22,000 in that. They asked if he knew of any projects and he told them he did. He told them that the Rodeo Arena, the City facility, could use a sign and the reason he thought it would fit is because their design kits are CAD design kits that they design on the computer. They could work out the sign, then it could be transferred next to the Shop kids and then they could weld and cut it out with a plasma and construct it and it would not be that expensive. He doesn't know where that funding is right now, but he did tell them that he would tell the City about it. It could be a multi-use sign. It could say the Arena and it could also have events on it. He thinks it would really benefit the City. It would also help those kids. The art kids can work on it, and the welding kids could also work on it too.

Jagger went on to comment on the selection process of public art. He has given the Board information before. Linda with the MainStreet program commented on that just a little while ago. They had an RFP out and he suspects that the City and the attorneys have probably looked at that already. It's already got the language in it so why reinvent the wheel. He had copies of that and passed them out. Jagger stated that this is from the Buckhorn Art Park and why reinvent the wheel when we already have this in place. It would seem pretty simple just to change it around. Jagger believes that it has already been looked at. Linda corrected Jagger saying that it hasn't been looked at. She had never done anything with RFPs and Juan asked her to do an RFP. She looked at RFPs from a bunch of other places and took what was applicable to us so it could be looked at by other people and Jay. Jagger stated that he is not against the horse. He has seen it and is familiar with the artist's work, but he really thinks it needs to be fair. There might

be an artist living in Hatch or somebody living in Hillsboro or wherever, Socorro, Albuquerque who would say, I could make a steel thing to fit what those people are looking for. It doesn't mean the Board couldn't select that one piece, but it would be more fair if there was a process and using this RFP as a template would help. Sid stated that it would go to someone from Sierra County. Linda thought they had put it in the RFP. Jagger asked Juan if he wanted him to find out more about the Carl Perkins Grant. Juan replied, yes. This is a great start, with the proposal Linda put together so if everybody wants to look at it. Jagger clarified that he was talking about signage for the rodeo arena. Juan answered, yes. If there's a grant, forward it to Traci. Jagger said he would get Traci some contact information. Juan said that what we were talking about is what do we do while we're waiting on this to be finalized, what's the next project. So if the next project is to put an RFP together for art in public places, rather than calling it specifically in the Buckhorn area, just say 'you're invited to participate in public art'. Jagger asked everyone to go back to his sample prospectus in the packet. He went through it as he did at the last meeting. Juan asked how he would plug all those questions into the RFP. Jagger replied that it's already in here. All these questions are already answered in the RFP, if you look at it. This is a simplified form that came from the State. Linda added that if there is a theme, you're going to want that. Jagger continued, you state who is eligible to submit a design and give a date of submission. State how it is to be submitted. Then you decide how many finalists you're going to look at. Then there needs to be some public comment. Juan responded that eventually the Board will have to come up with an approved RFP for art in public places that can be advertised. How does this group put together all of these things so that we can get started? Do we submit our suggestions to Linda? Juan asked Jagger and Linda if they want to take a stab at it. Jagger said he would be willing to do that. On the committee to draft an RFP is Jagger, Linda and Andy. Juan suggested getting it done by the end of the year and advertise it the first part of the year so that we can get an art piece by the end of the fiscal year. Sid mentioned the case with the Spaceport and how they did not open it to locals after repeatedly stating that locals would be involved. That created a lot of ill will. Jagger stated that they really so circumvented the process.

Linda stated that she would love to see the Board put small sculptures in the flowerbeds in the Healing Waters Plaza. She loves the HWP, but there's nothing in the HWP that identifies it as being T or C. Even if you were to do 2 small sculptures and put them in the flowerbeds because some of those flowers don't grow. It would be really cool to see something like that there because right now it's kind of nondescript which is uncharacteristic of T or C.

Jagger asked Linda how the prospect of putting something at the rodeo arena came about. Did somebody suggest that? Juan answered, yes – somebody suggested it because we were making improvements out there. The thought was that the art piece could be the sign; not necessarily the sign but a centerpiece, like when you see the gateways to communities. That could be another project for this Board, try to do a gateway to the community that would have an art piece. There are a lot of examples out there. The gateway to the rodeo arena off of the main road, the centerpiece could be the art piece. That is how the initial discussion/idea came about, but it's up to the will of the Advisory Board. After the committee has put the RFP together and everybody's approved it, it can be viewed by legal, then forwarded to the City Commission for

approval, and then we can put it out there. Andy asked Juan if he wants to see a suggestion on where to put it besides the rodeo arena with our little committee. Juan replied that he doesn't know that a location has to be identified, unless you want to be specific. The conversation recorded above about the location was repeated. Andy stated that it could be generic or it could be specific. He then asked if we are going generic or specific. Juan stated that he is leaving it up to the Advisory Board to decide. The RFP Committee can come back with a proposal.

COMMENTS FROM THE PUBLIC ARTS ADVISORY BOARD:

No other comments were made.

TIME, PLACE AND DATE OF NEXT MEETING:


The Board decided to meet again in November. The next meeting of the Board will be Monday, November 13, 2017 at 4:00 P.M. at the Administration Annex. Sid will be out on the 20th. Andy stated that the agenda says we meet quarterly on the 3rd Monday of the month; that doesn't make sense to him. Juan responded that we met quarterly, but because of this project, we started meeting monthly. Linda Sparks explained that the meeting schedule for advisory boards that was on her desk when she started working for the City had the Public Arts Advisory Board meeting quarterly, but she recently discovered that regular meetings can be monthly. The Board can meet as needed.

ADJOURN:

There being no further business to come before the Board, the meeting was adjourned at 5:17 P.M. Juan Fuentes moved to adjourn, seconded by Andy Underwood, and it carried.





WHEREAS, the State Canvassing Board of New Mexico establishes a determination of Estimated Actual Costs of Recount/Recheck Proceedings in March of even numbered years.

NOW, THEREFORE, BE IT HEREBY RESOLV ED by the governing body of the City of Truth or Consequences, New Mexico that the determination of estimated actual costs of Recount/Recheck Proceedings adopted March 15, 2016 by the State Canvassing Board of New Mexico be adopted as the Recount/Recheck Proceedings costs for the January 23, 2018 Special Municipal Election and the March 6, 2018 Regular Municipal Election.

BE IT FURTHER RESOLVED that a copy of the determination of Estimated Actual Costs of Recount/Recheck Proceedings be attached to this Resolution.

New Mexico State Canvassing Board

Cost Determinations – Estimated Actual Cost of Recount & Recheck Proceedings

1 INTRODUCTION

Pursuant to §1-14-15 NMSA 1978, the state canvassing board shall determine the estimated actual cost of a recount per precinct and a recheck per voting machine no later than March 15 of even-numbered years. The costs are valid upon approval of the state canvassing board for elections conducted through March 15, 2018.

Pursuant to §1-1-6 NMSA 1978:

"Recheck" pertains to electronic vote tabulating systems and means a verification procedure whereby a printout of the electronic record of votes cast in an election is made from each electronic memory device in the electronic vote tabulating system and the results are compared with the results shown on the official returns.

"Recount" pertains to all paper ballots, including absentee ballots, provisional paper ballots, optical scan paper ballots and any other paper ballot and means a verification procedure whereby the voters' selections for an office are re-tallied and the results compared with the results shown on the official returns.

2 RECHECK COSTS PER VOTE TABULATING SYSTEM

Pursuant to §1-14-15 NMSA 1978, an applicant for a recheck shall deposit with the proper canvassing board or, in the case of an office for which the state canvassing board issues a certificate of nomination or election, with the secretary of state sufficient cash, or a sufficient surety bond, to cover the cost of the recheck for each voting machine to be rechecked.

2.1 ESTIMATED ACTUAL COSTS – MINIMUM COSTS

- Recount Precinct Board - \$1,000 per day.
 - Precinct workers may be paid up to \$200 per day pursuant to §1-2-16 NMSA 1978.
 - A recount precinct board is established pursuant to the provisions of §1-2-12 NMSA 1978 and shall minimally consist of four members as follows:
 - A presiding judge;
 - Two election judges; and
 - One election clerk.
 - For purposes of the determination of estimated costs, a five person recount precinct board is the optimal minimum number of precinct board members necessary to run a recheck on up to ten vote tabulating systems per day.
 - Additional precinct board members or rechecks that last beyond one day will increase actual costs.

3 RECOUNT COSTS PER PRECINCT

Costs of a recount shall include the cost of programming and certifying the voting systems to be used during the recount proceedings and daily per diem costs for the recount precinct board.

Pursuant to §1-14-15(D) NMSA 1978, additional costs to be paid by the applicant seeking the recount shall consist of docket fees, mileage of the sheriff in serving summons and fees and mileage of precinct board members, at the same rates allowed witnesses in civil actions.


3.1 ESTIMATED ACTUAL COSTS – MINIMUM COSTS

- Election Project Development and Voting System Programming and Certification - \$1,440.
- Recount Precinct Board - \$1,000 per day.
 - Precinct workers may be paid up to \$200 per day pursuant to §1-2-16 NMSA 1978.
 - A recount precinct board is established pursuant to the provisions of §1-2-12 NMSA 1978 and shall minimally consist of four member as follows:
 - A presiding judge;
 - Two election judges; and
 - One election clerk.
 - For purposes of the determination of estimated costs, a five person recount precinct board is the optimal minimum number of precinct board members necessary to re-tally votes in up to ten precincts per day.
 - Depending on the size of the recount and the number of precincts included, recount precinct boards may include additional workers as determined by the county clerk and the secretary of state's office.

- Recounts that include additional precincts may require more members and/or more days, which may increase the actual cost of the recount.
- The county clerk and secretary of state shall establish the makeup of recount precinct boards and the conduct of a recount proceeding in accordance with applicable law. The makeup of recount precinct boards and the conduct of a recount proceeding may impact the actual costs associated with a recount. A hand tally of ballots is likely to require additional time and effort, which will increase costs.

- **Baseline Meter Accuracy**

- YESCO performed testing per AWWA standards of a statistical sample of existing water meters to establish the baseline average accuracy by meter size. YESCO determined that the ¾", 1" and 2" meter sizes accounted for 96.6% of the baseline annual billed water consumption, and therefore elected to focus the testing on these meter sizes.
- The tested meters had an average age of 20.0 Years, whereas the total meter populate has an average age of 20.7 Years.

- **Water and Sewer Utility Rates**

- YESCO reviewed the current effective water and sewer rates, and elected to conservatively set the baseline water rate at the lowest billing tier of \$1.75/kgal. The sewer billing rate is a level \$3.44/kgal.
- The City has established a plan to escalate sewer utility rates by 5.0% annually, and is intending to implement a similar plan for water utility rates in the near future. This project conservatively includes an annual utility escalation rate of 0.000% on Water and 5.000% on Sewer to align with the City's approved plan.

- i. The key parameter driving the estimated increase in water and sewer revenues is the improvement in new meter accuracy. Therefore, this key variable must serve at the foundation for the guarantee. YESCO guarantees the proposed new meter accuracy for the ¾", 1" and 2" meter sizes for the duration of the project finance period as depicted in the following table.

- How is the Guarantee Applied?
 - i. Testing of the new meters will be performed per AWWA standards on a recurring basis during the performance period. The results of this testing will determine if the average new meter accuracies are performing above the guaranteed meter accuracies detailed in the previous table.
 - ii. If the measured new meter average accuracy is above the guaranteed meter accuracy for that specific year, then the guarantee will be deemed as met.
 - iii. In the event the measured new meter average accuracy falls below the guaranteed meter accuracy for that specific year, then the methodologies detailed in the IGA Report will be followed to determine the monies owed to the City by YESCO to fulfill the guarantee. It is important to note the following:
 - 1. The baseline average annual water and sewer consumption values shall remain flat for the duration of the performance period. An overall increase or decrease in delivered water will have no effect on the guarantee.
 - 2. YESCO has accounted for a 5% reduction in water consumption as the result of implementing this project.
 - 3. From the previous tables above, the water and sewer rates for the corresponding year will applied against any shortfall in savings. Therefore, any escalation to the water and sewer rates shall also increase the guaranteed amount owed to the City in the event of a shortfall.
 - 4. To clearly restate, YESCO guarantees the accuracy of the new meters for the duration of the finance period. The estimated increase in revenue is fundamentally based on the recovered access to billable gallons through the installation of more accurate meters. YESCO does not guarantee changes in consumption or changes in revenue.

APPROVAL OF AGENDA:

Chairman Szigeti called for approval of the agenda.

Vice Chairman Dornbusch moved approval of the agenda as submitted.

Member Pacourek seconded the motion. Motion carried unanimously.

APPROVAL OF MINUTES:**Regular meeting of Monday, October 16, 2017:**

Chairman Szigeti mentioned an error that Vice Chairman Dornbusch found in the minutes under "comments from staff."

Vice Chairman Dornbusch moved approval of the October 16, 2017 minutes with changes noted by Chairman Szigeti.

Member Pacourek seconded the motion. Motion carried unanimously.

COMMENTS FROM THE PUBLIC:

Klaus Wittern - He would like to request the board to allow him to make a 20-30 minute presentation at the next Public Utility Advisory Board meeting.

RESPONSE TO COMMENTS FROM THE PUBLIC:

Chairman Szigeti - Does Mr. Wittern's request have to be approved by a vote from the board, or can it just be added to the agenda?

City Manager Fuentes – There is no action on this agenda item, so it would be at the discretion of the Chairman and Members of the board.

The board requested for Mr. Wittern's presentation to be added to next month's agenda.

Presentation – GIS Mapping-Susanna Diller, Planner/GIS Tech.:

Robbie Travis, Building Inspector, introduced the City's new Planner/GIS Tech. Susanna Diller to the board.

Susanna Diller gave a brief presentation on what Geographic Information Systems is, what kind of data we have available, and some of the capacity we have for using that. She explained that GIS is the relationship of people, technology, software, and information that allows you to analyze, capture, manage, present, organize and store spatial data, which is any data that is referenced to a real position on the earth.

Discussion/Action: Automated Meter Reading Project for Electric and Water System - Yearout Energy Services Company:

Scott Griffith, Yearout Energy Services Company – The City Commission recommended that they bring this item back to the Public Utility Advisory Board for any questions they may have. With the request of City Council, they added a price for just the meter project that would not require any escalation on the water side, but would include the sewer side. The intent on the water side was always a healthy project.

The idea was to be able to pay for the electric meters inside one project, which would require some creative funding and finances to make that happen. We added both in the packet, so you can take a look at what the priority would be moving forward.

Chairman Szigeti – The comment the Mayor made during the presentation had him thinking about it. He really needs to understand what the guarantee is, and how that works. So let's say... the system has been in place for a year, and you come back for that first evaluation, what happens?

Scott Griffith, Yearout Energy Services Company – This project is being done under a State Statute, and that State Statute requires that we have a heavy measurement verification of the project on a yearly basis, so that we reconcile it on the water side of it, because it is a revenue capture project and every M&V protocol is a little bit different, you design it per project. There are 4 different versions of an M&V Plan. One of the things we do is develop the baseline, and so what we do is the offset after the first year, and then we look at what the revenues are against what the revenues were predicted to be.

Alex Montano, Yearout Energy Services Company – Reviewed the following:

- **Description of Guarantee:** The completely described guarantee will first describe how the baseline was established, and then how the guarantee is applied against the baseline.
- YESCO reviewed several years of billing history to establish the baseline 3-Year average annual billed water and sewer consumption from 2014 to 2016.
- **Baseline Meter Accuracy:** YESCO performed testing per AWWA standards of a statistical sample of existing water meters to establish the baseline average accuracy by meter size. YESCO determined that the ¾", 1" and 2" meter sizes accounted for 96.6% of the baseline annual billed water consumption, and therefore elected to focus the testing on these meter sizes.
- The tested meters had an average age of 20.0 Years, whereas the total meter populate has an average age of 20.7 Years.
- **Water and Sewer Utility Rates -** YESCO reviewed the current effective water and sewer rates, and elected to conservatively set the baseline water rate at the lowest billing tier of \$1.75/kgal. The sewer billing rate is a level \$3.44/kgal.
- The City has established a plan to escalate sewer utility rates by 5.0% annually, and is intending to implement a similar plan for water utility rates in the near future. This project conservatively includes an annual utility escalation rate of 0.000% on Water and 5.000% on Sewer to align with the City's approved plan.
- **Proposed Meter Accuracy:** The key parameter driving the estimated increase in water and sewer revenues is the improvement in new meter accuracy. Therefore, this key variable must serve at the foundation for the guarantee. YESCO guarantees the proposed new meter accuracy for the ¾", 1" and 2" meter sizes for the duration of the project finance period as depicted in the following table.
- **How the Guarantee is applied:** The testing of the new meters will be performed per AWWA standards on a recurring basis during the performance period. The results of this testing will

determine if the average new meter accuracies are performing above the guaranteed meter accuracies detailed in the previous table.

- If the measured new meter average accuracy is above the guaranteed meter accuracy for that specific year, then the guarantee will be deemed as met.
- In the event the measured new meter average accuracy falls below the guaranteed meter accuracy for that specific year, the methodologies detailed in the IGA Report will be followed to determine the monies owed to the City by YESCO to fulfill the guarantee. It is important to note the following:
- The baseline average annual water and sewer consumption values shall remain flat for the duration of the performance period. An overall increase or decrease in delivered water will have no effect on the guarantee.
- YESCO has accounted for a 5% reduction in water consumption as the result of implementing this project.
- From the previous tables above, the water and sewer rates for the corresponding year will be applied against any shortfall in savings. Therefore, any escalation to the water and sewer rates shall also increase the guaranteed amount owed to the City in the event of a shortfall.
- To clearly restate, YESCO guarantees the accuracy of the new meters for the duration of the finance period. The estimated increase in revenue is fundamentally based on the recovered access to billable gallons through the installation of more accurate meters. YESCO does not guarantee changes in consumption or changes in revenue.

Vice Chairman Dornbusch made a motion to not recommend the proposed Automated Meter Reading Project for Electric and Water System, to the City Commission for approval, and they drop this project right here, right now.

Motion seconded by member Pacourek.

City Manager Fuentes – He understands the motion that was made by this board to not support this item. However, the item will be added to the December City Commission Agenda if the motion carries, because the intent of the City Commission was not for this board to avoid sending this item back them.

Member Pacourek – Well, that's our opinion.

City Manager Fuentes – The motion will be recorded, but the way it was made was for it not to be sent back to the Commission. His job is to present it here, then take it back to the Commission.

Chairman Szigeti – He does not think that they have the authority to “kill an item.”

Vice Chairman Dornbusch – This should be really simple. You came in here telling us that we have inefficient meters, and you had this plan to replace our water meters and electric meters with the cost of the efficiency increase. By taking our inefficient meters, and putting more efficient meters in, that

would generate the revenue that would pay for the system. But, I can't help but look at all these numbers we are cascaded with. Some are pertinent, and a lot of them are not. *"The cost will be covered by the increase efficiency of the new meters."* He has heard that so many times, but when he looks at the efficiency of the new meters at a 95.5 % guarantee, that's only 3%, maybe 4% above what we have going right now. So when he looks at the math, and looks at the 3% or 4%, that's only \$30,000 of generated revenue off of our dollar efficient meters. That comes nowhere close to the \$96,128 that all of this is predicated on, that we were told would be everything that we would need to pay for this over the next 20 years. He looks at these numbers, and he looks at the cost of the meters themselves, and just to pay for the meters for this community would cost us less than half a million dollars (\$480,000 roughly). Now if we put them only in the residences that are occupied, we would drop that by 20%. These meters cost \$130 a piece. How much have you raised that cost, 4%, 400%...quite a bit? Now with the AMI System, he understands staffs wish to have the human error out of the equation, and he agrees, but we don't live in a world where we have money raining down on us so we can't afford this, even at their proposed plan which is to have the meter efficiency pay for the system. It doesn't work out with his mathematics. So with that being said, he is totally against this system.

Chairman Szigeti – Ron, do you have anything to add?

Member Pacourek – We're a dying community. We've lost 1000 people in the last census. There are less people in the community, so our utilities have to go up because there are less people to pay for the growing utility departments that we have. That's a fact. And things have been kicked down the road so long it has now come to either get off the pot or do something. Yes, he would like to come into the 21st century with automatic meters, but he also thinks that "Tyler" cannot handle this system, because it cannot even handle budget billing. And he also thinks that this can be done "in-house" and cheaper.

Sonya Williams- Member Pacourek, your solar was put on a separate billing, because of the fact that if you were getting a credit, it wasn't going to come out of the water, sewer or trash, and you and I discussed that. But there was a time when the solar wasn't even on your bill, so because of the Tyler System, it is now, and you can see it. And as far as the budget billing, you signed an agreement saying that you would make a payment every month (that's what budget billing is) and you skipped a payment. Even if you had a credit, the system still shows that a payment wasn't made that month.

The board voted as follows, to not recommend the proposed Automated Meter Reading Project for Electric and Water System, to the City Commission for approval.

Chairman Szigeti voted nay.

Vice Chairman Dornbusch voted aye.

Member Pacourek voted aye.

Motion carried with a 2 to 1 vote.

COMMENTS FROM THE BOARD:

Member Pacourek – Where are we at on this Electric Cost Adjustment with City Attorney Rubin?

Chairman Szigeti – At the last meeting he reported that the pass-thru charge and the calculations are in an internal document within the Electric Department Procedures, it's not in the ordinance. The ordinance just authorizes the charge. At the last meeting it was requested that the Electric Department

revise their documentation to change the name to the Electric Cost Adjustment, and to update the way in which it is listed. He offered his assistance to help with that if needed. Since that time, he has not heard anything back from the city. It has been 6 months since the City Commission approved it, so hopefully we can get this in place for the 2018 billings.

COMMENTS FROM STAFF:

There were no additional comments from staff.

ADJOURNMENT:

There being no further business to come before the Public Utility Advisory Board, George Szigeti, Chairman, declared the meeting adjourned.
