A RESOLUTION of the Town of Twisp, Washington, amending TMC6.10.090 Violations—Penalties: 6.10.028 Failure to license dog

WHEREAS, the Town Council of the Town of Twisp, Washington, has determined that updating the TMC Section 6.10.090 Violations—Penalties is necessary to further town policy and public safety interests; and

WHEREAS, the Town Council of the Town of Twisp needs to amend the Twisp Municipal Code 6.10.028 Failure to license dog- 1st citation to reflect this determination;

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Twisp, as follows:

- 6.10.090 Violations—Penalties
- Any person, firm, company or entity violating the provisions of this chapter shall be guilty of a civil infraction and shall be subject to monetary penalties as follows (said penalties may be revised from time to time by Resolution of Town Council):

6.10.040(4)	Any violation of TMC 6.10.040(4), Registration and Restraint of Dangerous Dogs, is a misdemeanor and upon conviction thereof shall be punished by a fine not to exceed \$1,000 or by imprisonment for a period not to exceed one year, or by both such fine and imprisonment. For each violation of this chapter of a continuing nature, each day of violation may be considered a separate offense.	
6.10.042	Penalties for violation of TMC <u>6.10.042</u> , Animal waste	\$25.00 for first violation, \$50.00 for second, and \$100.00 for all subsequent violations within a three- year period from the first violation
6.10.060	Any violation of TMC <u>6.10.060</u> , Animals – Cruelty, is a misdemeanor and upon conviction thereof shall be punished by a fine not to exceed \$1,000 or by imprisonment for a period not to exceed one year, or by both such fine and imprisonment. For each violation of this chapter of a continuing nature, each day of violation may be considered a separate offense.
