ORDINANCE NO. 59, Second Series

ORDINANCE AMENDING CHAPTER V
OF THE TWO HARBORS HOME CHARTER 2005

THE CITY COUNCIL OF THE CITY OF TWO HARBORS DOES ORDAIN:

Section 1. Amendment to Chapter V, Sections 2 and 3. Chapter V, Sections 2 and 3 of the Two Harbors Home Charter 2005 are hereby amended to read as follows:

Organization

Section 2. The city council shall, at its first regularly scheduled meeting in January, elect a president and a vice president for a one year term, and such other officers as may be necessary for the transaction of its business. The mayor and council members shall be eligible for such positions. Such election shall be by ballot if so requested by any member, and the affirmative vote of the majority of all the members present shall be necessary.


Duties of President

Section 3. The president, and in the case of the absence of the president, the vice president, shall preside over the meetings of the city council, and shall sign all resolutions and ordinances passed by the city council. The president, as deemed necessary, shall appoint council members to city council standing or ad hoc committees now or hereinafter established by the mayor or city council. The appointment of council members to the city boards, commissions and committees designated in Two Harbors City Code Section 2.40 shall be governed by Two Harbors City Code Section 2.40. During the absence of the mayor from the city, or the mayor's inability for any reason to discharge the duties of the office, the president and in the case of the absence of the president, the vice president shall have and exercise all the powers and duties of the mayor, as "acting mayor." The acts of such acting mayor shall have the same force and effect as if performed by the mayor.


Section 2. Authority. Pursuant to Minnesota Statutes Section 410.12, Subd.7 (2009), a governing body may amend its charter by ordinance after the charter commission recommends an amendment. Upon the effective date of this Ordinance, the term of any officer selected after the adoption of this Ordinance, but prior to the effective date shall be reduced to a one-year term.

Section 3. Effective Date. This Ordinance shall be effective: (a) ninety (90) days after (1) its passage and (2) approval by the Mayor, and (b) upon its publication once in the legal newspaper for the City of Two Harbors.




Organization


Section 2. 

ORDINANCE NO. 112, SECOND SERIES

ORDINANCE AMENDING CHAPTER XII, SECTION 2
OF THE TWO HARBORS HOME CHARTER 2005

THE CITY COUNCIL OF THE CITY OF TWO HARBORS DOES ORDAIN:

Section 1. Amendment to Chapter XII, Section 2. Chapter XII, Section 2 of the Two Harbors Home Charter 2005 is hereby amended to read as follows:

Library Board, Appointments, etc.


Section 2. There shall be maintained in the city a library board which shall consist of nine directors who shall hold office for the term of three years, or until their successors are elected or appointed and duly qualified. Directors will not be eligible to serve more than three consecutive terms.

Annually the mayor, by and with the advice and consent of the city council, shall appoint three directors as members of the library board to serve for the period of three years. The majority of directors shall be chosen from the citizens of the city at large, without reference to sex or political opinions but with reference to their fitness for said office. Not more than one member of the city council and not more than one member of the county board shall at any time be a member of said library board.

Section 2. Authority. Pursuant to Minnesota Statutes Section 410.12, Subd.7 (2016), a governing body may amend its charter by ordinance after the charter commission recommends an amendment.




