Assembly, Business, Mercantile and Storage buildings with a required plumbing fixture count less than 12. 4. Work completed by a governmental subdivision of State agency costing less than \$15,000.00

*** All plumbing plan reviews are billed at \$80 per hour and are based on the inspectors hours billed for the review. All fees must be paid prior to permit being issued.**

FEE CLARIFICATION:

MOBILE HOME PARK SITE: When item is used for sewer excavations in a new park, the permit application should include the application fee plus the number of unit sites. When setting a mobile home in a park, or a mobile or modular home on property, a permit should include the application fee, a sewer or building drain, and a water service or water distribution pipe.

INSTRUCTIONS FOR COMPLETING APPLICATION:

GENERAL: Plumbing work shall not be started until a permit has been obtained. All installations shall be in conformance with the Plumbing Code. No work shall be concealed until it has been inspected.

When ready for an inspection, call the Township providing as much advance notice as possible. The Township will need the job location and permit number.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six (6) months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six (6) months after the time of commencing the work. A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX (6) MONTHS OF THE DATE OF ISSUANCE, OR THE DATE OF THE LAST INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED.
