

**ORDINANCE NO. 1-1996**


**BE IT ORDAINED** by the Fountain-Warren County Board of Health as follows:

Section 1: The Fountain-Warren County Board of Health shall make and collect a fee of \$5.00 for each search of the records in the Division of Vital Records of the County Health Department. If the requested record is found, the first certification of the record will be issued for a fee of \$5.00. An additional certification of the same record will be issued at that time for an additional fee of \$3.00 for each record, excepting as otherwise provided by the statutes of the State of Indiana. Verification without charge will be issued to any agency of local, state, of federal government upon written request by such agency.

Section 2: This Ordinance shall be subject to approval by the respective Boards of the County Commissioners of Fountain County, Indiana and Warren County, Indiana.


Section 3: This Ordinance shall be in full force and effect upon approval by the Boards of Commissioners of Fountain County, Indiana and Warren County, Indiana and the filing of the written approval endorsed on a copy of this Ordinance in the office of the County Health Officer of the Fountain-Warren County Health Department.
