Chairman Ericksen informed the Commissioners of his conversations with Tyler Stone, Administrative Officer, and Monica Morris, Finance Manager, regarding the request from Jim Burres for information pertaining to the County's Local Government Investment Pool Account. Chairman Ericksen has instructed Morris to remove the County's account number from the information. The requested documents will be provided to Mr. Burres by Chairman Ericksen and County Counsel Eric Nisley.

**APPROVAL of Special Session Consent Calendar of March 30, 2010.**

The Board considered the approval of the Special Session Consent Calendar of March 30, 2010, (Attached as Exhibit A).

**{{{Commissioner Holliday moved to approve the Special Session Consent Calendar of March 30, 2010, as presented. Commissioner Lennox seconded the motion; it was then passed unanimously.}}}**

Tyler Stone, Administrative Officer, informed the Commissioners that he is asking the General Fund Departments to reduce their materials and services by 10%, which will leave an additional \$200,000 in reductions in order to balance the proposed budget for Fiscal Year 2010-2011. He has requested that the North Central Public Health District push over more General Fund expenditures to the

dedicated Public Health Fund. Stone stated that he has managed to get there without cutting staff.

**{{{Commissioner Lennox moved to approve Amendment #001 to Grant Agreement GRNT0438 between the Oregon Department of Community Colleges & Workforce Development and Wasco County Youth Services Employment Program and Grant Agreement between Wasco County Commission on Children and Families and Mid-Columbia Child & Family Center; said approval are subject to Legal Counsel's approval. Commissioner Holliday seconded the motion; it was then passed unanimously.}}}**


