At 9:02 a.m. Chair Holliday called the Special Session to order.

Consideration of the Fee Waiver Request from Columbia Land Trust.

Commissioner Hege asked if the Columbia Land Trust was going to allow public access to the Mill Creek Ridge. The Trust did not have an answer last fall when they met with the Board of Commissioners in regards to a letter of support for their grant application.

Some discussion occurred.

Commissioner Runyon felt that the Board should get the answers to our questions before making a decision on their fee waiver request.

Staff was directed to contact the Columbia Land Trust to schedule a time when they can make a presentation to the Board of Commissioners.

Other Business:

Commissioner Holliday brought up the request from the City of The Dalles as to the installation of a WiFi antenna on the roof of the County Courthouse.

Some discussion occurred.

Tyler Stone, Administrative Officer, stated that he spoke to Nolan Young, City of The Dalles Manager, while in Washington, D.C. He asked Young why the antenna could not be placed on the roof of Annex B. Stone was informed that the antenna needed to be strategically placed in the downtown core area. The antenna does not have to be permanently mounted; it would be set on the roof.

The Board will consider the City of The Dalles' request at their meeting on April 6, 2011.
