Carol Friend, independent auditor for the Wasco County Library Service District, explained the County collects taxes on behalf of the District; the cities handle their own activity for the various libraries.

Ms. Friend reviewed the audit report (included in packet) noting that it presents and unqualified opinion. She pointed out that the fourth quarter payment to the City of The Dalles was not made by the end of the fiscal year and therefore shows as a liability to the District. She stated that the District employs the modified accrual basis method of accounting.
