THE COUNTY COURT OF WASCO COUNTY, OREGON DOES ORDAIN AS FOLLOWS:

Section 1. PURPOSE

The purpose of this Ordinance is to amend established uniform fees to be collected by the Wasco County Surveyor and Road Department; the Wasco County Clerk; the Wasco-Sherman Public Health Department; the Wasco County Treasurer/Tax Collector; and the Wasco County Community Corrections Department for performing the service required or necessitated by ORS 92.090, 92.100, 192.410 to 192.500, 205.340, 209.260, 271.230, 517.030, 517.220, and 517.290 within Wasco County.

Section 2. AUTHORITY

This Ordinance is enacted pursuant to the authority granted to general law Counties by ORS 203.035 and by Chapter 833 of the 1979 Oregon Laws.

Section 3. FEE SCHEDULE

The following fees shall be charged and collected by the indicated Department before the filing, recording, or coping of subject documents shall be completed.

(A) WASCO COUNTY SURVEYOR AND ROADMASTER

(1) The fee for performing the services set for in ORS 209.260 shall be \$10.00 for the filing and indexing of a map of a survey (no limit on size or number of sheets).

(2) The fee for Blue Line Printing shall be \$.30 per sq. ft.
(\$1.00 minimum).

(3) The fee for copies of documents shall be \$.25 per sheet.

(4) The fee for the Surveyor to check partition plats shall
be \$50.00.

(B) WASCO COUNTY PLANNING & DEVELOPMENT DEPARTMENT

(1) The fee for copies of documents shall be \$.25 per sheet.

(C) WASCO COUNTY JUVENILE DEPARTMENT

(1) The fee for a copy of the Wasco County Juvenile
Detention Facility Policy and Procedure Manual shall be \$13.00
(This fee may be waived for government agencies.)

(D) WASCO COUNTY CLERK

(1) The fee for performing the services set forth in ORS
92.090, 92.100 and 271.230 and 205.350 shall be as follows:

For approval by the County Court of any plat, the County
Clerk shall collect \$10.00;

For recording and indexing any plat, the County Clerk, in
whose office the deeds of the County are kept, shall charge
as follows:

- (a) For plats containing 20 lots or less - \$25.00
- (b) For plats containing over 20 lots, and less than
30 lots - \$30.00
- (c) For plats containing 30 lots, and less than 50
lots - \$35.00
- (d) For plats containing 50 lots, and less than 75
lots - \$40.00

(e) For plats containing 75 lots, and less than 100 lots - \$45.00

(f) For plats containing over 100 lots - \$75.00

(g) For partition plats - \$25.00

(2) The fee for performing the services set forth in ORS 271.230(2) for the services of the County Surveyor for marking the record upon the original plat shall be \$15.00 to be collected by the County Clerk and paid to the County Surveyor.

(3) The fee for performing the services set forth in ORS 517.030 shall be \$5.00 per page paid to the County Clerk who shall immediately pay over said sum to the County Treasurer.

(4) The fee for a transcript from the County Clerk lien docket to Circuit or District Court shall be \$10.00 which is set forth in ORS 205.320(13).

(5) The fee for performing the services set forth in ORS 517.220 shall be \$5.00 per page.

(6) The fee for performing the services set forth in ORS 517.290 shall be \$5.00 per page.

(7) The fee for performing the services set forth in ORS 471.210(3) for liquor license application recommendation shall be \$25.00.

(E) THE WASCO-SHERMAN PUBLIC HEALTH DEPARTMENT

(1) The fees for performing the services required for on-site sewage disposal shall be those on Exhibit A attached hereto and by this reference incorporated herein.

(2) The fee for a records search shall be \$.50 per record.

(3) The fee for copies of documents shall be \$.25 per sheet.

(4) The fees for performing the tests and providing the services incidental to the operation of the Health Department shall be those on Exhibit B attached hereto and by this reference incorporated herein. No person will be refused said services because of inability to pay.

(F) THE WASCO COUNTY SHERIFF'S DEPARTMENT

(1) The fee for performing a records search and providing a copy of a theft report shall be \$5.00 per request.

(2) The fee for performing a records search and providing a copy of an accident report shall be \$10.00 per request.

(3) The fee for taking a complete set of fingerprints and providing an inked set shall be \$2.50 per request.

(G) THE WASCO COUNTY ASSESSOR'S DEPARTMENT

(1) The fee for copies of documents shall be \$.25 per sheet.

(2) The fee for computer print outs shall be \$.25 per page, or \$5.00 minimum.

(3) The fee for Stock Maps shall be \$1.00 per map.

(4) The fee for State Ordered Maps shall be \$1.50 per map plus postage.

(H) THE WASCO COUNTY TREASURER/TAX COLLECTOR'S DEPARTMENT

(1) The fee for photocopies shall be \$.25 per sheet.

(2) The fee for computer copies shall be \$.50 per sheet.

(3) The fee for Non-Sufficient Funds shall be \$10.00 per check.

(4) The fee for certifying true copies shall be \$5.00.

1 (5) The fee for furnishing a substitute for a Tax Statement
2 (Copy of Tax Statement or Tax Roll) shall be \$2.00 if Reference
3 Number is furnished, if not, the fee shall be \$3.00.

4 (6) The fee for stop payment shall be \$11.00.

5 (I) THE WASCO COUNTY JUDGE'S OFFICE

6 (1) The fee for copies of documents shall be \$.25 per sheet.

7 (J) THE WASCO COUNTY COMMUNITY CORRECTION'S DEPARTMENT

8 (1) The fee for monthly Supervision Fee for Probation shall
9 be \$25.00 per month.

10 (2) The fee for Persons ordered by the Courts to perform
11 Community Service in Wasco County shall bear the cost of their
12 participation in such program.

13 Section 4. ENACTMENT PROVISIONS

14 (1) CONFORMANCE WITH LAW

15 Except as expressly provided herein, this Ordinance shall in no
16 way be a substitute for or eliminate the necessity of conforming with
17 any and all State and Federal Laws, rules and regulations including
18 but not limited to the payment of all other fees required by law and
19 other Ordinances which are now nor may be in the future in effect
20 which relate to the requirements provided in this Ordinance.

21 (2) SEPARABILITY

22 If any section, subsection, sentence, clause, phrase or portion
23 of this Ordinance is for any reason held invalid or unconstitutional
24 by a Court of competent jurisdiction, such portion shall be deemed a
25 separate, distinct and independent provision, and such holdings shall
26 not affect the validity of the remaining portion of this Ordinance.

(C) Each fee paid entitles the applicant to as many site inspections on a single parcel or lot as are necessary to determine site suitability for a single system. The applicant may request additional site inspections within 90 days of the initial site evaluation, at no extra cost.

(D) Separate fees shall be required if site inspections are to determine site suitability for more than one system on a single parcel of land.
