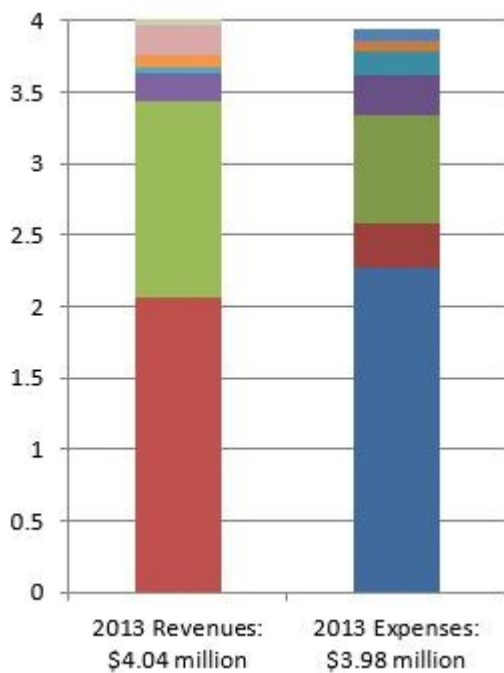

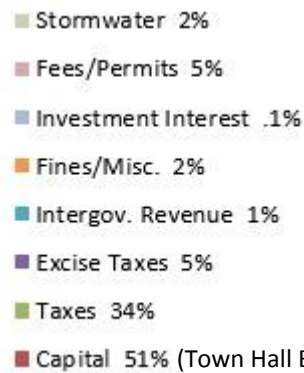
2013 BUDGET REPORT

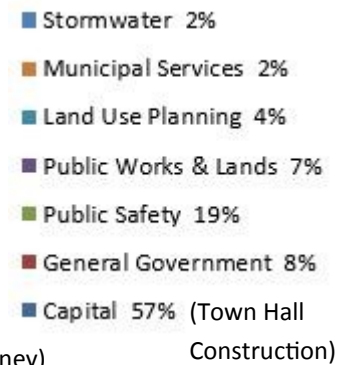

EXPENSES \$3.98 MILLION



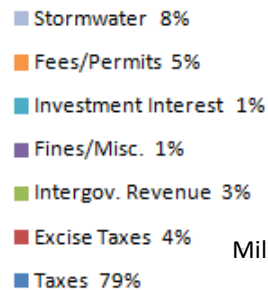
2013 ACCOMPLISHMENTS

- Woodway was awarded Conservation Futures funds from Snohomish County for the purchase of 4.3 acres of park lands.

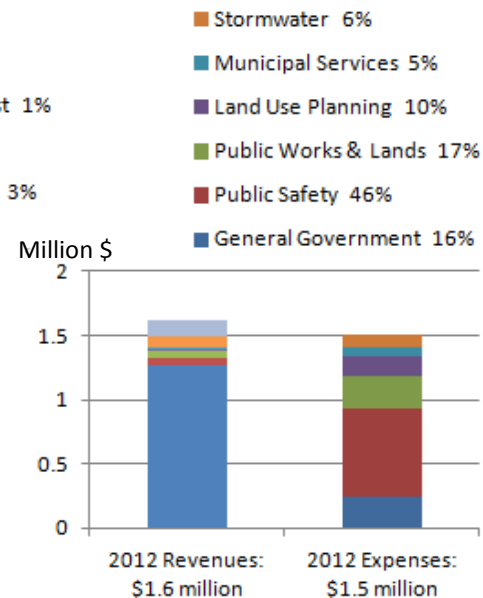

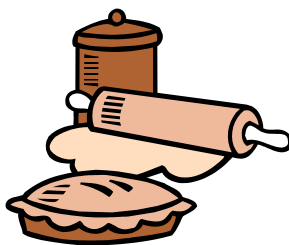
As in past years, local businesses

OUTDOOR BURNING INFORMATION



Smoke can be a public health problem and certain outdoor burning activities are actually prohibited in portions of our state. Residents of King, Kitsap, Pierce, and Snohomish Counties are prohibited from engaging in most outdoor burning activities.

- Burning for land-clearing

purposes is never allowed.

- Residential yard debris burning is also not allowed.
- If there is not a temporary burn ban in effect, small recreational fires are allowed. This includes campfires, cooking fires, and bonfires using charcoal or firewood.

Be alert to temporary burn bans in the summer (due to fire-safety issues) and in the winter (due to

air-quality issues). You can visit <http://www.pscleanair.org/airq/burnban/status.aspx> to determine if a burn ban is in effect.

Violations can be costly; fines may exceed \$17,000 per day. The usual fine starts at \$2,000 plus reimbursement costs for fire department responses. If you have questions about outdoor burning, please contact Shoreline Fire Department at 206.533.6565.

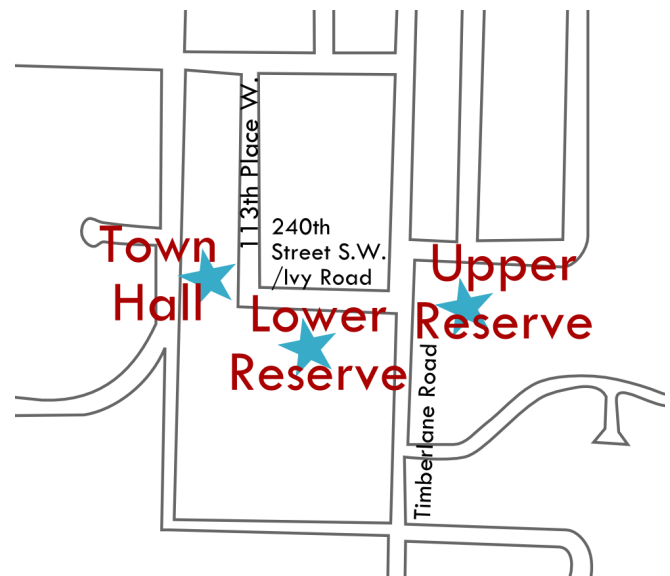
A SUMMER TREAT

A FIGHT OVER SEWAGE!

You might have heard recently of an impending controversy involving the City of Shoreline's efforts to become a sewer services provider. Shoreline, with the concurrence of the Ronald Wastewater Utility District Board, filed a proposal with the King and Snohomish County Boundary Review Boards to assume jurisdiction over Ronald. The controversy primarily revolves around whether Shoreline is the appropriate service provider for unincorporated property within Snohomish County.

Under the State's Growth Management Act, cities are deemed the logical providers for water and sewer services within the State's urban areas. Cities have the

authority to "assume" the assets and responsibilities of water and sewer districts under certain circumstances. County Growth Management Hearings Boards are charged with reviewing the appropriateness of any such assumption.

Snohomish County and Olympic View Water and Sewer District have asked both the King and Snohomish County Boundary Review Boards to reject Shoreline's proposal. In King County, the County and Olympic View argue that Shoreline's proposal before the King County Board includes references to the Snohomish County property – exceeding the King County Board's jurisdiction. In Snohomish County, the County

argues that Shoreline (as a city located outside of Snohomish County) is required to have an agreement with that county before annexing or assuming territory within the county's boundaries. Olympic View and Woodway challenge the assumption proposal arguing that Olympic View is the most appropriate service provider because its district boundaries include the unincorporated territory.

The case will be heard by the Boundary Review Boards in late August, with a final decision issued at that time. Please contact our Town Administrator, Eric Faison, at eric@townofwoodway.com if you have any questions about this case.

POINT WELLS EIS UPDATE

In our last Whisper, we reported that Snohomish County has begun the first major step in reviewing the environmental issues related to the proposed development of Point Wells. In February, the County issued a public notice—called a "scoping notice"—seeking comment on the various types of issues that should be evaluated in an environmental impact statement (EIS). The County has received those comments, and the next

major step is for the County to conduct a review and to prepare and issue a draft EIS (DEIS).

There will be one or more public meetings where the County will seek comment on the DEIS. Following this comment period, the EIS consultant and the County will review and provide responses to comments from the public, agencies, and jurisdictions in the final EIS.

At this time, the County is unable to predict when the project EIS process will be completed. The earliest the EIS could be completed would be late 2014 or early 2015, but it will likely take longer. If you have questions, please email Town Administrator Eric Faison at eric@townofwoodway.com.

TOWN COUNCIL CORNER

General Government:

- Approved Ordinance #14-555, instituting a marijuana business moratorium and held a public hearing.
- Heard a presentation on the Water Resource Inventory Area (WRIA) 8 by Jason Mulvihill-Kuntz, Lake Washington/Cedar/Sammamish Watershed Coordinator.
- Adopted Resolution #14-371, authorizing investment in the Local Government Investment Pool (LGIP).
- Approved Ordinance #14-556, revising the salary schedule.
- Heard a presentation on the Snohomish County Health Board by Woodway's representative, Sid Roberts, a Lynnwood Council member.
- Approved Resolution #14-373, authorizing the Mayor to sign the WRIA 8 Interlocal Agreement.

- Authorized the Mayor to renew the Interlocal Agreement with Snohomish County Housing and Community Development Urban County Consortium.
- Authorized the Mayor to sign Amendments 1 and 2 to the Interlocal Agreement for Inter-Jurisdictional Coordination related to Affordable Housing to allow the cities of Arlington and Stanwood to join the consortium of Snohomish County cities.

Public Works & Lands:

- Authorized an increase to PACE Engineers' contract service rates.
- Accepted the Town Hall construction as complete and released the retainage and bond being held for Faber Construction.
- Authorized the building of a stage on the south side of the Town Hall front lawn.

Land Use & Planning:

- Authorized the Mayor to sign a

contract with PACE Engineers to draft the transportation element for Woodway's Comprehensive Plan update.

- Submitted an Environmental Impact Statement scoping letter to Snohomish County for the Point Wells project.
- Adopted Resolution #14-372, declaring Woodway's intent to initiate negotiations with Snohomish County on a Master Annexation Interlocal Agreement

Public Safety:

- Awarded Officer Tim Dreyer a plaque for his 25 years of service to Woodway.

PLANNING COMMISSION NOTES

The Planning Commission is working on the multi-year process of updating the Comprehensive Plan. The state-mandated update is completed every six years.

Working with Robin Nelson of PACE Engineers, the Commission updated Chapter 4, the Transportation Element, to include

current traffic volumes and new signage/notification for non-motorized traffic and pedestrians.

They also revised Chapter 6, the Capital Facilities/Utilities Element based on changes in the town, including the new Town Hall, the contract with Shoreline Fire Department, and road repairs that

were finished in the last six years.

The next step will be to review and update the municipal code to reflect these new goals and policies.

All of the chapters will be given a final review before the draft of the updated plan is forwarded to the Council for adoption.
