NEW BUSINESS

Review Ordinance No. 1297-franchise with Yakima County: Ms. Steele provided information related to revisions made to the ordinance. Discussion was held and staff was directed to bring a revised ordinance back that is project specific relating to service being provided to the Sheriff Substation.

Review Applications for Funding: Ms. Steele provided information relating to the applications being submitted for the cost of engineering. It was explained that council approval is necessary for these applications to be submitted. Ms. Steele told Council the amounts of the city match on these applications as well as information on the need for the financing.

Review Ordinance No. 1298/Establishing Debt Service Fund (209): Ms. Bounds provided information related to the need for the fund. It is to be used for the debt service on the SIED Loan for the Teapot Project.

COUNCIL/STAFF REPORTS

ZPD: Chief Simmons explained that there was a shooting at the Sun Mart last weekend.

Police Vehicles: Chief Simmons provided information relating to the purchase of new police vehicles. The amount included in the budget discussions was for three vehicles financed over four (4) years for a total of \$132,000. He told council that the purchase price of the vehicles was going to be around \$92,000, decals at 3,000, lighting at \$9,400, computer equipment and scanners at \$10,000, video equipment at \$20,000 to \$25,000. The radios are the only thing being transferred over to the new cars. His new request is for funding of apx. \$155,000 stretched over a five (5) year period instead of \$132,000 for a four (4) year period. Chief Simmons also explained that he has been working with US Bank on a funding package for five (5) years with an interest rate of 2.58%. Ms. Bounds has been working with the State Treasurer's Office on a funding package that has historically had a lower interest rate. The interest rate for their November 2011 package was 1.51%, prior to that it was 2% and 2.1%. The hope would be that the interest rate will still stay below the US Bank rate but we won't know until August when everything goes through. The State is used to dealing with municipalities and public entities and all of the requirements associated with the process so Ms. Bounds feels like that program would be the safer of the two.

Mayor Clark asked Ms. Bounds if she had comment on the financing. She said that it was discussed during budget that the expenditure would be for \$132,000 over a four year period. Her thought process on whether this would be feasible was partly due to the fact that the water and sewer rate increases were approved for the same four year period and because of that the utility tax going into the general fund increases as well which would in part take care of the additional cost of the loan payment. She has no thought on funding the additional year without additional revenue commitment. Hope is always that growth will fill any funding gaps but that is also unknown at this time.
