COUNCIL/STAFF REPORTS

<u>Swimming Pool:</u> Mr. Tilley reported that the recent ADA requirements dictate that a lift chair or sloped entry be installed in our swimming pool. The only way to postpone the requirements being done at this time is to declare a hardship and to put a plan in place showing that the city will meet the requirements in the future. Council agreed they would like staff to draft a plan and bring it back for review. It was thought that a five year plan should be implemented.

<u>Utility work:</u> Mr. Tilley reported that his crew has recently been working on the water lines on Roza and Cutler Way.

<u>Teapot Move:</u> The Teapot Building will be moved tomorrow and everyone is invited to the event at 10 a.m.

Mold House: Mr. Carmody reported on the status of the mold house. He said that publishing of 60 days needs to be done and then the court will order the house to be removed. The city has the first lien with the bank having the second lien placement. The property could come back to the city if the finance company decides to quit claim it to the city. He will keep Council informed of any status updates.

<u>ATT Settlement:</u> Mr. Carmody informed council that AT&T offered to give the city a 10% discount of the monies they are requesting. He feels the city needs to continue negotiations. He will keep Council informed of any status updates.
