### **NEW BUSINESS**

Mayor Clark asked Council to add the following item as item 6A on the agenda: "Review recommendation to accept proposal from Watch Guard. The other items on the agenda will be moved one down.

Review recommendation to accept proposal from Watch Guard: Chief Simmons showed the graphic he's finalizing for the logo on the side of the new police vehicles. Mr. Gallagher asked several questions relating to the vehicle performance. The vehicles have a one year warranty. Chief Simmons explained that the city had to go out to RFP for the video equipment and two vendors submitted proposals. One of the vendors did not meet the specifications so the other vendor (Watch Guard) was chosen.

<u>Review Ord No. 1302 / LS Network:</u> Robin of Lightspeed Network provided details relating to the Franchise Ordinance and discussion was held.

Review Ord No. 1303 / 2012 Budget Amendment: Ms. Bounds provided details relating to the budget amendment. Mr. Russell asked Mr. Tilley to obtain estimates for fencing and construction for the dog kennels before the project is done.

Review Ord No. 1304 / Nugent Annexation: Ms. Steele explained that this annexation has been reviewed by the Boundary Review Board and is being sent back to the city by them for approval.

<u>Review Resolution No. 2012-22 / Interfund Loan:</u> Ms. Bounds explained that this interfund loan is a short term loan from the city water fund to the capital projects fund to pay for construction related to the Teapot Project.

Review Request from school for Mileage Club: Ms. Bounds explained that the city was contacted by Hilton Elementary School again this year to see if the city would donate 47 one day passes for children involved in the Mileage Club. It is a program that encourages walking.

### VISITOR'S COMMENTS

<u>Loud Music:</u> Barry Laws (Second Avenue, Zillah) told Council that the vehicles going by play loud music and asked Council if there is a noise ordinance. He also wondered if the police department would monitor his area of Second Avenue. There are vehicles being driven past his house (mostly during lunch time) that drive very fast and/or that are racing. Mayor Clark said that he would talk to Chief Simmons about it and have him call Mr. Laws.

**Hydrants:** Mr. Tilley reported that the hydrants on Cutler and on Roza are now live.

<u>Teapot Signs:</u> Mr. Tilley mentioned that the city needs to call about having the location of the historic signs on the freeway changed. Ms. Steele mentioned that she had and that the request is being considered.

Review recommendation to accept proposal from Watch Guard: Mr. Stewart moved, seconded by Ms. Gonzales that the City Council approve the proposal from Watch Guard for the video equipment for the new police vehicles in the amount of \$27,212.38. Motion carried unanimously.
