Terri Winckler/Coordinator, introduced herself and had the girls introduce themselves. The Girls thanked the city and staff for their support and help during this past year in various ways. They also commented that the Mayor has been a huge help in hauling the float to the various parades and they really appreciate his help. They have several parades left and they really need to look into getting a new truck in order to haul the float.

PUBLIC HEARING

Mayor Clark opened the Public Hearing at 7:13 p.m. Ms. Steele explained that this hearing is being opened but she suggested that it be continued to the next meeting. When the Planning Commission held their public hearing they were still waiting on some information from the County in order to make their recommendation and it had not come in yet. NEW BUSINESS

Review Planning Commission recommendation: Mayor Clark acknowledged Carol Wane was present. He explained that the Planning Commission recently held interviews for their vacant seat and that they recommended that Ms. Wane be appointed to fill the seat. A brief discussion was held.

Review Ord. No. 1307/2012 Budget Amendment: Ms. Bounds provided information related to the budget amendments.

Review Ord. No. 1308/Reclassifying Fund: Ms. Bounds explained she recently evaluated the fund classifications and that the Investment Trust Fund (601) needs to be reclassified to a Cemetery Endowment Fund (701) as it fits the definitions of such.

Review Street Applications: Mr. Tilley provided information related to the street applications and explained what the city match would be on each of them. Council was agreeable with them being submitted.

Review Ord. No. 1309/Moratorium Extension: Mayor Clark explained that the moratorium the city placed on collective gardens is being extended an additional six (6) months in order to give the Planning Commission and staff further time to work on the regulations.

VISITOR'S COMMENTS

Resident Comment: Georgia Clayton (501 Bartley) was present to complain about being robbed every night. She said that people break into her car and steal sprinkler parts and other various items. She was encouraged to call the police department to report the losses and Mayor Clark said that he would talk to Chief Simmons about the issue.

MAYOR'S REPORT

<u>Zillah Float/Parades:</u> Mayor Clark said that the Zillah Royalty will be at the Council meeting. He explained that they were in the Grandview parade last week and that they won first prize on their float.

COUNCIL/STAFF REPORTS

<u>Water quality:</u> Tim Tilley reported that the issue with the positive water reports have been resolved. Chlorination was done and the reports are coming back normal now.

<u>Fuel Tank Removal:</u> Ms. Bounds reported that the fuel tanks at the old Teapot site are on the docket to be removed next week by the Department of Ecology.

2013 Pool Proposal: Ms. Bounds said she spoke to John Hill today and he suggested getting groups or businesses to sponsor free swim on Fridays during August next year. Council suggested the sponsors be charged \$100 to sponsor a day of swimming. Mr. Stewart asked to be put on the list of sponsors.

<u>Sewer Line:</u> Mayor Clark asked for the status of the appeal with the County (Larsen/Alteejen residents). Ms. Steele reported that the parties lost their appeal and that the prior judgment was upheld by the County.

Mold House: Mr. Carmody reported that the issue with the mold house is being resolved.
