NEW BUSINESS

Review Ordinance No. 1347/2014 Salaries: Chief Simmons explained that the change to this ordinance was to change the prosecuting attorney from a flat rate to an hourly rate.

Review Ordinance No. 1348/Moratorium Extension: Ms. Steele provided information about the status of this issue. Mr. Carmody clarified that this ordinance is for an extension to the current moratorium. He provided information relating to the Attorney General Opinion that was issued and explained that the opinion is not binding. Mr. Carmody said that there may be an ability to charge a B&O type tax on marijuana sales. He was asked how the 1000 ft. distance is measured, whether it is drivable or as the crow flies. He gave an example of a past issue he was involved with that indicated it is walkable or drivable distance.

Review Ordinance No. 1349/2014 Budget Amendment: Mayor Clark explained that the finance committee recently met in order to review year end and 2014 supplemental budget requests. Ms. Bounds pointed out that council approved a finance policy in December and it has provided them some much-

needed guidance. She provided information about the year-end review and carry-over balances and showed the requests that the finance committee is recommending be approved.

Review Resolution No. 2014-07/NDA Agreement: Ms. Steele provided information about the NDA and explained that the city is required to have this agreement in place in order to secure federal funds.

PUBLIC HEARING

<u>Moratorium-Recreational Marijuana:</u> Mayor Clark opened the Public Hearing at 7:04 p.m. City Associate Planner Ardele Steele, provided information related to the public hearing.

Steve Gay - 110 Miles Drive: Mr. Gay explained that he has been a Police Officer for 25 years. He has worked on investigations and with drugs and has seen a lot. He is currently working in the schools. The schools have a zero tolerance for weapons, drugs and violence and he feels that this law is hypocritical and goes against what is being taught to the children. He doesn't want the city to give into this because it's had a very negative effect on individuals and he thinks the city should not allow it.

Robert Tucker – 211 Sunset Way: Mr. Tucker works in Yakima as an officer and with a K9 unit. He stated that alcohol is regulated and marijuana is not. He is concerned that this new law will foster 19 year old burn-outs, which he has seen plenty of in his life. He stated that this will not alleviate cartels because they are already in our state and that won't change. He said that teen access to the drug will be increased as they will just have their older friends purchase it for them. He stated he is against allowing it in Zillah because of it's effects on individuals, especially children.

Jamie Carmody – City Attorney clarified that this ordinance is extending a current moratorium that is in place relating to regulations for recreational marijuana. The moratorium provides an opportunity for the city to further review and consider public input during the drafting phase. He encouraged the planning commission to consider the law, the AG opinion as well as public input during the time that regulations are being considered.

Mayor Clark closed the Public Hearing at 7:22 p.m.

<u>Vote on Ordinance No. 1348/Moratorium Extension:</u> Mr. Bower moved, seconded by Mr. Miles that City Council approve Ordinance No. 1348 extending a moratorium prohibiting production, processing and retail sales of recreational marijuana. Motion carried unanimously.

<u>Vote on Ordinance No. 1349/2014 Budget Amendment:</u> Mr. Williams moved, seconded by Mr. Stewart that City Council approve Ordinance No. 1349/2014 Budget Amendment. Motion carried unanimously.

<u>Vote on Resolution No. 2014-07/NDA Agreement:</u> Mr. Bower moved, seconded by Mr. Williams that City Council approve Resolution No. 2014-07 approving a Non-discrimination agreement with WSDOT. Motion carried unanimously.

COMMITTEE/COMMISSION REPORTS

<u>Finance Committee:</u> Mr. Miles explained that the Finance Committee met last week to review 2013 year end finances and to consider the 2014 Supplemental Budget requests. The finances seemed to track well and revenues are budgeted conservatively. They discussed items listed in the Financial Policy and looked at carry-over balances, etc.
