<u>Discuss Open Government Training Act:</u> Ms. Bounds explained that the legislature recently enacted legislation relating to the Open Government Trainings Act. It is a risk management requirement for public agencies. It provides for open public meetings and records trainings and is intended to improve trust in government and at the same time help prevent costly lawsuits to government agencies. Certain trainings are now required for officials and records officers within government. The trainings include Open Public Meetings Act, Public Records and Records Retention. Ms. Bounds will watch for training that will best suit everyone this year.

Basement Improvements: Chief Simmons reported that the repairs to the basement are coming along slowly.

<u>Irrigation:</u> Mr. Tilley reported that the irrigation is coming in slowly and his department has been busy responding to various calls relating to it.
