### **NEW BUSINESS**

**School Bond-Kevin McKay:** Mr. McKay was not able to attend. Mayor Clark explained that the school made the decision to go out to ballot for a bond for a new Intermediate School. It was planned to be on the November ballot. After going through the process, the school was notified that they were not eligible for the matching funds (over 5M) for the project. Because of that, the school is not planning to move forward with the project. They are working to get that news out to the voters prior to the election.

Review application letter to DOH for Source Well Improvements: Ms. Bounds explained that the engineer is almost done with the application to DOH for the Source Well Improvements that's been discussed prior. These type of funding applications are normally brought to council for review prior to submission. She was informed today that the applications are due prior to the next council meeting but

the application is not ready yet for council review. She asked that city council authorize the engineer to submit the application to DOH for Source Well Improvements. If there is any issue with the application then staff will not submit it.

<u>Mayoral Candidate for Granger:</u> Charles Weaton (Granger Mayoral Candidate) was present. He stated that he is running for Mayor of Granger and he is visiting to see how other cities run their meetings. He complimented Zillah on their positive working relationships.

**ZPD:** Chief Simmons mentioned that he would like to draft an ordinance in dealing with trucks on Maple Way and Fox Blvd. listing those roads as restricted from trucks. There is an issue with the trucks taking an alternate route through that area because of bad GPS information and the city needs to deal with it. He said he'd also like to explore the possibility of restricting a left turn off Fox onto First Avenue.

<u>Public Works:</u> Mr. Tilley reported that the Second Avenue Project is complete and the contractor is completing the punch list items.
