NEW BUSINESS

Review Resolution No. 2022-07 Approving Addendum No. 1 to Task Order 2021-05: Ms. Bounds explained that the city previously had the cultural resources study done as per RCO requirements and now RCO tells us that they won't certify that study until 60% of the engineering plans are complete. This task order is for the engineering on the project.

Review Resolution No. 2022-08 Approving Easement Extension with Van Wyk: Ms. Bounds explained that she and Jamie Carmody have been working with the Van Wyk's on an extension of the current agreement. They have negotiated an extension of 15 years with a 5% increase at the end of each term and if they go for additional years, the increase will be at 10%.

Review Resolution No. 2022-09 Accepting RV Dump Station Project as complete: Ms. Bounds explained that the RV Dump Station Repair Project is now complete and the Notice of Completion needs to be sent out to the state agencies. The attached resolution officially closes out the project for the city.

Review Ordinance No. 1537/2022 Budget Amendment: Ms. Bounds explained that the budget amendment includes the supplemental budget items that were included in the budget process as well as the street projects that are coming up. It was explained that the budget/finance committee met last week to review the items and are recommending approval. Mr. Williams reported on the year end finances.

Review Ordinance No. 1538 Amending Salary Ordinance: Chief Quantrell explained that he requested an increase to the wage for Reserve officers and Ms. Bounds explained that the wage for the Teapot Visitor Center operator was added. Those items were also reviewed by the finance/budget committee at their meeting last week.
