NEW BUSINESS

- A. Review Resolution No. 2023-24, Housing Action Plan The Yakima Valley Conference of Governments was awarded a grant on behalf of the City of Zillah from the Washington State Department of Commerce to develop a Housing Action Plan in compliance with HB 1923. A Resolution is proposed to approve the Housing Plan for the City of Zillah, but Councilmembers expressed difficulty opening the link so the document was emailed out to review and they will take it up at the next Council meeting on Augusts 21, 2023.
- **B.** Review Ordinance No. 1562, Fireworks Regulations Council discussed feedback from residents and removing July 3rd from the regulations to allow fireworks to be set off, with a permit, only on July 4th. Council discussed holding a public hearing on August 7th and the one-year waiting period/effective date to adopt a local ordinance more restrictive than state law, per RCW 70.77.395 and RCW 70.77.250(4)
- C. Review Resolution No. 2023-25, RCO Agreement Council discussed the City's application for funding assistance through a Planning for Recreation Access grant for the Zillah Splash Park, which was approved for \$109,700.00. A resolution is proposed to authorize Mayor Carmack to sign the grant agreement with the Washington State Recreation and Conservation Office.
- D. Review Resolution No. 2023-26, Nondebatable Emergency Expenditure Council was briefed on the need to replace the City's The City of Zillah's most frequently used vehicle is the vactor truck, which is essential for the regular water and sewer system maintenance the Public Works staff provides several times a week and suddenly broke. Staff is having difficulty finding parts to make the necessary repairs, which must occur immediately to fully protect water and sewer obligations to the community. This circumstance is defined in Washington State RCW 35.33.081 as a Nondebatable Emergency Expenditure.

MAYOR'S REPORT

Mayor Carmack appreciated everyone's work to establish the Local Crime Lab in Zillah and appreciated everyone's attendance at the ribbon cutting and tour.

COUNCIL/STAFF REPORTS

The Police Department reported on the success of another National Night Out and Movie In the Park event. The Planning Department received development plans for a parcel recently purchased along Vintage Valley Parkway. The City continues to work collaboratively with the property owner to support their vision and help them navigate the State building codes and permitting process. The City Administrator and Fire Chief continue meeting with other Fire Departments and jurisdictions to explore options as the City of Zillah contemplates the "future of fire" with a retiring part-time fire chief and a diminishing number of volunteer firefighters. The Council was informed the Public Hospital District failed. Although it passed overwhelmingly by popular vote, it fell short of 160 votes meeting the requirement for voter turnout.
